### A BILL

To amend title 18, United States Code, with regard to stalking.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Combat Online Preda-
- 5 tors Act".
- 6 SEC. 2. ENHANCED PENALTY FOR STALKERS OF CHILDREN.
- 7 (a) In General.—Chapter 110A of title 18, United
- 8 States Code, is amended by inserting after section 2261A
- 9 the following:
- 10 "§2261B. Enhanced penalty for stalkers of children
- 11 "If the victim of an offense under section 2261A is
- 12 under the age of 18 years, the maximum imprisonment for
- 13 the offense is 5 years greater than the maximum term of
- 14 imprisonment otherwise provided for that offense in section
- 15 2261.".
- 16 (b) Clerical Amendment.—The table of sections at
- 17 the beginning of chapter 110A of title 18, United States
- 18 Code, is amended by inserting after the item relating to
- 19 section 2261A the following new item:
  - "2261B. Enhanced penalty for stalkers of children.".
- 20 (c) Conforming Amendment.—Section 2261A of title
- 21 18, United States Code, is amended by striking "section
- 22 2261(b) of this title" and inserting "section 2261(b) or sec-
- 23 tion 2262B, as the case may be".
