A BILL

To amend the Workforce Innovation and Opportunity Act to require the Secretary of Labor to submit to Congress an annual report relating to the amount of funds requested and awarded through YouthBuild programs, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Missed Opportunities
- 5 in Jobs Act".

1 SEC. 2. FINDINGS.

- 2 Congress finds that there are at least 2.3 million low-
- 3 income individuals age 16 to 24 in the United States who
- 4 are neither in school nor employed.
- 5 SEC. 3. SENSE OF CONGRESS.
- 6 It is the sense of Congress that—
- 7 (1) the United States should create meaningful
- 8 employment opportunities for the Nation's youth to
- 9 learn practical and meaningful skills because an in-
- vestment in the Nation's youth is an investment in
- 11 the United States;
- 12 (2) States should invest in the futures of at-risk
- 13 youth and others who may contribute to the United
- 14 States economy because doing so will decrease the
- unemployment rate; and
- 16 (3) the Department of Labor Grant Programs
- such as YouthBuild programs will provide critical re-
- sources necessary to keep the Nation's youth in-
- volved in their communities.
- 20 SEC. 4. ANNUAL REPORT FOR YOUTHBUILD PROGRAM.
- 21 Section 171(c) of the Workforce Innovation and Op-
- 22 portunity Act (29 U.S.C. 3226(c)) is amended by adding
- 23 at the end the following new paragraph:
- 24 "(6) Report to congress.—Not later than
- January 31 of each calendar year, the Secretary
- shall submit to Congress a report on the results of

1	YouthBuild programs authorized under this sub-
2	section that shall include the following:
3	"(A) The amount of funds, in aggregate,
4	requested by applicants.
5	"(B) The amount of funds awarded, in ag-
6	gregate, to entities that receive grants under
7	this subsection.
8	"(C) The difference between the amount of
9	funds reported under subparagraph (A) and the
10	amount of funds reported under subparagraph
11	(B).
12	"(D) A calculation of how many more indi-
13	viduals would have been provided opportunities
14	for employment, education, leadership develop-
15	ment, and training through YouthBuild pro-
16	grams or would have been provided with hous-
17	ing or access to public facilities through Youth-
18	Build programs if each eligible entity who ap-
