WHEREAS, it is with highest commendation that we recognize Senior Trooper Richard Daryl Bosarge, Jr., of the Alabama State Law Enforcement Agency as a nominee for the 2017 Alabama Legislative Medal of Honor for Law Enforcement, Alabama's highest law enforcement award for extraordinary courage in the line of duty; and

WHEREAS, as he was assisting a motorist on the westbound lane of Interstate 10 in Mobile County on February 6, 2016, Senior Trooper Bosarge observed a vehicle veer off the eastbound lane of I10 into the woods; quickly, he merged across four lanes of traffic to check on the occupants of the wrecked vehicle; he observed an unresponsive male slumped over the steering wheel and used his baton to break the side window of the locked vehicle; he removed the victim from the vehicle and rendered first aid; Trooper Bosarge turned the victim onto his side to clear his airway and continued to monitor his condition until paramedics arrived and transported the injured driver to the hospital, where medical staff reported that he
