AN ACT

Making appropriations for the Department of Defense for the fiscal year ending September 30, 2017, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 fiscal year ending September 30, 2017, for military func-
6 tions administered by the Department of Defense and for
7 other purposes, namely:

1 TITLE I

2 MILITARY PERSONNEL

3 MILITARY PERSONNEL, ARMY

4 For pay, allowances, individual clothing, subsistence,
5 interest on deposits, gratuities, permanent change of sta-
6 tion travel (including all expenses thereof for organiza-
7 tional movements), and expenses of temporary duty travel
8 between permanent duty stations, for members of the
9 Army on active duty (except members of reserve compo-
10 nents provided for elsewhere), cadets, and aviation cadets;
11 for members of the Reserve Officers' Training Corps; and
12 for payments pursuant to section 156 of Public Law 97-
13 377, as amended (42 U.S.C. 402 note), and to the Depart-
14 ment of Defense Military Retirement Fund,
15 \$40,042,962,000.

16 MILITARY PERSONNEL, NAVY

17 For pay, allowances, individual clothing, subsistence,
18 interest on deposits, gratuities, permanent change of sta-
19 tion travel (including all expenses thereof for organiza-
20 tional movements), and expenses of temporary duty travel
21 between permanent duty stations, for members of the
22 Navy on active duty (except members of the Reserve pro-
23 vided for elsewhere), midshipmen, and aviation cadets; for
24 members of the Reserve Officers' Training Corps; and for
25 payments pursuant to section 156 of Public Law 97-377,

1 as amended (42 U.S.C. 402 note), and to the Department
2 of Defense Military Retirement Fund, \$27,889,405,000.

3 MILITARY PERSONNEL, MARINE CORPS

4 For pay, allowances, individual clothing, subsistence,
5 interest on deposits, gratuities, permanent change of sta-
6 tion travel (including all expenses thereof for organiza-
7 tional movements), and expenses of temporary duty travel
8 between permanent duty stations, for members of the Ma-
9 rine Corps on active duty (except members of the Reserve
10 provided for elsewhere); and for payments pursuant to sec-
11 tion 156 of Public Law 97–377, as amended (42 U.S.C.
12 402 note), and to the Department of Defense Military Re-
13 tirement Fund, \$12,735,182,000.

14 MILITARY PERSONNEL, AIR FORCE

15 For pay, allowances, individual clothing, subsistence,
16 interest on deposits, gratuities, permanent change of sta-
17 tion travel (including all expenses thereof for organiza-
18 tional movements), and expenses of temporary duty travel
19 between permanent duty stations, for members of the Air
20 Force on active duty (except members of reserve compo-
21 nents provided for elsewhere), cadets, and aviation cadets;
22 for members of the Reserve Officers’ Training Corps; and
23 for payments pursuant to section 156 of Public Law 97–
24 377, as amended (42 U.S.C. 402 note), and to the Depart-

1 ment of Defense Military Retirement Fund,
2 \$27,958,795,000.

3 RESERVE PERSONNEL, ARMY

4 For pay, allowances, clothing, subsistence, gratuities,
5 travel, and related expenses for personnel of the Army Re-
6 serve on active duty under sections 10211, 10302, and
7 3038 of title 10, United States Code, or while serving on
8 active duty under section 12301(d) of title 10, United
9 States Code, in connection with performing duty specified
10 in section 12310(a) of title 10, United States Code, or
11 while undergoing reserve training, or while performing
12 drills or equivalent duty or other duty, and expenses au-
13 thorized by section 16131 of title 10, United States Code;
14 and for payments to the Department of Defense Military
15 Retirement Fund, \$4,524,863,000.

16 RESERVE PERSONNEL, NAVY

17 For pay, allowances, clothing, subsistence, gratuities,
18 travel, and related expenses for personnel of the Navy Re-
19 serve on active duty under section 10211 of title 10,
20 United States Code, or while serving on active duty under
21 section 12301(d) of title 10, United States Code, in con-
22 nection with performing duty specified in section 12310(a)
23 of title 10, United States Code, or while undergoing re-
24 serve training, or while performing drills or equivalent
25 duty, and expenses authorized by section 16131 of title

1 10, United States Code; and for payments to the Depart-
2 ment of Defense Military Retirement Fund,
3 \$1,921,045,000.

4 RESERVE PERSONNEL, MARINE CORPS

5 For pay, allowances, clothing, subsistence, gratuities,
6 travel, and related expenses for personnel of the Marine
7 Corps Reserve on active duty under section 10211 of title
8 10, United States Code, or while serving on active duty
9 under section 12301(d) of title 10, United States Code,
10 in connection with performing duty specified in section
11 12310(a) of title 10, United States Code, or while under-
12 going reserve training, or while performing drills or equiv-
13 alent duty, and for members of the Marine Corps platoon
14 leaders class, and expenses authorized by section 16131
15 of title 10, United States Code; and for payments to the
16 Department of Defense Military Retirement Fund,
17 \$744,795,000.

18 RESERVE PERSONNEL, AIR FORCE

19 For pay, allowances, clothing, subsistence, gratuities,
20 travel, and related expenses for personnel of the Air Force
21 Reserve on active duty under sections 10211, 10305, and
22 8038 of title 10, United States Code, or while serving on
23 active duty under section 12301(d) of title 10, United
24 States Code, in connection with performing duty specified
25 in section 12310(a) of title 10, United States Code, or

1 while undergoing reserve training, or while performing
2 drills or equivalent duty or other duty, and expenses au-
3 thorized by section 16131 of title 10, United States Code;
4 and for payments to the Department of Defense Military
5 Retirement Fund, \$1,725,526,000.

6 NATIONAL GUARD PERSONNEL, ARMY

7 For pay, allowances, clothing, subsistence, gratuities,
8 travel, and related expenses for personnel of the Army Na-
9 tional Guard while on duty under sections 10211, 10302,
10 or 12402 of title 10 or section 708 of title 32, United
11 States Code, or while serving on duty under section
12 12301(d) of title 10 or section 502(f) of title 32, United
13 States Code, in connection with performing duty specified
14 in section 12310(a) of title 10, United States Code, or
15 while undergoing training, or while performing drills or
16 equivalent duty or other duty, and expenses authorized by
17 section 16131 of title 10, United States Code; and for pay-
18 ments to the Department of Defense Military Retirement
19 Fund, \$7,899,423,000.

20 NATIONAL GUARD PERSONNEL, AIR FORCE

21 For pay, allowances, clothing, subsistence, gratuities,
22 travel, and related expenses for personnel of the Air Na-
23 tional Guard on duty under sections 10211, 10305, or
24 12402 of title 10 or section 708 of title 32, United States
25 Code, or while serving on duty under section 12301(d) of

1 title 10 or section 502(f) of title 32, United States Code,
2 in connection with performing duty specified in section
3 12310(a) of title 10, United States Code, or while under-
4 going training, or while performing drills or equivalent
5 duty or other duty, and expenses authorized by section
6 16131 of title 10, United States Code; and for payments
7 to the Department of Defense Military Retirement Fund,
8 \$3,283,982,000.

9 TITLE II

10 OPERATION AND MAINTENANCE

11 OPERATION AND MAINTENANCE, ARMY

12 For expenses, not otherwise provided for, necessary
13 for the operation and maintenance of the Army, as author-
14 ized by law, \$32,738,173,000: *Provided*, That not to ex-
15 ceed \$12,478,000 can be used for emergencies and ex-
16 traordinary expenses, to be expended on the approval or
17 authority of the Secretary of the Army, and payments may
18 be made on his certificate of necessity for confidential mili-
19 tary purposes.

20 OPERATION AND MAINTENANCE, NAVY

21 For expenses, not otherwise provided for, necessary
22 for the operation and maintenance of the Navy and the
23 Marine Corps, as authorized by law, \$38,552,017,000:
24 *Provided*, That not to exceed \$15,055,000 can be used for
25 emergencies and extraordinary expenses, to be expended

1 on the approval or authority of the Secretary of the Navy,
2 and payments may be made on his certificate of necessity
3 for confidential military purposes.

4 OPERATION AND MAINTENANCE, MARINE CORPS

5 For expenses, not otherwise provided for, necessary
6 for the operation and maintenance of the Marine Corps,
7 as authorized by law, \$5,676,152,000.

8 OPERATION AND MAINTENANCE, AIR FORCE

9 For expenses, not otherwise provided for, necessary
10 for the operation and maintenance of the Air Force, as
11 authorized by law, \$36,247,724,000: *Provided*, That not
12 to exceed \$7,699,000 can be used for emergencies and ex-
13 traordinary expenses, to be expended on the approval or
14 authority of the Secretary of the Air Force, and payments
15 may be made on his certificate of necessity for confidential
16 military purposes.

17 OPERATION AND MAINTENANCE, DEFENSE-WIDE

18 (INCLUDING TRANSFER OF FUNDS)

19 For expenses, not otherwise provided for, necessary
20 for the operation and maintenance of activities and agen-
21 cies of the Department of Defense (other than the military
22 departments), as authorized by law, \$32,373,949,000:
23 *Provided*, That not more than \$15,000,000 may be used
24 for the Combatant Commander Initiative Fund authorized
25 under section 166a of title 10, United States Code: *Pro-*

1 *vided further*, That not to exceed \$36,000,000 can be used
2 for emergencies and extraordinary expenses, to be ex-
3 pended on the approval or authority of the Secretary of
4 Defense, and payments may be made on his certificate of
5 necessity for confidential military purposes: *Provided fur-*
6 *ther*, That of the funds provided under this heading, not
7 less than \$34,964,000 shall be made available for the Pro-
8 curement Technical Assistance Cooperative Agreement
9 Program, of which not less than \$3,600,000 shall be avail-
10 able for centers defined in 10 U.S.C. 2411(1)(D): *Pro-*
11 *vided further*, That none of the funds appropriated or oth-
12 erwise made available by this Act may be used to plan
13 or implement the consolidation of a budget or appropria-
14 tions liaison office of the Office of the Secretary of De-
15 fense, the office of the Secretary of a military department,
16 or the service headquarters of one of the Armed Forces
17 into a legislative affairs or legislative liaison office: *Pro-*
18 *vided further*, That \$5,023,000, to remain available until
19 expended, is available only for expenses relating to certain
20 classified activities, and may be transferred as necessary
21 by the Secretary of Defense to operation and maintenance
22 appropriations or research, development, test and evalua-
23 tion appropriations, to be merged with and to be available
24 for the same time period as the appropriations to which
25 transferred: *Provided further*, That any ceiling on the in-

1 vestment item unit cost of items that may be purchased
2 with operation and maintenance funds shall not apply to
3 the funds described in the preceding proviso: *Provided fur-*
4 *ther*, That of the funds provided under this heading,
5 \$480,000,000, to remain available until September 30,
6 2018, shall be available to provide support and assistance
7 to foreign security forces or other groups or individuals
8 to conduct, support or facilitate counterterrorism, crisis
9 response, or other Department of Defense security co-
10 operation programs: *Provided further*, That the transfer
11 authority provided under this heading is in addition to any
12 other transfer authority provided elsewhere in this Act.

13 OPERATION AND MAINTENANCE, ARMY RESERVE

14 For expenses, not otherwise provided for, necessary
15 for the operation and maintenance, including training, or-
16 ganization, and administration, of the Army Reserve; re-
17 pair of facilities and equipment; hire of passenger motor
18 vehicles; travel and transportation; care of the dead; re-
19 cruiting; procurement of services, supplies, and equip-
20 ment; and communications, \$2,743,688,000.

21 OPERATION AND MAINTENANCE, NAVY RESERVE

22 For expenses, not otherwise provided for, necessary
23 for the operation and maintenance, including training, or-
24 ganization, and administration, of the Navy Reserve; re-
25 pair of facilities and equipment; hire of passenger motor

1 vehicles; travel and transportation; care of the dead; re-
2 cruiting; procurement of services, supplies, and equip-
3 ment; and communications, \$929,656,000.

4 OPERATION AND MAINTENANCE, MARINE CORPS
5 RESERVE

6 For expenses, not otherwise provided for, necessary
7 for the operation and maintenance, including training, or-
8 ganization, and administration, of the Marine Corps Re-
9 serve; repair of facilities and equipment; hire of passenger
10 motor vehicles; travel and transportation; care of the dead;
11 recruiting; procurement of services, supplies, and equip-
12 ment; and communications, \$271,133,000.

13 OPERATION AND MAINTENANCE, AIR FORCE RESERVE

14 For expenses, not otherwise provided for, necessary
15 for the operation and maintenance, including training, or-
16 ganization, and administration, of the Air Force Reserve;
17 repair of facilities and equipment; hire of passenger motor
18 vehicles; travel and transportation; care of the dead; re-
19 cruiting; procurement of services, supplies, and equip-
20 ment; and communications, \$3,069,229,000.

21 OPERATION AND MAINTENANCE, ARMY NATIONAL
22 GUARD

23 For expenses of training, organizing, and admin-
24 istering the Army National Guard, including medical and
25 hospital treatment and related expenses in non-Federal

1 hospitals; maintenance, operation, and repairs to struc-
2 tures and facilities; hire of passenger motor vehicles; per-
3 sonnel services in the National Guard Bureau; travel ex-
4 penses (other than mileage), as authorized by law for
5 Army personnel on active duty, for Army National Guard
6 division, regimental, and battalion commanders while in-
7 specting units in compliance with National Guard Bureau
8 regulations when specifically authorized by the Chief, Na-
9 tional Guard Bureau; supplying and equipping the Army
10 National Guard as authorized by law; and expenses of re-
11 pair, modification, maintenance, and issue of supplies and
12 equipment (including aircraft), \$6,861,478,000.

13 OPERATION AND MAINTENANCE, AIR NATIONAL GUARD

14 For expenses of training, organizing, and admin-
15 istering the Air National Guard, including medical and
16 hospital treatment and related expenses in non-Federal
17 hospitals; maintenance, operation, and repairs to struc-
18 tures and facilities; transportation of things, hire of pas-
19 senger motor vehicles; supplying and equipping the Air
20 National Guard, as authorized by law; expenses for repair,
21 modification, maintenance, and issue of supplies and
22 equipment, including those furnished from stocks under
23 the control of agencies of the Department of Defense;
24 travel expenses (other than mileage) on the same basis as
25 authorized by law for Air National Guard personnel on

1 active Federal duty, for Air National Guard commanders
2 while inspecting units in compliance with National Guard
3 Bureau regulations when specifically authorized by the
4 Chief, National Guard Bureau, \$6,615,095,000.

5 UNITED STATES COURT OF APPEALS FOR THE ARMED
6 FORCES

7 For salaries and expenses necessary for the United
8 States Court of Appeals for the Armed Forces,
9 \$14,194,000, of which not to exceed \$5,000 may be used
10 for official representation purposes.

11 ENVIRONMENTAL RESTORATION, ARMY
12 (INCLUDING TRANSFER OF FUNDS)

13 For the Department of the Army, \$170,167,000, to
14 remain available until transferred: *Provided*, That the Sec-
15 retary of the Army shall, upon determining that such
16 funds are required for environmental restoration, reduc-
17 tion and recycling of hazardous waste, removal of unsafe
18 buildings and debris of the Department of the Army, or
19 for similar purposes, transfer the funds made available by
20 this appropriation to other appropriations made available
21 to the Department of the Army, to be merged with and
22 to be available for the same purposes and for the same
23 time period as the appropriations to which transferred:
24 *Provided further*, That upon a determination that all or
25 part of the funds transferred from this appropriation are

1 not necessary for the purposes provided herein, such
2 amounts may be transferred back to this appropriation:
3 *Provided further*, That the transfer authority provided
4 under this heading is in addition to any other transfer au-
5 thority provided elsewhere in this Act.

6 ENVIRONMENTAL RESTORATION, NAVY

7 (INCLUDING TRANSFER OF FUNDS)

8 For the Department of the Navy, \$289,262,000, to
9 remain available until transferred: *Provided*, That the Sec-
10 retary of the Navy shall, upon determining that such
11 funds are required for environmental restoration, reduc-
12 tion and recycling of hazardous waste, removal of unsafe
13 buildings and debris of the Department of the Navy, or
14 for similar purposes, transfer the funds made available by
15 this appropriation to other appropriations made available
16 to the Department of the Navy, to be merged with and
17 to be available for the same purposes and for the same
18 time period as the appropriations to which transferred:
19 *Provided further*, That upon a determination that all or
20 part of the funds transferred from this appropriation are
21 not necessary for the purposes provided herein, such
22 amounts may be transferred back to this appropriation:
23 *Provided further*, That the transfer authority provided
24 under this heading is in addition to any other transfer au-
25 thority provided elsewhere in this Act.

1 ENVIRONMENTAL RESTORATION, AIR FORCE

2 (INCLUDING TRANSFER OF FUNDS)

3 For the Department of the Air Force, \$371,521,000,
4 to remain available until transferred: *Provided*, That the
5 Secretary of the Air Force shall, upon determining that
6 such funds are required for environmental restoration, re-
7 duction and recycling of hazardous waste, removal of un-
8 safe buildings and debris of the Department of the Air
9 Force, or for similar purposes, transfer the funds made
10 available by this appropriation to other appropriations
11 made available to the Department of the Air Force, to be
12 merged with and to be available for the same purposes
13 and for the same time period as the appropriations to
14 which transferred: *Provided further*, That upon a deter-
15 mination that all or part of the funds transferred from
16 this appropriation are not necessary for the purposes pro-
17 vided herein, such amounts may be transferred back to
18 this appropriation: *Provided further*, That the transfer au-
19 thority provided under this heading is in addition to any
20 other transfer authority provided elsewhere in this Act.

21 ENVIRONMENTAL RESTORATION, DEFENSE-WIDE

22 (INCLUDING TRANSFER OF FUNDS)

23 For the Department of Defense, \$9,009,000, to re-
24 main available until transferred: *Provided*, That the Sec-
25 retary of Defense shall, upon determining that such funds

1 are required for environmental restoration, reduction and
2 recycling of hazardous waste, removal of unsafe buildings
3 and debris of the Department of Defense, or for similar
4 purposes, transfer the funds made available by this appro-
5 priation to other appropriations made available to the De-
6 partment of Defense, to be merged with and to be avail-
7 able for the same purposes and for the same time period
8 as the appropriations to which transferred: *Provided fur-*
9 *ther*, That upon a determination that all or part of the
10 funds transferred from this appropriation are not nec-
11 essary for the purposes provided herein, such amounts
12 may be transferred back to this appropriation: *Provided*
13 *further*, That the transfer authority provided under this
14 heading is in addition to any other transfer authority pro-
15 vided elsewhere in this Act.

16 ENVIRONMENTAL RESTORATION, FORMERLY USED
17 DEFENSE SITES
18 (INCLUDING TRANSFER OF FUNDS)

19 For the Department of the Army, \$222,084,000, to
20 remain available until transferred: *Provided*, That the Sec-
21 retary of the Army shall, upon determining that such
22 funds are required for environmental restoration, reduc-
23 tion and recycling of hazardous waste, removal of unsafe
24 buildings and debris at sites formerly used by the Depart-
25 ment of Defense, transfer the funds made available by this

1 appropriation to other appropriations made available to
2 the Department of the Army, to be merged with and to
3 be available for the same purposes and for the same time
4 period as the appropriations to which transferred: *Pro-*
5 *vided further*, That upon a determination that all or part
6 of the funds transferred from this appropriation are not
7 necessary for the purposes provided herein, such amounts
8 may be transferred back to this appropriation: *Provided*
9 *further*, That the transfer authority provided under this
10 heading is in addition to any other transfer authority pro-
11 vided elsewhere in this Act.

12 OVERSEAS HUMANITARIAN, DISASTER, AND CIVIC AID

13 For expenses relating to the Overseas Humanitarian,
14 Disaster, and Civic Aid programs of the Department of
15 Defense (consisting of the programs provided under sec-
16 tions 401, 402, 404, 407, 2557, and 2561 of title 10,
17 United States Code), \$123,125,000, to remain available
18 until September 30, 2018.

19 COOPERATIVE THREAT REDUCTION ACCOUNT

20 For assistance, including assistance provided by con-
21 tract or by grants, under programs and activities of the
22 Department of Defense Cooperative Threat Reduction
23 Program authorized under the Department of Defense Co-
24 operative Threat Reduction Act, \$325,604,000, to remain
25 available until September 30, 2019.

1 TITLE III
2 PROCUREMENT

3 AIRCRAFT PROCUREMENT, ARMY

4 For construction, procurement, production, modifica-
5 tion, and modernization of aircraft, equipment, including
6 ordnance, ground handling equipment, spare parts, and
7 accessories therefor; specialized equipment and training
8 devices; expansion of public and private plants, including
9 the land necessary therefor, for the foregoing purposes,
10 and such lands and interests therein, may be acquired,
11 and construction prosecuted thereon prior to approval of
12 title; and procurement and installation of equipment, ap-
13 pliances, and machine tools in public and private plants;
14 reserve plant and Government and contractor-owned
15 equipment layaway; and other expenses necessary for the
16 foregoing purposes, \$4,587,598,000, to remain available
17 for obligation until September 30, 2019.

18 MISSILE PROCUREMENT, ARMY

19 For construction, procurement, production, modifica-
20 tion, and modernization of missiles, equipment, including
21 ordnance, ground handling equipment, spare parts, and
22 accessories therefor; specialized equipment and training
23 devices; expansion of public and private plants, including
24 the land necessary therefor, for the foregoing purposes,
25 and such lands and interests therein, may be acquired,

1 and construction prosecuted thereon prior to approval of
2 title; and procurement and installation of equipment, ap-
3 pliances, and machine tools in public and private plants;
4 reserve plant and Government and contractor-owned
5 equipment layaway; and other expenses necessary for the
6 foregoing purposes, \$1,533,804,000, to remain available
7 for obligation until September 30, 2019.

8 PROCUREMENT OF WEAPONS AND TRACKED COMBAT
9 VEHICLES, ARMY

10 For construction, procurement, production, and
11 modification of weapons and tracked combat vehicles,
12 equipment, including ordnance, spare parts, and acces-
13 sories therefor; specialized equipment and training devices;
14 expansion of public and private plants, including the land
15 necessary therefor, for the foregoing purposes, and such
16 lands and interests therein, may be acquired, and con-
17 struction prosecuted thereon prior to approval of title; and
18 procurement and installation of equipment, appliances,
19 and machine tools in public and private plants; reserve
20 plant and Government and contractor-owned equipment
21 layaway; and other expenses necessary for the foregoing
22 purposes, \$2,229,455,000, to remain available for obliga-
23 tion until September 30, 2019.

1 PROCUREMENT OF AMMUNITION, ARMY

2 For construction, procurement, production, and
3 modification of ammunition, and accessories therefor; spe-
4 cialized equipment and training devices; expansion of pub-
5 lic and private plants, including ammunition facilities, au-
6 thorized by section 2854 of title 10, United States Code,
7 and the land necessary therefor, for the foregoing pur-
8 poses, and such lands and interests therein, may be ac-
9 quired, and construction prosecuted thereon prior to ap-
10 proval of title; and procurement and installation of equip-
11 ment, appliances, and machine tools in public and private
12 plants; reserve plant and Government and contractor-
13 owned equipment layaway; and other expenses necessary
14 for the foregoing purposes, \$1,483,566,000, to remain
15 available for obligation until September 30, 2019.

16 OTHER PROCUREMENT, ARMY

17 For construction, procurement, production, and
18 modification of vehicles, including tactical, support, and
19 non-tracked combat vehicles; the purchase of passenger
20 motor vehicles for replacement only; communications and
21 electronic equipment; other support equipment; spare
22 parts, ordnance, and accessories therefor; specialized
23 equipment and training devices; expansion of public and
24 private plants, including the land necessary therefor, for
25 the foregoing purposes, and such lands and interests

1 therein, may be acquired, and construction prosecuted
2 thereon prior to approval of title; and procurement and
3 installation of equipment, appliances, and machine tools
4 in public and private plants; reserve plant and Govern-
5 ment and contractor-owned equipment layaway; and other
6 expenses necessary for the foregoing purposes,
7 \$6,147,328,000, to remain available for obligation until
8 September 30, 2019.

9 AIRCRAFT PROCUREMENT, NAVY

10 For construction, procurement, production, modifica-
11 tion, and modernization of aircraft, equipment, including
12 ordnance, spare parts, and accessories therefor; specialized

17 TITLE VIII

18 GENERAL PROVISIONS

19 SEC. 8001. No part of any appropriation contained
20 in this Act shall be used for publicity or propaganda pur-
21 poses not authorized by the Congress.

22 SEC. 8002. During the current fiscal year, provisions
23 of law prohibiting the payment of compensation to, or em-
24 ployment of, any person not a citizen of the United States
25 shall not apply to personnel of the Department of Defense:

1 *Provided*, That salary increases granted to direct and indi-
2 rect hire foreign national employees of the Department of
3 Defense funded by this Act shall not be at a rate in excess
4 of the percentage increase authorized by law for civilian
5 employees of the Department of Defense whose pay is
6 computed under the provisions of section 5332 of title 5,
7 United States Code, or at a rate in excess of the percent-
8 age increase provided by the appropriate host nation to
9 its own employees, whichever is higher: *Provided further*,
10 That this section shall not apply to Department of De-
11 fense foreign service national employees serving at United
12 States diplomatic missions whose pay is set by the Depart-
13 ment of State under the Foreign Service Act of 1980: *Pro-*
14 *vided further*, That the limitations of this provision shall
15 not apply to foreign national employees of the Department
16 of Defense in the Republic of Turkey.

17 SEC. 8003. No part of any appropriation contained
18 in this Act shall remain available for obligation beyond
19 the current fiscal year, unless expressly so provided herein.

20 SEC. 8004. No more than 20 percent of the appro-
21 priations in this Act which are limited for obligation dur-
22 ing the current fiscal year shall be obligated during the
23 last 2 months of the fiscal year: *Provided*, That this sec-
24 tion shall not apply to obligations for support of active

1 duty training of reserve components or summer camp
2 training of the Reserve Officers' Training Corps.

3 (TRANSFER OF FUNDS)

4 SEC. 8005. Upon determination by the Secretary of
5 Defense that such action is necessary in the national inter-
6 est, he may, with the approval of the Office of Manage-
7 ment and Budget, transfer not to exceed \$4,500,000,000
8 of working capital funds of the Department of Defense
9 or funds made available in this Act to the Department
10 of Defense for military functions (except military con-
11 struction) between such appropriations or funds or any
12 subdivision thereof, to be merged with and to be available
13 for the same purposes, and for the same time period, as
14 the appropriation or fund to which transferred: *Provided*,
15 That such authority to transfer may not be used unless
16 for higher priority items, based on unforeseen military re-
17 quirements, than those for which originally appropriated
18 and in no case where the item for which funds are re-
19 quested has been denied by the Congress: *Provided further*,
20 That the Secretary of Defense shall notify the Congress
21 promptly of all transfers made pursuant to this authority
22 or any other authority in this Act: *Provided further*, That
23 no part of the funds in this Act shall be available to pre-
24 pare or present a request to the Committees on Appropria-
25 tions for reprogramming of funds, unless for higher pri-

1 ority items, based on unforeseen military requirements,
2 than those for which originally appropriated and in no
3 case where the item for which reprogramming is requested
4 has been denied by the Congress: *Provided further*, That
5 a request for multiple reprogrammings of funds using au-
6 thority provided in this section shall be made prior to June
7 30, 2017: *Provided further*, That transfers among military
8 personnel appropriations shall not be taken into account
9 for purposes of the limitation on the amount of funds that
10 may be transferred under this section.

11 SEC. 8006. (a) With regard to the list of specific pro-
12 grams, projects, and activities (and the dollar amounts
13 and adjustments to budget activities corresponding to
14 such programs, projects, and activities) contained in the
15 tables titled Explanation of Project Level Adjustments in
16 the explanatory statement regarding this Act, the obliga-
17 tion and expenditure of amounts appropriated or other-
18 wise made available in this Act for those programs,
19 projects, and activities for which the amounts appro-
20 priated exceed the amounts requested are hereby required
21 by law to be carried out in the manner provided by such
22 tables to the same extent as if the tables were included
23 in the text of this Act.

24 (b) Amounts specified in the referenced tables de-
25 scribed in subsection (a) shall not be treated as subdivi-

1 sions of appropriations for purposes of section 8005 of this
2 Act: *Provided*, That section 8005 shall apply when trans-
3 fers of the amounts described in subsection (a) occur be-
4 tween appropriation accounts.

5 SEC. 8007. (a) Not later than 60 days after enact-
6 ment of this Act, the Department of Defense shall submit
7 a report to the congressional defense committees to estab-
8 lish the baseline for application of reprogramming and
9 transfer authorities for fiscal year 2017: *Provided*, That
10 the report shall include—

11 (1) a table for each appropriation with a sepa-
12 rate column to display the President's budget re-
13 quest, adjustments made by Congress, adjustments
14 due to enacted rescissions, if appropriate, and the
15 fiscal year enacted level;

16 (2) a delineation in the table for each appro-
17 priation both by budget activity and program,
18 project, and activity as detailed in the Budget Ap-
19 pendix; and

20 (3) an identification of items of special congres-
21 sional interest.

22 (b) Notwithstanding section 8005 of this Act, none
23 of the funds provided in this Act shall be available for
24 reprogramming or transfer until the report identified in
25 subsection (a) is submitted to the congressional defense

1 committees, unless the Secretary of Defense certifies in
 2 writing to the congressional defense committees that such
 3 reprogramming or transfer is necessary as an emergency
 4 requirement: *Provided*, That this subsection shall not
 5 apply to transfers from the following appropriations ac-
 6 counts:

- 7 (1) “Environmental Restoration, Army”;
- 8 (2) “Environmental Restoration, Navy”;
- 9 (3) “Environmental Restoration, Air Force”;
- 10 (4) “Environmental Restoration, Defense-
- 11 wide”;
- 12 (5) “Environmental Restoration, Formerly
- 13 Used Defense Sites”; and
- 14 (6) “Drug Interdiction and Counter-drug Ac-
- 15 tivities, Defense”.

16 (TRANSFER OF FUNDS)

17 SEC. 8008. During the current fiscal year, cash bal-
 18 ances in working capital funds of the Department of De-
 19 fense established pursuant to section 2208 of title 10,
 20 United States Code, may be maintained in only such
 21 amounts as are necessary at any time for cash disburse-
 22 ments to be made from such funds: *Provided*, That trans-
 23 fers may be made between such funds: *Provided further*,
 24 That transfers may be made between working capital
 25 funds and the “Foreign Currency Fluctuations, Defense”

1 appropriation and the “Operation and Maintenance” ap-
2 propriation accounts in such amounts as may be deter-
3 mined by the Secretary of Defense, with the approval of
4 the Office of Management and Budget, except that such
5 transfers may not be made unless the Secretary of Defense
6 has notified the Congress of the proposed transfer: *Pro-*
7 *vided further*, That except in amounts equal to the
8 amounts appropriated to working capital funds in this Act,
9 no obligations may be made against a working capital fund
10 to procure or increase the value of war reserve material
11 inventory, unless the Secretary of Defense has notified the
12 Congress prior to any such obligation.

13 SEC. 8009. Funds appropriated by this Act may not
14 be used to initiate a special access program without prior
15 notification 30 calendar days in advance to the congres-
16 sional defense committees.

17 SEC. 8010. None of the funds provided in this Act
18 shall be available to initiate: (1) a multiyear contract that
19 employs economic order quantity procurement in excess of
20 \$20,000,000 in any one year of the contract or that in-
21 cludes an unfunded contingent liability in excess of
22 \$20,000,000; or (2) a contract for advance procurement
23 leading to a multiyear contract that employs economic
24 order quantity procurement in excess of \$20,000,000 in
25 any one year, unless the congressional defense committees

1 have been notified at least 30 days in advance of the pro-
2 posed contract award: *Provided*, That no part of any ap-
3 propriation contained in this Act shall be available to ini-
4 tiate a multiyear contract for which the economic order
5 quantity advance procurement is not funded at least to
6 the limits of the Government's liability: *Provided further*,
7 That no part of any appropriation contained in this Act
8 shall be available to initiate multiyear procurement con-
9 tracts for any systems or component thereof if the value
10 of the multiyear contract would exceed \$500,000,000 un-
11 less specifically provided in this Act: *Provided further*,
12 That no multiyear procurement contract can be termi-
13 nated without 30-day prior notification to the congres-
14 sional defense committees: *Provided further*, That the exe-
15 cution of multiyear authority shall require the use of a
16 present value analysis to determine lowest cost compared
17 to an annual procurement: *Provided further*, That none of
18 the funds provided in this Act may be used for a multiyear
19 contract executed after the date of the enactment of this
20 Act unless in the case of any such contract—

21 (1) the Secretary of Defense has submitted to
22 Congress a budget request for full funding of units
23 to be procured through the contract and, in the case
24 of a contract for procurement of aircraft, that in-
25 cludes, for any aircraft unit to be procured through

1 the contract for which procurement funds are re-
2 requested in that budget request for production be-
3 yond advance procurement activities in the fiscal
4 year covered by the budget, full funding of procure-
5 ment of such unit in that fiscal year;

6 (2) cancellation provisions in the contract do
7 not include consideration of recurring manufacturing
8 costs of the contractor associated with the produc-
9 tion of unfunded units to be delivered under the con-
10 tract;

11 (3) the contract provides that payments to the
12 contractor under the contract shall not be made in
13 advance of incurred costs on funded units; and

14 (4) the contract does not provide for a price ad-
15 justment based on a failure to award a follow-on
16 contract.

17 Funds appropriated in title III of this Act may be
18 used for a multiyear procurement contract as follows: AH-
19 64E Apache Helicopter and UH-60M Blackhawk Heli-
20 copter.

21 SEC. 8011. Within the funds appropriated for the op-
22 eration and maintenance of the Armed Forces, funds are
23 hereby appropriated pursuant to section 401 of title 10,
24 United States Code, for humanitarian and civic assistance
25 costs under chapter 20 of title 10, United States Code.

1 Such funds may also be obligated for humanitarian and
2 civic assistance costs incidental to authorized operations
3 and pursuant to authority granted in section 401 of chap-
4 ter 20 of title 10, United States Code, and these obliga-
5 tions shall be reported as required by section 401(d) of
6 title 10, United States Code: *Provided*, That funds avail-
7 able for operation and maintenance shall be available for
8 providing humanitarian and similar assistance by using
9 Civic Action Teams in the Trust Territories of the Pacific
10 Islands and freely associated states of Micronesia, pursu-
11 ant to the Compact of Free Association as authorized by
12 Public Law 99–239: *Provided further*, That upon a deter-
13 mination by the Secretary of the Army that such action
14 is beneficial for graduate medical education programs con-
15 ducted at Army medical facilities located in Hawaii, the
16 Secretary of the Army may authorize the provision of med-
17 ical services at such facilities and transportation to such
18 facilities, on a nonreimbursable basis, for civilian patients
19 from American Samoa, the Commonwealth of the North-
20 ern Mariana Islands, the Marshall Islands, the Federated
21 States of Micronesia, Palau, and Guam.

22 SEC. 8012. (a) During fiscal year 2017, the civilian
23 personnel of the Department of Defense may not be man-
24 aged on the basis of any end-strength, and the manage-
25 ment of such personnel during that fiscal year shall not

1 be subject to any constraint or limitation (known as an
2 end-strength) on the number of such personnel who may
3 be employed on the last day of such fiscal year.

4 (b) The fiscal year 2018 budget request for the De-
5 partment of Defense as well as all justification material
6 and other documentation supporting the fiscal year 2018
7 Department of Defense budget request shall be prepared
8 and submitted to the Congress as if subsections (a) and
9 (b) of this provision were effective with regard to fiscal
10 year 2018.

11 (c) As required by section 1107 of the National De-
12 fense Authorization Act for Fiscal Year 2014 (Public Law
13 113–66; 10 U.S.C. 2358 note) civilian personnel at the
14 Department of Army Science and Technology Reinvention
15 Laboratories may not be managed on the basis of the
16 Table of Distribution and Allowances, and the manage-
17 ment of the workforce strength shall be done in a manner
18 consistent with the budget available with respect to such
19 Laboratories.

20 (d) Nothing in this section shall be construed to apply
21 to military (civilian) technicians.

22 SEC. 8013. None of the funds appropriated by this
23 Act shall be used for the support of any nonappropriated
24 funds activity of the Department of Defense that procures
25 malt beverages and wine with nonappropriated funds for

1 resale (including such alcoholic beverages sold by the
2 drink) on a military installation located in the United
3 States unless such malt beverages and wine are procured
4 within that State, or in the case of the District of Colum-
5 bia, within the District of Columbia, in which the military
6 installation is located: *Provided*, That, in a case in which
7 the military installation is located in more than one State,
8 purchases may be made in any State in which the installa-
9 tion is located: *Provided further*, That such local procure-
10 ment requirements for malt beverages and wine shall
11 apply to all alcoholic beverages only for military installa-
12 tions in States which are not contiguous with another
13 State: *Provided further*, That alcoholic beverages other
14 than wine and malt beverages, in contiguous States and
15 the District of Columbia shall be procured from the most
16 competitive source, price and other factors considered.

17 SEC. 8014. None of the funds made available by this
18 Act shall be used in any way, directly or indirectly, to in-
19 fluence congressional action on any legislation or appro-
20 priation matters pending before the Congress.

21 SEC. 8015. None of the funds appropriated by this
22 Act shall be available for the basic pay and allowances of
23 any member of the Army participating as a full-time stu-
24 dent and receiving benefits paid by the Secretary of Vet-
25 erans Affairs from the Department of Defense Education

1 Benefits Fund when time spent as a full-time student is
2 credited toward completion of a service commitment: *Pro-*
3 *vided*, That this section shall not apply to those members
4 who have reenlisted with this option prior to October 1,
5 1987: *Provided further*, That this section applies only to
6 active components of the Army.

7 (TRANSFER OF FUNDS)

8 SEC. 8016. Funds appropriated in title III of this Act
9 for the Department of Defense Pilot Mentor-Protégé Pro-
10 gram may be transferred to any other appropriation con-
11 tained in this Act solely for the purpose of implementing
12 a Mentor-Protégé Program developmental assistance
13 agreement pursuant to section 831 of the National De-
14 fense Authorization Act for Fiscal Year 1991 (Public Law
15 101–510; 10 U.S.C. 2302 note), as amended, under the
16 authority of this provision or any other transfer authority
17 contained in this Act.

18 SEC. 8017. None of the funds in this Act may be
19 available for the purchase by the Department of Defense
20 (and its departments and agencies) of welded shipboard
21 anchor and mooring chain 4 inches in diameter and under
22 unless the anchor and mooring chain are manufactured
23 in the United States from components which are substan-
24 tially manufactured in the United States: *Provided*, That
25 for the purpose of this section, the term “manufactured”

1 shall include cutting, heat treating, quality control, testing
2 of chain and welding (including the forging and shot blast-
3 ing process): *Provided further*, That for the purpose of this
4 section substantially all of the components of anchor and
5 mooring chain shall be considered to be produced or manu-
6 factured in the United States if the aggregate cost of the
7 components produced or manufactured in the United
8 States exceeds the aggregate cost of the components pro-
9 duced or manufactured outside the United States: *Pro-*
10 *vided further*, That when adequate domestic supplies are
11 not available to meet Department of Defense requirements
12 on a timely basis, the Secretary of the service responsible
13 for the procurement may waive this restriction on a case-
14 by-case basis by certifying in writing to the Committees
15 on Appropriations that such an acquisition must be made
16 in order to acquire capability for national security pur-
17 poses.

18 SEC. 8018. Of the amounts appropriated for “Work-
19 ing Capital Fund, Army”, \$140,000,000 shall be available
20 to maintain competitive rates at the arsenals.

21 SEC. 8019. None of the funds available to the De-
22 partment of Defense may be used to demilitarize or dis-
23 pose of M-1 Carbines, M-1 Garand rifles, M-14 rifles,
24 .22 caliber rifles, .30 caliber rifles, or M-1911 pistols, or
25 to demilitarize or destroy small arms ammunition or am-

1 munition components that are not otherwise prohibited
2 from commercial sale under Federal law, unless the small
3 arms ammunition or ammunition components are certified
4 by the Secretary of the Army or designee as unserviceable
5 or unsafe for further use.

6 SEC. 8020. No more than \$500,000 of the funds ap-
7 propriated or made available in this Act shall be used dur-
8 ing a single fiscal year for any single relocation of an orga-
9 nization, unit, activity or function of the Department of
10 Defense into or within the National Capital Region: *Pro-*
11 *vided*, That the Secretary of Defense may waive this re-
12 striction on a case-by-case basis by certifying in writing
13 to the congressional defense committees that such a relo-
14 cation is required in the best interest of the Government.

15 SEC. 8021. Of the funds made available in this Act,
16 \$15,000,000 shall be available for incentive payments au-
17 thorized by section 504 of the Indian Financing Act of
18 1974 (25 U.S.C. 1544): *Provided*, That a prime contractor
19 or a subcontractor at any tier that makes a subcontract
20 award to any subcontractor or supplier as defined in sec-
21 tion 1544 of title 25, United States Code, or a small busi-
22 ness owned and controlled by an individual or individuals
23 defined under section 4221(9) of title 25, United States
24 Code, shall be considered a contractor for the purposes
25 of being allowed additional compensation under section

1 504 of the Indian Financing Act of 1974 (25 U.S.C.
2 1544) whenever the prime contract or subcontract amount
3 is over \$500,000 and involves the expenditure of funds
4 appropriated by an Act making appropriations for the De-
5 partment of Defense with respect to any fiscal year: *Pro-*
6 *vided further*, That notwithstanding section 1906 of title
7 41, United States Code, this section shall be applicable
8 to any Department of Defense acquisition of supplies or
9 services, including any contract and any subcontract at
10 any tier for acquisition of commercial items produced or
11 manufactured, in whole or in part, by any subcontractor
12 or supplier defined in section 1544 of title 25, United
13 States Code, or a small business owned and controlled by
14 an individual or individuals defined under section 4221(9)
15 of title 25, United States Code.

16 SEC. 8022. Funds appropriated by this Act for the
17 Defense Media Activity shall not be used for any national
18 or international political or psychological activities.

19 SEC. 8023. During the current fiscal year, the De-
20 partment of Defense is authorized to incur obligations of
21 not to exceed \$350,000,000 for purposes specified in sec-
22 tion 2350j(c) of title 10, United States Code, in anticipa-
23 tion of receipt of contributions, only from the Government
24 of Kuwait, under that section: *Provided*, That, upon re-
25 ceipt, such contributions from the Government of Kuwait

1 shall be credited to the appropriations or fund which in-
2 curred such obligations.

3 SEC. 8024. (a) Of the funds made available in this
4 Act, not less than \$40,021,000 shall be available for the
5 Civil Air Patrol Corporation, of which—

6 (1) \$28,000,000 shall be available from “Oper-
7 ation and Maintenance, Air Force” to support Civil
8 Air Patrol Corporation operation and maintenance,
9 readiness, counter-drug activities, and drug demand
10 reduction activities involving youth programs;

11 (2) \$10,337,000 shall be available from “Air-
12 craft Procurement, Air Force”; and

13 (3) \$1,684,000 shall be available from “Other
14 Procurement, Air Force” for vehicle procurement.

15 (b) The Secretary of the Air Force should waive reim-
16 bursement for any funds used by the Civil Air Patrol for
17 counter-drug activities in support of Federal, State, and
18 local government agencies.

19 SEC. 8025. (a) None of the funds appropriated in this
20 Act are available to establish a new Department of De-
21 fense (department) federally funded research and develop-
22 ment center (FFRDC), either as a new entity, or as a
23 separate entity administrated by an organization man-
24 aging another FFRDC, or as a nonprofit membership cor-

1 poration consisting of a consortium of other FFRDCs and
2 other nonprofit entities.

3 (b) No member of a Board of Directors, Trustees,
4 Overseers, Advisory Group, Special Issues Panel, Visiting
5 Committee, or any similar entity of a defense FFRDC,
6 and no paid consultant to any defense FFRDC, except
7 when acting in a technical advisory capacity, may be com-
8 pensated for his or her services as a member of such enti-
9 ty, or as a paid consultant by more than one FFRDC in
10 a fiscal year: *Provided*, That a member of any such entity
11 referred to previously in this subsection shall be allowed
12 travel expenses and per diem as authorized under the Fed-
13 eral Joint Travel Regulations, when engaged in the per-
14 formance of membership duties.

15 (c) Notwithstanding any other provision of law, none
16 of the funds available to the department from any source
17 during the current fiscal year may be used by a defense
18 FFRDC, through a fee or other payment mechanism, for
19 construction of new buildings not located on a military in-
20 stallation, for payment of cost sharing for projects funded
21 by Government grants, for absorption of contract over-
22 runs, or for certain charitable contributions, not to include
23 employee participation in community service and/or devel-
24 opment.

1 (d) Notwithstanding any other provision of law, of
2 the funds available to the department during fiscal year
3 2017, not more than 5,750 staff years of technical effort
4 (staff years) may be funded for defense FFRDCs: *Pro-*
5 *vided*, That, of the specific amount referred to previously
6 in this subsection, not more than 1,125 staff years may
7 be funded for the defense studies and analysis FFRDCs:
8 *Provided further*, That this subsection shall not apply to
9 staff years funded in the National Intelligence Program
10 (NIP) and the Military Intelligence Program (MIP).

11 (e) The Secretary of Defense shall, with the submis-
12 sion of the department's fiscal year 2018 budget request,
13 submit a report presenting the specific amounts of staff
14 years of technical effort to be allocated for each defense
15 FFRDC during that fiscal year and the associated budget
16 estimates.

17 (f) Notwithstanding any other provision of this Act,
18 the total amount appropriated in this Act for FFRDCs
19 is hereby reduced by \$60,000,000.

20 SEC. 8026. None of the funds appropriated or made
21 available in this Act shall be used to procure carbon, alloy,
22 or armor steel plate for use in any Government-owned fa-
23 cility or property under the control of the Department of
24 Defense which were not melted and rolled in the United
25 States or Canada: *Provided*, That these procurement re-

1 strictions shall apply to any and all Federal Supply Class
2 9515, American Society of Testing and Materials (ASTM)
3 or American Iron and Steel Institute (AISI) specifications
4 of carbon, alloy or armor steel plate: *Provided further*,
5 That the Secretary of the military department responsible
6 for the procurement may waive this restriction on a case-
7 by-case basis by certifying in writing to the Committees
8 on Appropriations of the House of Representatives and the
9 Senate that adequate domestic supplies are not available
10 to meet Department of Defense requirements on a timely
11 basis and that such an acquisition must be made in order
12 to acquire capability for national security purposes: *Pro-*
13 *vided further*, That these restrictions shall not apply to
14 contracts which are in being as of the date of the enact-
15 ment of this Act.

16 SEC. 8027. For the purposes of this Act, the term
17 “congressional defense committees” means the Armed
18 Services Committee of the House of Representatives, the
19 Armed Services Committee of the Senate, the Sub-
20 committee on Defense of the Committee on Appropriations
21 of the Senate, and the Subcommittee on Defense of the
22 Committee on Appropriations of the House of Representa-
23 tives.

24 SEC. 8028. During the current fiscal year, the De-
25 partment of Defense may acquire the modification, depot

1 maintenance and repair of aircraft, vehicles and vessels
2 as well as the production of components and other De-
3 fense-related articles, through competition between De-
4 partment of Defense depot maintenance activities and pri-
5 vate firms: *Provided*, That the Senior Acquisition Execu-
6 tive of the military department or Defense Agency con-
7 cerned, with power of delegation, shall certify that success-
8 ful bids include comparable estimates of all direct and in-
9 direct costs for both public and private bids: *Provided fur-*
10 *ther*, That Office of Management and Budget Circular A-
11 76 shall not apply to competitions conducted under this
12 section.

13 SEC. 8029. (a)(1) If the Secretary of Defense, after
14 consultation with the United States Trade Representative,
15 determines that a foreign country which is party to an
16 agreement described in paragraph (2) has violated the
17 terms of the agreement by discriminating against certain
18 types of products produced in the United States that are
19 covered by the agreement, the Secretary of Defense shall
20 rescind the Secretary's blanket waiver of the Buy Amer-
21 ican Act with respect to such types of products produced
22 in that foreign country.

23 (2) An agreement referred to in paragraph (1) is any
24 reciprocal defense procurement memorandum of under-
25 standing, between the United States and a foreign country

1 pursuant to which the Secretary of Defense has prospec-
2 tively waived the Buy American Act for certain products
3 in that country.

4 (b) The Secretary of Defense shall submit to the Con-
5 gress a report on the amount of Department of Defense
6 purchases from foreign entities in fiscal year 2017. Such
7 report shall separately indicate the dollar value of items
8 for which the Buy American Act was waived pursuant to
9 any agreement described in subsection (a)(2), the Trade
10 Agreement Act of 1979 (19 U.S.C. 2501 et seq.), or any
11 international agreement to which the United States is a
12 party.

13 (c) For purposes of this section, the term “Buy
14 American Act” means chapter 83 of title 41, United
15 States Code.

16 SEC. 8030. During the current fiscal year, amounts
17 contained in the Department of Defense Overseas Military
18 Facility Investment Recovery Account established by sec-
19 tion 2921(c)(1) of the National Defense Authorization Act
20 of 1991 (Public Law 101–510; 10 U.S.C. 2687 note) shall
21 be available until expended for the payments specified by
22 section 2921(c)(2) of that Act.

23 SEC. 8031. (a) Notwithstanding any other provision
24 of law, the Secretary of the Air Force may convey at no
25 cost to the Air Force, without consideration, to Indian

1 tribes located in the States of Nevada, Idaho, North Da-
2 kota, South Dakota, Montana, Oregon, Minnesota, and
3 Washington relocatable military housing units located at
4 Grand Forks Air Force Base, Malmstrom Air Force Base,
5 Mountain Home Air Force Base, Ellsworth Air Force
6 Base, and Minot Air Force Base that are excess to the
7 needs of the Air Force.

8 (b) The Secretary of the Air Force shall convey, at
9 no cost to the Air Force, military housing units under sub-
10 section (a) in accordance with the request for such units
11 that are submitted to the Secretary by the Operation
12 Walking Shield Program on behalf of Indian tribes located
13 in the States of Nevada, Idaho, North Dakota, South Da-
14 kota, Montana, Oregon, Minnesota, and Washington. Any
15 such conveyance shall be subject to the condition that the
16 housing units shall be removed within a reasonable period
17 of time, as determined by the Secretary.

18 (c) The Operation Walking Shield Program shall re-
19 solve any conflicts among requests of Indian tribes for
20 housing units under subsection (a) before submitting re-
21 quests to the Secretary of the Air Force under subsection
22 (b).

23 (d) In this section, the term “Indian tribe” means
24 any recognized Indian tribe included on the current list
25 published by the Secretary of the Interior under section

1 104 of the Federally Recognized Indian Tribe Act of 1994
2 (Public Law 103–454; 108 Stat. 4792; 25 U.S.C. 479a–
3 1).

4 SEC. 8032. During the current fiscal year, appropria-
5 tions which are available to the Department of Defense
6 for operation and maintenance may be used to purchase
7 items having an investment item unit cost of not more
8 than \$250,000.

9 SEC. 8033. None of the funds made available by this
10 Act may be used to—

11 (1) disestablish, or prepare to disestablish, a
12 Senior Reserve Officers’ Training Corps program in
13 accordance with Department of Defense Instruction
14 Number 1215.08, dated June 26, 2006; or

15 (2) close, downgrade from host to extension
16 center, or place on probation a Senior Reserve Offi-
17 cers’ Training Corps program in accordance with the
18 information paper of the Department of the Army
19 titled “Army Senior Reserve Officers’ Training
20 Corps (SROTC) Program Review and Criteria”,
21 dated January 27, 2014.

22 SEC. 8034. The Secretary of Defense shall issue reg-
23 ulations to prohibit the sale of any tobacco or tobacco-
24 related products in military resale outlets in the United
25 States, its territories and possessions at a price below the

1 most competitive price in the local community: *Provided*,
2 That such regulations shall direct that the prices of to-
3 bacco or tobacco-related products in overseas military re-
4 tail outlets shall be within the range of prices established
5 for military retail system stores located in the United
6 States.

7 SEC. 8035. (a) During the current fiscal year, none
8 of the appropriations or funds available to the Department
9 of Defense Working Capital Funds shall be used for the
10 purchase of an investment item for the purpose of acquir-
11 ing a new inventory item for sale or anticipated sale dur-
12 ing the current fiscal year or a subsequent fiscal year to
13 customers of the Department of Defense Working Capital
14 Funds if such an item would not have been chargeable
15 to the Department of Defense Business Operations Fund
16 during fiscal year 1994 and if the purchase of such an
17 investment item would be chargeable during the current
18 fiscal year to appropriations made to the Department of
19 Defense for procurement.

20 (b) The fiscal year 2018 budget request for the De-
21 partment of Defense as well as all justification material
22 and other documentation supporting the fiscal year 2018
23 Department of Defense budget shall be prepared and sub-
24 mitted to the Congress on the basis that any equipment
25 which was classified as an end item and funded in a pro-

1 curement appropriation contained in this Act shall be
2 budgeted for in a proposed fiscal year 2018 procurement
3 appropriation and not in the supply management business
4 area or any other area or category of the Department of
5 Defense Working Capital Funds.

6 SEC. 8036. None of the funds appropriated by this
7 Act for programs of the Central Intelligence Agency shall
8 remain available for obligation beyond the current fiscal
9 year, except for funds appropriated for the Reserve for
10 Contingencies, which shall remain available until Sep-
11 tember 30, 2018: *Provided*, That funds appropriated,
12 transferred, or otherwise credited to the Central Intel-
13 ligence Agency Central Services Working Capital Fund
14 during this or any prior or subsequent fiscal year shall
15 remain available until expended: *Provided further*, That
16 any funds appropriated or transferred to the Central Intel-
17 ligence Agency for advanced research and development ac-
18 quisition, for agent operations, and for covert action pro-
19 grams authorized by the President under section 503 of
20 the National Security Act of 1947 (50 U.S.C. 3093) shall
21 remain available until September 30, 2018.

22 SEC. 8037. Notwithstanding any other provision of
23 law, funds made available in this Act and hereafter for
24 the Defense Intelligence Agency may be used for the de-
25 sign, development, and deployment of General Defense In-

1 telligence Program intelligence communications and intel-
2 ligence information systems for the Services, the Unified
3 and Specified Commands, and the component commands.

4 SEC. 8038. Of the funds appropriated to the Depart-
5 ment of Defense under the heading “Operation and Main-
6 tenance, Defense-Wide”, not less than \$12,000,000 shall
7 be made available only for the mitigation of environmental
8 impacts, including training and technical assistance to
9 tribes, related administrative support, the gathering of in-
10 formation, documenting of environmental damage, and de-
11 veloping a system for prioritization of mitigation and cost
12 to complete estimates for mitigation, on Indian lands re-
13 sulting from Department of Defense activities.

14 SEC. 8039. (a) None of the funds appropriated in this
15 Act may be expended by an entity of the Department of
16 Defense unless the entity, in expending the funds, com-
17 plies with the Buy American Act. For purposes of this
18 subsection, the term “Buy American Act” means chapter
19 83 of title 41, United States Code.

20 (b) If the Secretary of Defense determines that a per-
21 son has been convicted of intentionally affixing a label
22 bearing a “Made in America” inscription to any product
23 sold in or shipped to the United States that is not made
24 in America, the Secretary shall determine, in accordance
25 with section 2410f of title 10, United States Code, wheth-

1 er the person should be debarred from contracting with
2 the Department of Defense.

3 (c) In the case of any equipment or products pur-
4 chased with appropriations provided under this Act, it is
5 the sense of the Congress that any entity of the Depart-
6 ment of Defense, in expending the appropriation, purchase
7 only American-made equipment and products, provided
8 that American-made equipment and products are cost-
9 competitive, quality competitive, and available in a timely
10 fashion.

11 SEC. 8040. Notwithstanding any other provision of
12 law, none of the funds appropriated or otherwise made
13 available by this or any other Act may be used to consoli-
14 date or relocate any element of a United States Air Force
15 Rapid Engineer Deployable Heavy Operational Repair
16 Squadron Engineer (RED HORSE) outside of the United
17 States until the Secretary of the Air Force—

18 (1) completes an analysis and comparison of
19 the cost and infrastructure investment required to
20 consolidate or relocate a RED HORSE squadron
21 outside of the United States versus within the
22 United States;

23 (2) provides to the congressional defense com-
24 mittees a report detailing the findings of the cost
25 analysis; and

1 (3) certifies in writing to the congressional de-
2 fense committees that the preferred site for the con-
3 solidation or relocation yields the greatest savings
4 for the Air Force:

5 *Provided*, That the term “United States” in this section
6 does not include any territory or possession of the United
7 States.

8 SEC. 8041. (a) Except as provided in subsections (b)
9 and (c), none of the funds made available by this Act may
10 be used—

11 (1) to establish a field operating agency; or

12 (2) to pay the basic pay of a member of the
13 Armed Forces or civilian employee of the depart-
14 ment who is transferred or reassigned from a head-
15 quarters activity if the member or employee’s place
16 of duty remains at the location of that headquarters.

17 (b) The Secretary of Defense or Secretary of a mili-
18 tary department may waive the limitations in subsection
19 (a), on a case-by-case basis, if the Secretary determines,
20 and certifies to the Committees on Appropriations of the
21 House of Representatives and the Senate that the grant-
22 ing of the waiver will reduce the personnel requirements
23 or the financial requirements of the department.

24 (c) This section does not apply to—

1 (1) field operating agencies funded within the
2 National Intelligence Program;

3 (2) an Army field operating agency established
4 to eliminate, mitigate, or counter the effects of im-
5 provised explosive devices, and, as determined by the
6 Secretary of the Army, other similar threats;

7 (3) an Army field operating agency established
8 to improve the effectiveness and efficiencies of bio-
9 metric activities and to integrate common biometric
10 technologies throughout the Department of Defense;
11 or

12 (4) an Air Force field operating agency estab-
13 lished to administer the Air Force Mortuary Affairs
14 Program and Mortuary Operations for the Depart-
15 ment of Defense and authorized Federal entities.

16 SEC. 8042. (a) None of the funds appropriated by
17 this Act shall be available to convert to contractor per-
18 formance an activity or function of the Department of De-
19 fense that, on or after the date of the enactment of this
20 Act, is performed by Department of Defense civilian em-
21 ployees unless—

22 (1) the conversion is based on the result of a
23 public-private competition that includes a most effi-
24 cient and cost effective organization plan developed
25 by such activity or function;

1 (2) the Competitive Sourcing Official deter-
2 mines that, over all performance periods stated in
3 the solicitation of offers for performance of the ac-
4 tivity or function, the cost of performance of the ac-
5 tivity or function by a contractor would be less costly
6 to the Department of Defense by an amount that
7 equals or exceeds the lesser of—

8 (A) 10 percent of the most efficient organi-
9 zation's personnel-related costs for performance
10 of that activity or function by Federal employ-
11 ees; or

12 (B) \$10,000,000; and

13 (3) the contractor does not receive an advan-
14 tage for a proposal that would reduce costs for the
15 Department of Defense by—

16 (A) not making an employer-sponsored
17 health insurance plan available to the workers
18 who are to be employed in the performance of
19 that activity or function under the contract; or

20 (B) offering to such workers an employer-
21 sponsored health benefits plan that requires the
22 employer to contribute less towards the pre-
23 mium or subscription share than the amount
24 that is paid by the Department of Defense for

1 health benefits for civilian employees under
2 chapter 89 of title 5, United States Code.

3 (b)(1) The Department of Defense, without regard
4 to subsection (a) of this section or subsection (a), (b), or
5 (c) of section 2461 of title 10, United States Code, and
6 notwithstanding any administrative regulation, require-
7 ment, or policy to the contrary shall have full authority
8 to enter into a contract for the performance of any com-
9 mercial or industrial type function of the Department of
10 Defense that—

11 (A) is included on the procurement list estab-
12 lished pursuant to section 2 of the Javits-Wagner-
13 O'Day Act (section 8503 of title 41, United States
14 Code);

15 (B) is planned to be converted to performance
16 by a qualified nonprofit agency for the blind or by
17 a qualified nonprofit agency for other severely handi-
18 capped individuals in accordance with that Act; or

19 (C) is planned to be converted to performance
20 by a qualified firm under at least 51 percent owner-
21 ship by an Indian tribe, as defined in section 4(e)
22 of the Indian Self-Determination and Education As-
23 sistance Act (25 U.S.C. 450b(e)), or a Native Ha-
24 waiian Organization, as defined in section 8(a)(15)
25 of the Small Business Act (15 U.S.C. 637(a)(15)).

(2) This section shall not apply to depot contracts or contracts for depot maintenance as provided in sections 2469 and 2474 of title 10, United States Code.

(c) The conversion of any activity or function of the Department of Defense under the authority provided by this section shall be credited toward any competitive or outsourcing goal, target, or measurement that may be established by statute, regulation, or policy and is deemed to be awarded under the authority of, and in compliance with, subsection (h) of section 2304 of title 10, United States Code, for the competition or outsourcing of commercial activities.

(RESCISSIONS)

3 SEC. 8044. None of the funds available in this Act
4 may be used to reduce the authorized positions for mili-
5 tary technicians (dual status) of the Army National
6 Guard, Air National Guard, Army Reserve and Air Force
7 Reserve for the purpose of applying any administratively
8 imposed civilian personnel ceiling, freeze, or reduction on
9 military technicians (dual status), unless such reductions
10 are a direct result of a reduction in military force struc-
11 ture.

12 SEC. 8045. None of the funds appropriated or other-
13 wise made available in this Act may be obligated or ex-
14 pended for assistance to the Democratic People’s Republic
15 of Korea unless specifically appropriated for that purpose.

16 SEC. 8046. Funds appropriated in this Act for oper-
17 ation and maintenance of the Military Departments, Com-
18 batant Commands and Defense Agencies shall be available
19 for reimbursement of pay, allowances and other expenses
20 which would otherwise be incurred against appropriations
21 for the National Guard and Reserve when members of the
22 National Guard and Reserve provide intelligence or coun-
23 terintelligence support to Combatant Commands, Defense
24 Agencies and Joint Intelligence Activities, including the
25 activities and programs included within the National Intel-

1 ligence Program and the Military Intelligence Program:
2 *Provided*, That nothing in this section authorizes deviation
3 from established Reserve and National Guard personnel
4 and training procedures.

5 SEC. 8047. (a) None of the funds available to the
6 Department of Defense for any fiscal year for drug inter-
7 diction or counter-drug activities may be transferred to
8 any other department or agency of the United States ex-
9 cept as specifically provided in an appropriations law.

10 (b) None of the funds available to the Central Intel-
11 ligence Agency for any fiscal year for drug interdiction or
12 counter-drug activities may be transferred to any other de-
13 partment or agency of the United States except as specifi-
14 cally provided in an appropriations law.

15 SEC. 8048. None of the funds appropriated by this
16 Act may be used for the procurement of ball and roller
17 bearings other than those produced by a domestic source
18 and of domestic origin: *Provided*, That the Secretary of
19 the military department responsible for such procurement
20 may waive this restriction on a case-by-case basis by certi-
21 fying in writing to the Committees on Appropriations of
22 the House of Representatives and the Senate, that ade-
23 quate domestic supplies are not available to meet Depart-
24 ment of Defense requirements on a timely basis and that
25 such an acquisition must be made in order to acquire ca-

1 pability for national security purposes: *Provided further*,
2 That this restriction shall not apply to the purchase of
3 “commercial items”, as defined by section 103 of title 41,
4 United States Code, except that the restriction shall apply
5 to ball or roller bearings purchased as end items.

6 SEC. 8049. None of the funds made available by this
7 Act may be used to retire, divest, realign, or transfer RQ–
8 4B Global Hawk aircraft, or to disestablish or convert
9 units associated with such aircraft.

10 SEC. 8050. None of the funds made available by this
11 Act for Evolved Expendable Launch Vehicle service com-
12 petitive procurements may be used unless the competitive
13 procurements are open for award to all certified providers
14 of Evolved Expendable Launch Vehicle-class systems: *Pro-*
15 *vided*, That the award shall be made to the provider that
16 offers the best value to the government.

17 SEC. 8051. In addition to the amounts appropriated
18 or otherwise made available elsewhere in this Act,
19 \$44,000,000 is hereby appropriated to the Department of
20 Defense: *Provided*, That upon the determination of the
21 Secretary of Defense that it shall serve the national inter-
22 est, the Secretary shall make grants in the amounts speci-
23 fied as follows: \$20,000,000 to the United Service Organi-
24 zations and \$24,000,000 to the Red Cross.

1 SEC. 8052. None of the funds in this Act may be
2 used to purchase any supercomputer which is not manu-
3 factured in the United States, unless the Secretary of De-
4 fense certifies to the congressional defense committees
5 that such an acquisition must be made in order to acquire
6 capability for national security purposes that is not avail-
7 able from United States manufacturers.

8 SEC. 8053. Notwithstanding any other provision in
9 this Act, the Small Business Innovation Research program
10 and the Small Business Technology Transfer program set-
11 asides shall be taken proportionally from all programs,
12 projects, or activities to the extent they contribute to the
13 extramural budget.

14 SEC. 8054. None of the funds available to the De-
15 partment of Defense under this Act shall be obligated or
16 expended to pay a contractor under a contract with the
17 Department of Defense for costs of any amount paid by
18 the contractor to an employee when—

19 (1) such costs are for a bonus or otherwise in
20 excess of the normal salary paid by the contractor
21 to the employee; and

22 (2) such bonus is part of restructuring costs as-
23 sociated with a business combination.

(INCLUDING TRANSFER OF FUNDS)

SEC. 8055. During the current fiscal year, no more than \$30,000,000 of appropriations made in this Act under the heading “Operation and Maintenance, Defense-Wide” may be transferred to appropriations available for the pay of military personnel, to be merged with, and to be available for the same time period as the appropriations to which transferred, to be used in support of such personnel in connection with support and services for eligible organizations and activities outside the Department of Defense pursuant to section 2012 of title 10, United States Code.

SEC. 8056. During the current fiscal year, in the case of an appropriation account of the Department of Defense for which the period of availability for obligation has expired or which has closed under the provisions of section 1552 of title 31, United States Code, and which has a negative unliquidated or unexpended balance, an obligation or an adjustment of an obligation may be charged to any current appropriation account for the same purpose as the expired or closed account if—

(1) the obligation would have been properly chargeable (except as to amount) to the expired or closed account before the end of the period of availability or closing of that account;

1 (2) the obligation is not otherwise properly
2 chargeable to any current appropriation account of
3 the Department of Defense; and

4 (3) in the case of an expired account, the obli-
5 gation is not chargeable to a current appropriation
6 of the Department of Defense under the provisions
7 of section 1405(b)(8) of the National Defense Au-
8 thorization Act for Fiscal Year 1991, Public Law
9 101–510, as amended (31 U.S.C. 1551 note): *Pro-*
10 *vided*, That in the case of an expired account, if sub-
11 sequent review or investigation discloses that there
12 was not in fact a negative unliquidated or unex-
13 pended balance in the account, any charge to a cur-
14 rent account under the authority of this section shall
15 be reversed and recorded against the expired ac-
16 count: *Provided further*, That the total amount
17 charged to a current appropriation under this sec-
18 tion may not exceed an amount equal to 1 percent
19 of the total appropriation for that account.

20 SEC. 8057. (a) Notwithstanding any other provision
21 of law, the Chief of the National Guard Bureau may per-
22 mit the use of equipment of the National Guard Distance
23 Learning Project by any person or entity on a space-avail-
24 able, reimbursable basis. The Chief of the National Guard

1 Bureau shall establish the amount of reimbursement for
2 such use on a case-by-case basis.

3 (b) Amounts collected under subsection (a) shall be
4 credited to funds available for the National Guard Dis-
5 tance Learning Project and be available to defray the costs
6 associated with the use of equipment of the project under
7 that subsection. Such funds shall be available for such
8 purposes without fiscal year limitation.

9 SEC. 8058. None of the funds available to the De-
10 partment of Defense may be obligated to modify command
11 and control relationships to give Fleet Forces Command
12 operational and administrative control of United States
13 Navy forces assigned to the Pacific fleet: *Provided*, That
14 the command and control relationships which existed on
15 October 1, 2004, shall remain in force until a written
16 modification has been proposed to the House and Senate
17 Appropriations Committees: *Provided further*, That the
18 proposed modification may be implemented 30 days after
19 the notification unless an objection is received from either
20 the House or Senate Appropriations Committees: *Provided*
21 *further*, That any proposed modification shall not preclude
22 the ability of the commander of United States Pacific
23 Command to meet operational requirements.

(INCLUDING TRANSFER OF FUNDS)

SEC. 8059. Of the funds appropriated in this Act under the heading “Operation and Maintenance, Defense-wide”, \$25,000,000 shall be for continued implementation and expansion of the Sexual Assault Special Victims’ Counsel Program: *Provided*, That the funds are made available for transfer to the Department of the Army, the Department of the Navy, and the Department of the Air Force: *Provided further*, That funds transferred shall be merged with and available for the same purposes and for the same time period as the appropriations to which the funds are transferred: *Provided further*, That this transfer authority is in addition to any other transfer authority provided in this Act.

SEC. 8060. None of the funds appropriated in title IV of this Act may be used to procure end-items for delivery to military forces for operational training, operational use or inventory requirements: *Provided*, That this restriction does not apply to end-items used in development, prototyping, and test activities preceding and leading to acceptance for operational use: *Provided further*, That this restriction does not apply to programs funded within the National Intelligence Program: *Provided further*, That the Secretary of Defense may waive this restriction on a case-by-case basis by certifying in writing to the Committees

1 on Appropriations of the House of Representatives and the
2 Senate that it is in the national security interest to do
3 so.

4 SEC. 8061. (a) The Secretary of Defense may, on a
5 case-by-case basis, waive with respect to a foreign country
6 each limitation on the procurement of defense items from
7 foreign sources provided in law if the Secretary determines
8 that the application of the limitation with respect to that
9 country would invalidate cooperative programs entered
10 into between the Department of Defense and the foreign
11 country, or would invalidate reciprocal trade agreements
12 for the procurement of defense items entered into under
13 section 2531 of title 10, United States Code, and the
14 country does not discriminate against the same or similar
15 defense items produced in the United States for that coun-
16 try.

17 (b) Subsection (a) applies with respect to—

18 (1) contracts and subcontracts entered into on
19 or after the date of the enactment of this Act; and

20 (2) options for the procurement of items that
21 are exercised after such date under contracts that
22 are entered into before such date if the option prices
23 are adjusted for any reason other than the applica-
24 tion of a waiver granted under subsection (a).

1 (c) Subsection (a) does not apply to a limitation re-
2 garding construction of public vessels, ball and roller bear-
3 ings, food, and clothing or textile materials as defined by
4 section XI (chapters 50–65) of the Harmonized Tariff
5 Schedule of the United States and products classified
6 under headings 4010, 4202, 4203, 6401 through 6406,
7 6505, 7019, 7218 through 7229, 7304.41 through
8 7304.49, 7306.40, 7502 through 7508, 8105, 8108, 8109,
9 8211, 8215, and 9404.

10 SEC. 8062. None of the funds appropriated or other-
11 wise made available by this or other Department of De-
12 fense Appropriations Acts may be obligated or expended
13 for the purpose of performing repairs or maintenance to
14 military family housing units of the Department of De-
15 fense, including areas in such military family housing
16 units that may be used for the purpose of conducting offi-
17 cial Department of Defense business.

18 (INCLUDING TRANSFER OF FUNDS)

19 SEC. 8063. Of the amounts appropriated for “Oper-
20 ation and Maintenance, Navy”, up to \$1,000,000 shall be
21 available for transfer to the John C. Stennis Center for
22 Public Service Development Trust Fund established under
23 section 116 of the John C. Stennis Center for Public Serv-
24 ice Training and Development Act (2 U.S.C. 1105).

1 SEC. 8064. Notwithstanding any other provision of
2 law, funds appropriated in this Act under the heading
3 “Research, Development, Test and Evaluation, Defense-
4 Wide” for any new start advanced concept technology
5 demonstration project or joint capability demonstration
6 project may only be obligated 45 days after a report, in-
7 cluding a description of the project, the planned acquisi-
8 tion and transition strategy and its estimated annual and
9 total cost, has been provided in writing to the congres-
10 sional defense committees: *Provided*, That the Secretary
11 of Defense may waive this restriction on a case-by-case
12 basis by certifying to the congressional defense committees
13 that it is in the national interest to do so.

14 SEC. 8065. The Secretary of Defense shall continue
15 to provide a classified quarterly report to the House and
16 Senate Appropriations Committees, Subcommittees on
17 Defense on certain matters as directed in the classified
18 annex accompanying this Act.

19 SEC. 8066. Notwithstanding section 12310(b) of title
20 10, United States Code, a Reserve who is a member of
21 the National Guard serving on full-time National Guard
22 duty under section 502(f) of title 32, United States Code,
23 may perform duties in support of the ground-based ele-
24 ments of the National Ballistic Missile Defense System.

1 SEC. 8067. None of the funds provided in this Act
2 may be used to transfer to any nongovernmental entity
3 ammunition held by the Department of Defense that has
4 a center-fire cartridge and a United States military no-
5 menclature designation of “armor penetrator”, “armor
6 piercing (AP)”, “armor piercing incendiary (API)”, or
7 “armor-piercing incendiary tracer (API-T)”, except to an
8 entity performing demilitarization services for the Depart-
9 ment of Defense under a contract that requires the entity
10 to demonstrate to the satisfaction of the Department of
11 Defense that armor piercing projectiles are either: (1) ren-
12 dered incapable of reuse by the demilitarization process;
13 or (2) used to manufacture ammunition pursuant to a con-
14 tract with the Department of Defense or the manufacture
15 of ammunition for export pursuant to a License for Per-
16 manent Export of Unclassified Military Articles issued by
17 the Department of State.

18 SEC. 8068. Notwithstanding any other provision of
19 law, the Chief of the National Guard Bureau, or his des-
20 ignee, may waive payment of all or part of the consider-
21 ation that otherwise would be required under section 2667
22 of title 10, United States Code, in the case of a lease of
23 personal property for a period not in excess of 1 year to
24 any organization specified in section 508(d) of title 32,
25 United States Code, or any other youth, social, or fra-

1 ternal nonprofit organization as may be approved by the
2 Chief of the National Guard Bureau, or his designee, on
3 a case-by-case basis.

4 (INCLUDING TRANSFER OF FUNDS)

5 SEC. 8069. Of the amounts appropriated in this Act
6 under the heading “Operation and Maintenance, Army”,
7 \$75,950,170 shall remain available until expended: *Pro-*
8 *vided*, That, notwithstanding any other provision of law,
9 the Secretary of Defense is authorized to transfer such
10 funds to other activities of the Federal Government: *Pro-*
11 *vided further*, That the Secretary of Defense is authorized
12 to enter into and carry out contracts for the acquisition
13 of real property, construction, personal services, and oper-
14 ations related to projects carrying out the purposes of this
15 section: *Provided further*, That contracts entered into
16 under the authority of this section may provide for such
17 indemnification as the Secretary determines to be nec-
18 essary: *Provided further*, That projects authorized by this
19 section shall comply with applicable Federal, State, and
20 local law to the maximum extent consistent with the na-
21 tional security, as determined by the Secretary of Defense.

22 SEC. 8070. (a) None of the funds appropriated in this
23 or any other Act may be used to take any action to mod-
24 ify—

1 (1) the appropriations account structure for the
2 National Intelligence Program budget, including
3 through the creation of a new appropriation or new
4 appropriation account;

5 (2) how the National Intelligence Program
6 budget request is presented in the unclassified P-1,
7 R-1, and O-1 documents supporting the Depart-
8 ment of Defense budget request;

9 (3) the process by which the National Intel-
10 ligence Program appropriations are apportioned to
11 the executing agencies; or

12 (4) the process by which the National Intel-
13 ligence Program appropriations are allotted, obli-
14 gated and disbursed.

15 (b) Nothing in section (a) shall be construed to pro-
16 hibit the merger of programs or changes to the National
17 Intelligence Program budget at or below the Expenditure
18 Center level, provided such change is otherwise in accord-
19 ance with paragraphs (a)(1)–(3).

20 (c) The Director of National Intelligence and the Sec-
21 retary of Defense may jointly, only for the purposes of
22 achieving auditable financial statements and improving
23 fiscal reporting, study and develop detailed proposals for
24 alternative financial management processes. Such study
25 shall include a comprehensive counterintelligence risk as-

1 sessment to ensure that none of the alternative processes
2 will adversely affect counterintelligence.

3 (d) Upon development of the detailed proposals de-
4 fined under subsection (c), the Director of National Intel-
5 ligence and the Secretary of Defense shall—

6 (1) provide the proposed alternatives to all af-
7 fected agencies;

8 (2) receive certification from all affected agen-
9 cies attesting that the proposed alternatives will help
10 achieve auditability, improve fiscal reporting, and
11 will not adversely affect counterintelligence; and

12 (3) not later than 30 days after receiving all
13 necessary certifications under paragraph (2), present
14 the proposed alternatives and certifications to the
15 congressional defense and intelligence committees.

16 SEC. 8071. In addition to amounts provided else-
17 where in this Act, \$5,000,000 is hereby appropriated to
18 the Department of Defense, to remain available for obliga-
19 tion until expended: *Provided*, That notwithstanding any
20 other provision of law, that upon the determination of the
21 Secretary of Defense that it shall serve the national inter-
22 est, these funds shall be available only for a grant to the
23 Fisher House Foundation, Inc., only for the construction
24 and furnishing of additional Fisher Houses to meet the
25 needs of military family members when confronted with

1 the illness or hospitalization of an eligible military bene-
2 ficiary.

3 (INCLUDING TRANSFER OF FUNDS)

4 SEC. 8072. Of the amounts appropriated in this Act
5 under the headings “Procurement, Defense-Wide” and
6 “Research, Development, Test and Evaluation, Defense-
7 Wide”, \$600,735,000 shall be for the Israeli Cooperative
8 Programs: *Provided*, That of this amount, \$62,000,000
9 shall be for the Secretary of Defense to provide to the Gov-
10 ernment of Israel for the procurement of the Iron Dome
11 defense system to counter short-range rocket threats, sub-
12 ject to the U.S.-Israel Iron Dome Procurement Agree-
13 ment, as amended; \$266,511,000 shall be for the Short
14 Range Ballistic Missile Defense (SRBMD) program, in-
15 cluding cruise missile defense research and development
16 under the SRBMD program, of which \$150,000,000 shall
17 be for co-production activities of SRBMD missiles in the
18 United States and in Israel to meet Israel’s defense re-
19 quirements consistent with each nation’s laws, regulations,
20 and procedures, of which not more than \$90,000,000, sub-
21 ject to previously established transfer procedures, may be
22 obligated or expended until establishment of a U.S.-Israeli
23 co-production agreement for SRBMD; \$204,893,000 shall
24 be for an upper-tier component to the Israeli Missile De-
25 fense Architecture, of which \$120,000,000 shall be for co-

1 production activities of Arrow 3 Upper Tier missiles in
2 the United States and in Israel to meet Israel's defense
3 requirements consistent with each nation's laws, regula-
4 tions, and procedures, of which not more than
5 \$70,000,000 subject to previously established transfer
6 procedures, may be obligated or expended until establish-
7 ment of a U.S.-Israeli co-production agreement for Arrow
8 3 Upper Tier; and \$67,331,000 shall be for the Arrow
9 System Improvement Program including development of
10 a long range, ground and airborne, detection suite: *Pro-*
11 *vided further*, That the transfer authority provided under
12 this provision is in addition to any other transfer authority
13 contained in this Act.

14 (INCLUDING TRANSFER OF FUNDS)

15 SEC. 8073. Of the amounts appropriated in this Act
16 under the heading "Shipbuilding and Conversion, Navy",
17 \$160,274,000 shall be available until September 30, 2017,
18 to fund prior year shipbuilding cost increases: *Provided*,
19 That upon enactment of this Act, the Secretary of the
20 Navy shall transfer funds to the following appropriations
21 in the amounts specified: *Provided further*, That the
22 amounts transferred shall be merged with and be available
23 for the same purposes as the appropriations to which
24 transferred to:

1 (1) Under the heading “Shipbuilding and Con-
2 version, Navy”, 2012/2017: LPD–17 Amphibious
3 Transport Dock Program \$45,060,000;

4 (2) Under the heading “Shipbuilding and Con-
5 version, Navy”, 2011/2017: DDG–51 Destroyer
6 \$15,959,000;

7 (3) Under the heading “Shipbuilding and Con-
8 version, Navy”, 2012/2017: Littoral Combat Ship
9 \$3,600,000;

10 (4) Under the heading “Shipbuilding and Con-
11 version, Navy”, 2013/2017: Littoral Combat Ship
12 \$82,400,000;

13 (5) Under the heading “Shipbuilding and Con-
14 version, Navy”, 2012/2017: Expeditionary Fast
15 Transport \$6,710,000; and

16 (6) Under the heading “Shipbuilding and Con-
17 version, Navy”, 2013/2017: Expeditionary Fast
18 Transport \$6,545,000.

19 SEC. 8074. Funds appropriated by this Act, or made
20 available by the transfer of funds in this Act, for intel-
21 ligence activities are deemed to be specifically authorized
22 by the Congress for purposes of section 504 of the Na-
23 tional Security Act of 1947 (50 U.S.C. 3094) during fiscal
24 year 2017 until the enactment of the Intelligence Author-
25 ization Act for Fiscal Year 2017.

1 SEC. 8075. None of the funds provided in this Act
2 shall be available for obligation or expenditure through a
3 reprogramming of funds that creates or initiates a new
4 program, project, or activity unless such program, project,
5 or activity must be undertaken immediately in the interest
6 of national security and only after written prior notifica-
7 tion to the congressional defense committees.

8 SEC. 8076. The budget of the President for fiscal
9 year 2018 submitted to the Congress pursuant to section
10 1105 of title 31, United States Code, shall include sepa-
11 rate budget justification documents for costs of United
12 States Armed Forces' participation in contingency oper-
13 ations for the Military Personnel accounts, the Operation
14 and Maintenance accounts, the Procurement accounts,
15 and the Research, Development, Test and Evaluation ac-
16 counts: *Provided*, That these documents shall include a de-
17 scription of the funding requested for each contingency op-
18 eration, for each military service, to include all Active and
19 Reserve components, and for each appropriations account:
20 *Provided further*, That these documents shall include esti-
21 mated costs for each element of expense or object class,
22 a reconciliation of increases and decreases for each contin-
23 gency operation, and programmatic data including, but
24 not limited to, troop strength for each Active and Reserve
25 component, and estimates of the major weapons systems

1 deployed in support of each contingency: *Provided further*,
2 That these documents shall include budget exhibits OP–
3 5 and OP–32 (as defined in the Department of Defense
4 Financial Management Regulation) for all contingency op-
5 erations for the budget year and the two preceding fiscal
6 years.

7 SEC. 8077. None of the funds in this Act may be
8 used for research, development, test, evaluation, procure-
9 ment or deployment of nuclear armed interceptors of a
10 missile defense system.

11 SEC. 8078. Notwithstanding any other provision of
12 this Act, to reflect savings due to favorable foreign ex-
13 change rates, the total amount appropriated in this Act
14 is hereby reduced by \$157,000,000.

15 SEC. 8079. None of the funds appropriated or made
16 available in this Act shall be used to reduce or disestablish
17 the operation of the 53rd Weather Reconnaissance Squad-
18 ron of the Air Force Reserve, if such action would reduce
19 the WC–130 Weather Reconnaissance mission below the
20 levels funded in this Act: *Provided*, That the Air Force
21 shall allow the 53rd Weather Reconnaissance Squadron to
22 perform other missions in support of national defense re-
23 quirements during the non-hurricane season.

24 SEC. 8080. None of the funds provided in this Act
25 shall be available for integration of foreign intelligence in-

1 formation unless the information has been lawfully col-
2 lected and processed during the conduct of authorized for-
3 eign intelligence activities: *Provided*, That information
4 pertaining to United States persons shall only be handled
5 in accordance with protections provided in the Fourth
6 Amendment of the United States Constitution as imple-
7 mented through Executive Order No. 12333.

8 SEC. 8081. (a) None of the funds appropriated by
9 this Act may be used to transfer research and develop-
10 ment, acquisition, or other program authority relating to
11 current tactical unmanned aerial vehicles (TUAVs) from
12 the Army.

13 (b) The Army shall retain responsibility for and oper-
14 ational control of the MQ-1C Gray Eagle Unmanned Aer-
15 ial Vehicle (UAV) in order to support the Secretary of De-
16 fense in matters relating to the employment of unmanned
17 aerial vehicles.

18 SEC. 8082. Up to \$10,120,000 of the funds appro-
19 priated under the heading “Operation and Maintenance,
20 Navy” may be made available for the Asia Pacific Re-
21 gional Initiative Program for the purpose of enabling the
22 Pacific Command to execute Theater Security Cooperation
23 activities such as humanitarian assistance, and payment
24 of incremental and personnel costs of training and exer-
25 cising with foreign security forces: *Provided*, That funds

1 made available for this purpose may be used, notwith-
2 standing any other funding authorities for humanitarian
3 assistance, security assistance or combined exercise ex-
4 penses: *Provided further*, That funds may not be obligated
5 to provide assistance to any foreign country that is other-
6 wise prohibited from receiving such type of assistance
7 under any other provision of law.

8 SEC. 8083. None of the funds appropriated by this
9 Act for programs of the Office of the Director of National
10 Intelligence shall remain available for obligation beyond
11 the current fiscal year, except for funds appropriated for
12 research and technology, which shall remain available until
13 September 30, 2018.

14 SEC. 8084. For purposes of section 1553(b) of title
15 31, United States Code, any subdivision of appropriations
16 made in this Act under the heading “Shipbuilding and
17 Conversion, Navy” shall be considered to be for the same
18 purpose as any subdivision under the heading “Ship-
19 building and Conversion, Navy” appropriations in any
20 prior fiscal year, and the 1 percent limitation shall apply
21 to the total amount of the appropriation.

22 SEC. 8085. (a) Not later than 60 days after the date
23 of enactment of this Act, the Director of National Intel-
24 ligence shall submit a report to the congressional intel-
25 ligence committees to establish the baseline for application

1 of reprogramming and transfer authorities for fiscal year
2 2017: *Provided*, That the report shall include—

3 (1) a table for each appropriation with a sepa-
4 rate column to display the President’s budget re-
5 quest, adjustments made by Congress, adjustments
6 due to enacted rescissions, if appropriate, and the
7 fiscal year enacted level;

8 (2) a delineation in the table for each appro-
9 priation by Expenditure Center and project; and

10 (3) an identification of items of special congres-
11 sional interest.

12 (b) None of the funds provided for the National Intel-
13 ligence Program in this Act shall be available for re-
14 programming or transfer until the report identified in sub-
15 section (a) is submitted to the congressional intelligence
16 committees, unless the Director of National Intelligence
17 certifies in writing to the congressional intelligence com-
18 mittees that such reprogramming or transfer is necessary
19 as an emergency requirement.

20 SEC. 8086. None of the funds made available by this
21 Act may be used to eliminate, restructure, or realign Army
22 Contracting Command—New Jersey or make dispropor-
23 tionate personnel reductions at any Army Contracting
24 Command—New Jersey sites without 30-day prior notifi-
25 cation to the congressional defense committees.

(RESCISSION)

1
2 SEC. 8087. Of the unobligated balances available to
3 the Department of Defense, the following funds are per-
4 manently rescinded from the following accounts and pro-
5 grams in the specified amounts to reflect excess cash bal-
6 ances in Department of Defense Acquisition Workforce
7 Development Fund: *Provided*, That no amounts may be
8 rescinded from amounts that were designated by the Con-
9 gress for Overseas Contingency Operations/Global War on
10 Terrorism or as an emergency requirement pursuant to
11 the Concurrent Resolution on the Budget or the Balanced
12 Budget and Emergency Deficit Control Act of 1985, as
13 amended:

14 From “Department of Defense Acquisition
15 Workforce Development Fund, Defense”,
16 \$531,000,000.

17 SEC. 8088. None of the funds made available by this
18 Act for excess defense articles, assistance under section
19 1206 of the National Defense Authorization Act for Fiscal
20 Year 2006 (Public Law 109–163; 119 Stat. 3456), or
21 peacekeeping operations for the countries designated an-
22 nually to be in violation of the standards of the Child Sol-
23 diers Prevention Act of 2008 (Public Law 110–457; 22
24 U.S.C. 2370c–1) may be used to support any military
25 training or operation that includes child soldiers, as de-

1 fined by the Child Soldiers Prevention Act of 2008, unless
2 such assistance is otherwise permitted under section 404
3 of the Child Soldiers Prevention Act of 2008.

4 SEC. 8089. Of the amounts appropriated for “Oper-
5 ation and Maintenance, Defense-Wide”, \$67,500,000, to
6 remain available until expended, shall be available, not-
7 withstanding any other provision of law, to the Secretary
8 of Defense acting through the Office of Economic Adjust-
9 ment of the Department of Defense to make grants, con-
10 clude cooperative agreements, and supplement other Fed-
11 eral funds to address the need for assistance to support
12 critical existing and enduring military installations and
13 missions on Guam, as well as any potential Department
14 of Defense growth, for purposes of addressing the need
15 for civilian water and wastewater improvements.

16 SEC. 8090. (a) None of the funds provided for the
17 National Intelligence Program in this or any prior appro-
18 priations Act shall be available for obligation or expendi-
19 ture through a reprogramming or transfer of funds in ac-
20 cordance with section 102A(d) of the National Security
21 Act of 1947 (50 U.S.C. 3024(d)) that—

22 (1) creates a new start effort;

23 (2) terminates a program with appropriated
24 funding of \$10,000,000 or more;

1 (3) transfers funding into or out of the Na-
2 tional Intelligence Program; or

3 (4) transfers funding between appropriations,
4 unless the congressional intelligence committees are
5 notified 30 days in advance of such reprogramming
6 of funds; this notification period may be reduced for
7 urgent national security requirements.

8 (b) None of the funds provided for the National Intel-
9 ligence Program in this or any prior appropriations Act
10 shall be available for obligation or expenditure through a
11 reprogramming or transfer of funds in accordance with
12 section 102A(d) of the National Security Act of 1947 (50
13 U.S.C. 3024(d)) that results in a cumulative increase or
14 decrease of the levels specified in the classified annex ac-
15 companying the Act unless the congressional intelligence
16 committees are notified 30 days in advance of such re-
17 programming of funds; this notification period may be re-
18 duced for urgent national security requirements.

19 SEC. 8091. The Director of National Intelligence
20 shall submit to Congress each year, at or about the time
21 that the President's budget is submitted to Congress that
22 year under section 1105(a) of title 31, United States
23 Code, a future-years intelligence program (including asso-
24 ciated annexes) reflecting the estimated expenditures and
25 proposed appropriations included in that budget. Any such

1 future-years intelligence program shall cover the fiscal
2 year with respect to which the budget is submitted and
3 at least the four succeeding fiscal years.

4 SEC. 8092. For the purposes of this Act, the term
5 “congressional intelligence committees” means the Perma-
6 nent Select Committee on Intelligence of the House of
7 Representatives, the Select Committee on Intelligence of
8 the Senate, the Subcommittee on Defense of the Com-
9 mittee on Appropriations of the House of Representatives,
10 and the Subcommittee on Defense of the Committee on
11 Appropriations of the Senate.

12 (INCLUDING TRANSFER OF FUNDS)

13 SEC. 8093. During the current fiscal year, not to ex-
14 ceed \$11,000,000 from each of the appropriations made
15 in title II of this Act for “Operation and Maintenance,
16 Army”, “Operation and Maintenance, Navy”, and “Oper-
17 ation and Maintenance, Air Force” may be transferred by
18 the military department concerned to its central fund es-
19 tablished for Fisher Houses and Suites pursuant to sec-
20 tion 2493(d) of title 10, United States Code.

21 (INCLUDING TRANSFER OF FUNDS)

22 SEC. 8094. Funds appropriated by this Act for oper-
23 ation and maintenance may be available for the purpose
24 of making remittances and transfer to the Defense Acqui-

1 sition Workforce Development Fund in accordance with
2 section 1705 of title 10, United States Code.

3 SEC. 8095. (a) Any agency receiving funds made
4 available in this Act, shall, subject to subsections (b) and
5 (c), post on the public Web site of that agency any report
6 required to be submitted by the Congress in this or any
7 other Act, upon the determination by the head of the agen-
8 cy that it shall serve the national interest.

9 (b) Subsection (a) shall not apply to a report if—

10 (1) the public posting of the report com-
11 promises national security; or

12 (2) the report contains proprietary information.

13 (c) The head of the agency posting such report shall
14 do so only after such report has been made available to
15 the requesting Committee or Committees of Congress for
16 no less than 45 days.

17 SEC. 8096. (a) None of the funds appropriated or
18 otherwise made available by this Act may be expended for
19 any Federal contract for an amount in excess of
20 \$1,000,000, unless the contractor agrees not to—

21 (1) enter into any agreement with any of its
22 employees or independent contractors that requires,
23 as a condition of employment, that the employee or
24 independent contractor agree to resolve through ar-
25 bitration any claim under title VII of the Civil

1 Rights Act of 1964 or any tort related to or arising
2 out of sexual assault or harassment, including as-
3 sault and battery, intentional infliction of emotional
4 distress, false imprisonment, or negligent hiring, su-
5 pervision, or retention; or

6 (2) take any action to enforce any provision of
7 an existing agreement with an employee or inde-
8 pendent contractor that mandates that the employee
9 or independent contractor resolve through arbitra-
10 tion any claim under title VII of the Civil Rights Act
11 of 1964 or any tort related to or arising out of sex-
12 ual assault or harassment, including assault and
13 battery, intentional infliction of emotional distress,
14 false imprisonment, or negligent hiring, supervision,
15 or retention.

16 (b) None of the funds appropriated or otherwise
17 made available by this Act may be expended for any Fed-
18 eral contract unless the contractor certifies that it requires
19 each covered subcontractor to agree not to enter into, and
20 not to take any action to enforce any provision of, any
21 agreement as described in paragraphs (1) and (2) of sub-
22 section (a), with respect to any employee or independent
23 contractor performing work related to such subcontract.
24 For purposes of this subsection, a “covered subcon-

1 tractor” is an entity that has a subcontract in excess of
2 \$1,000,000 on a contract subject to subsection (a).

3 (c) The prohibitions in this section do not apply with
4 respect to a contractor’s or subcontractor’s agreements
5 with employees or independent contractors that may not
6 be enforced in a court of the United States.

7 (d) The Secretary of Defense may waive the applica-
8 tion of subsection (a) or (b) to a particular contractor or
9 subcontractor for the purposes of a particular contract or
10 subcontract if the Secretary or the Deputy Secretary per-
11 sonally determines that the waiver is necessary to avoid
12 harm to national security interests of the United States,
13 and that the term of the contract or subcontract is not
14 longer than necessary to avoid such harm. The determina-
15 tion shall set forth with specificity the grounds for the
16 waiver and for the contract or subcontract term selected,
17 and shall state any alternatives considered in lieu of a
18 waiver and the reasons each such alternative would not
19 avoid harm to national security interests of the United
20 States. The Secretary of Defense shall transmit to Con-
21 gress, and simultaneously make public, any determination
22 under this subsection not less than 15 business days be-
23 fore the contract or subcontract addressed in the deter-
24 mination may be awarded.

(INCLUDING TRANSFER OF FUNDS)

SEC. 8097. From within the funds appropriated for operation and maintenance for the Defense Health Program in this Act, up to \$122,375,000, shall be available for transfer to the Joint Department of Defense-Department of Veterans Affairs Medical Facility Demonstration Fund in accordance with the provisions of section 1704 of the National Defense Authorization Act for Fiscal Year 2010, Public Law 111–84: *Provided*, That for purposes of section 1704(b), the facility operations funded are operations of the integrated Captain James A. Lovell Federal Health Care Center, consisting of the North Chicago Veterans Affairs Medical Center, the Navy Ambulatory Care Center, and supporting facilities designated as a combined Federal medical facility as described by section 706 of Public Law 110–417: *Provided further*, That additional funds may be transferred from funds appropriated for operation and maintenance for the Defense Health Program to the Joint Department of Defense-Department of Veterans Affairs Medical Facility Demonstration Fund upon written notification by the Secretary of Defense to the Committees on Appropriations of the House of Representatives and the Senate.

SEC. 8098. None of the funds appropriated or otherwise made available by this Act may be used by the De-

1 partment of Defense or a component thereof in contraven-
2 tion of the provisions of section 130h of title 10, United
3 States Code.

4 SEC. 8099. Appropriations available to the Depart-
5 ment of Defense may be used for the purchase of heavy
6 and light armored vehicles for the physical security of per-
7 sonnel or for force protection purposes up to a limit of
8 \$450,000 per vehicle, notwithstanding price or other limi-
9 tations applicable to the purchase of passenger carrying
10 vehicles.

11 (INCLUDING TRANSFER OF FUNDS)

12 SEC. 8100. Upon a determination by the Director of
13 National Intelligence that such action is necessary and in
14 the national interest, the Director may, with the approval
15 of the Office of Management and Budget, transfer not to
16 exceed \$1,500,000,000 of the funds made available in this
17 Act for the National Intelligence Program: *Provided*, That
18 such authority to transfer may not be used unless for
19 higher priority items, based on unforeseen intelligence re-
20 quirements, than those for which originally appropriated
21 and in no case where the item for which funds are re-
22 quested has been denied by the Congress: *Provided further*,
23 That a request for multiple reprogrammings of funds
24 using authority provided in this section shall be made
25 prior to June 30, 2017.

1 SEC. 8101. None of the funds appropriated or other-
2 wise made available in this or any other Act may be used
3 to transfer, release, or assist in the transfer or release to
4 or within the United States, its territories, or possessions
5 Khalid Sheikh Mohammed or any other detainee who—

6 (1) is not a United States citizen or a member
7 of the Armed Forces of the United States; and

8 (2) is or was held on or after June 24, 2009,
9 at United States Naval Station, Guantánamo Bay,
10 Cuba, by the Department of Defense.

11 SEC. 8102. (a) None of the funds appropriated or
12 otherwise made available in this or any other Act may be
13 used to construct, acquire, or modify any facility in the
14 United States, its territories, or possessions to house any
15 individual described in subsection (c) for the purposes of
16 detention or imprisonment in the custody or under the ef-
17 fective control of the Department of Defense.

18 (b) The prohibition in subsection (a) shall not apply
19 to any modification of facilities at United States Naval
20 Station, Guantánamo Bay, Cuba.

21 (c) An individual described in this subsection is any
22 individual who, as of June 24, 2009, is located at United
23 States Naval Station, Guantánamo Bay, Cuba, and who—

1 (1) is not a citizen of the United States or a
2 member of the Armed Forces of the United States;
3 and

4 (2) is—

5 (A) in the custody or under the effective
6 control of the Department of Defense; or

7 (B) otherwise under detention at United
8 States Naval Station, Guantánamo Bay, Cuba.

9 SEC. 8103. None of the funds appropriated or other-
10 wise made available in this Act may be used to transfer
11 any individual detained at United States Naval Station
12 Guantanamo Bay, Cuba, to the custody or control of the
13 individual's country of origin, any other foreign country,
14 or any other foreign entity except in accordance with sec-
15 tion 1034 of the National Defense Authorization Act for
16 Fiscal Year 2016 (Public Law 114–92) and section 1034
17 of the National Defense Authorization Act for Fiscal Year
18 2017 (Public Law 114–328).

19 SEC. 8104. None of the funds made available by this
20 Act may be used in contravention of the War Powers Res-
21 olution (50 U.S.C. 1541 et seq.).

22 SEC. 8105. (a) None of the funds appropriated or
23 otherwise made available by this or any other Act may
24 be used by the Secretary of Defense, or any other official
25 or officer of the Department of Defense, to enter into a

1 contract, memorandum of understanding, or cooperative
2 agreement with, or make a grant to, or provide a loan
3 or loan guarantee to Rosoboronexport or any subsidiary
4 of Rosoboronexport.

5 (b) The Secretary of Defense may waive the limita-
6 tion in subsection (a) if the Secretary, in consultation with
7 the Secretary of State and the Director of National Intel-
8 ligence, determines that it is in the vital national security
9 interest of the United States to do so, and certifies in writ-
10 ing to the congressional defense committees that, to the
11 best of the Secretary's knowledge:

12 (1) Rosoboronexport has ceased the transfer of
13 lethal military equipment to, and the maintenance of
14 existing lethal military equipment for, the Govern-
15 ment of the Syrian Arab Republic;

16 (2) The armed forces of the Russian Federation
17 have withdrawn from Crimea, other than armed
18 forces present on military bases subject to agree-
19 ments in force between the Government of the Rus-
20 sian Federation and the Government of Ukraine;
21 and

22 (3) Agents of the Russian Federation have
23 ceased taking active measures to destabilize the con-
24 trol of the Government of Ukraine over eastern
25 Ukraine.

1 (c) The Inspector General of the Department of De-
2 fense shall conduct a review of any action involving
3 Rosoboronexport with respect to a waiver issued by the
4 Secretary of Defense pursuant to subsection (b), and not
5 later than 90 days after the date on which such a waiver
6 is issued by the Secretary of Defense, the Inspector Gen-
7 eral shall submit to the congressional defense committees
8 a report containing the results of the review conducted
9 with respect to such waiver.

10 SEC. 8106. None of the funds made available in this
11 Act may be used for the purchase or manufacture of a
12 flag of the United States unless such flags are treated as
13 covered items under section 2533a(b) of title 10, United
14 States Code.

15 SEC. 8107. (a) Of the funds appropriated in this Act
16 for the Department of Defense, amounts may be made
17 available, under such regulations as the Secretary of De-
18 fense may prescribe, to local military commanders ap-
19 pointed by the Secretary, or by an officer or employee des-
20 ignated by the Secretary, to provide at their discretion ex
21 gratia payments in amounts consistent with subsection (d)
22 of this section for damage, personal injury, or death that
23 is incident to combat operations of the Armed Forces in
24 a foreign country.

1 (b) An ex gratia payment under this section may be
2 provided only if—

3 (1) the prospective foreign civilian recipient is
4 determined by the local military commander to be
5 friendly to the United States;

6 (2) a claim for damages would not be compen-
7 sable under chapter 163 of title 10, United States
8 Code (commonly known as the “Foreign Claims
9 Act”); and

10 (3) the property damage, personal injury, or
11 death was not caused by action by an enemy.

12 (c) NATURE OF PAYMENTS.—Any payments provided
13 under a program under subsection (a) shall not be consid-
14 ered an admission or acknowledgement of any legal obliga-
15 tion to compensate for any damage, personal injury, or
16 death.

17 (d) AMOUNT OF PAYMENTS.—If the Secretary of De-
18 fense determines a program under subsection (a) to be ap-
19 propriate in a particular setting, the amounts of pay-
20 ments, if any, to be provided to civilians determined to
21 have suffered harm incident to combat operations of the
22 Armed Forces under the program should be determined
23 pursuant to regulations prescribed by the Secretary and
24 based on an assessment, which should include such factors

1 as cultural appropriateness and prevailing economic condi-
2 tions.

3 (e) LEGAL ADVICE.—Local military commanders
4 shall receive legal advice before making ex gratia pay-
5 ments under this subsection. The legal advisor, under reg-
6 ulations of the Department of Defense, shall advise on
7 whether an ex gratia payment is proper under this section
8 and applicable Department of Defense regulations.

9 (f) WRITTEN RECORD.—A written record of any ex
10 gratia payment offered or denied shall be kept by the local
11 commander and on a timely basis submitted to the appro-
12 priate office in the Department of Defense as determined
13 by the Secretary of Defense.

14 (g) REPORT.—The Secretary of Defense shall report
15 to the congressional defense committees on an annual
16 basis the efficacy of the ex gratia payment program in-
17 cluding the number of types of cases considered, amounts
18 offered, the response from ex gratia payment recipients,
19 and any recommended modifications to the program.

20 SEC. 8108. None of the funds available in this Act
21 to the Department of Defense, other than appropriations
22 made for necessary or routine refurbishments, upgrades
23 or maintenance activities, shall be used to reduce or to
24 prepare to reduce the number of deployed and non-de-
25 ployed strategic delivery vehicles and launchers below the

1 levels set forth in the report submitted to Congress in ac-
2 cordance with section 1042 of the National Defense Au-
3 thorization Act for Fiscal Year 2012.

4 SEC. 8109. The Secretary of Defense shall post grant
5 awards on a public Web site in a searchable format.

6 SEC. 8110. None of the funds made available by this
7 Act may be used to fund the performance of a flight dem-
8 onstration team at a location outside of the United States:
9 *Provided*, That this prohibition applies only if a perform-
10 ance of a flight demonstration team at a location within
11 the United States was canceled during the current fiscal
12 year due to insufficient funding.

13 SEC. 8111. None of the funds made available by this
14 Act may be used by the National Security Agency to—

15 (1) conduct an acquisition pursuant to section
16 702 of the Foreign Intelligence Surveillance Act of
17 1978 for the purpose of targeting a United States
18 person; or

19 (2) acquire, monitor, or store the contents (as
20 such term is defined in section 2510(8) of title 18,
21 United States Code) of any electronic communica-
22 tion of a United States person from a provider of
23 electronic communication services to the public pur-
24 suant to section 501 of the Foreign Intelligence Sur-
25 veillance Act of 1978.

1 SEC. 8112. None of the funds made available by this
2 Act may be obligated or expended to implement the Arms
3 Trade Treaty until the Senate approves a resolution of
4 ratification for the Treaty.

5 SEC. 8113. None of the funds made available in this
6 or any other Act may be used to pay the salary of any
7 officer or employee of any agency funded by this Act who
8 approves or implements the transfer of administrative re-
9 sponsibilities or budgetary resources of any program,
10 project, or activity financed by this Act to the jurisdiction
11 of another Federal agency not financed by this Act with-
12 out the express authorization of Congress: *Provided*, That
13 this limitation shall not apply to transfers of funds ex-
14 pressly provided for in Defense Appropriations Acts, or
15 provisions of Acts providing supplemental appropriations
16 for the Department of Defense.

17 SEC. 8114. None of the funds made available in this
18 Act may be obligated for activities authorized under sec-
19 tion 1208 of the Ronald W. Reagan National Defense Au-
20 thorization Act for Fiscal Year 2005 (Public Law 112–
21 81; 125 Stat. 1621) to initiate support for, or expand sup-
22 port to, foreign forces, irregular forces, groups, or individ-
23 uals unless the congressional defense committees are noti-
24 fied in accordance with the direction contained in the clas-
25 sified annex accompanying this Act, not less than 15 days

1 before initiating such support: *Provided*, That none of the
2 funds made available in this Act may be used under sec-
3 tion 1208 for any activity that is not in support of an
4 ongoing military operation being conducted by United
5 States Special Operations Forces to combat terrorism:
6 *Provided further*, That the Secretary of Defense may waive
7 the prohibitions in this section if the Secretary determines
8 that such waiver is required by extraordinary cir-
9 cumstances and, by not later than 72 hours after making
10 such waiver, notifies the congressional defense committees
11 of such waiver.

12 SEC. 8115. None of the funds made available by this
13 Act may be used with respect to Iraq in contravention of

16 into hostilities in Iraq, into situations in Iraq where immi-
17 nent involvement in hostilities is clearly indicated by the
18 circumstances, or into Iraqi territory, airspace, or waters
19 while equipped for combat, in contravention of the con-
20 gressional consultation and reporting requirements of sec-
21 tions 3 and 4 of such Resolution (50 U.S.C. 1542 and
22 1543).

23 SEC. 8116. None of the funds made available by this
24 Act may be used to divest, retire, transfer, or place in stor-
25 age or on backup aircraft inventory status, or prepare to

1 divest, retire, transfer, or place in storage or on backup
2 aircraft inventory status, any A-10 aircraft, or to dis-
3 tablish any units of the active or reserve component associ-
4 ated with such aircraft.

5 SEC. 8117. None of the funds provided in this Act
6 for the T-AO(X) program shall be used to award a new
7 contract that provides for the acquisition of the following
8 components unless those components are manufactured in
9 the United States: Auxiliary equipment (including pumps)
10 for shipboard services; propulsion equipment (including
11 engines, reduction gears, and propellers); shipboard
12 cranes; and spreaders for shipboard cranes.

13 SEC. 8118. The amount appropriated in title II of
14 this Act for “Operation and Maintenance, Army” is here-
15 by reduced by \$336,000,000 to reflect excess cash bal-
16 ances in Department of Defense Working Capital Funds.

17 SEC. 8119. Notwithstanding any other provision of
18 this Act, to reflect savings due to lower than anticipated
19 fuel costs, the total amount appropriated in title II of this
20 Act is hereby reduced by \$1,155,000,000.

21 SEC. 8120. None of the funds made available by this
22 Act may be used to divest or retire, or to prepare to divest
23 or retire, KC-10 aircraft.

24 SEC. 8121. None of the funds made available by this
25 Act may be used to divest, retire, transfer, or place in stor-

1 age or on backup aircraft inventory status, or prepare to
2 divest, retire, transfer, or place in storage or on backup
3 aircraft inventory status, any EC-130H aircraft.

4 SEC. 8122. None of the funds made available by this
5 Act may be used for Government Travel Charge Card ex-
6 penses by military or civilian personnel of the Department
7 of Defense for gaming, or for entertainment that includes
8 topless or nude entertainers or participants, as prohibited
9 by Department of Defense FMR, Volume 9, Chapter 3
10 and Department of Defense Instruction 1015.10 (enclo-
11 sure 3, 14a and 14b).

12 SEC. 8123. None of the funds made available by this
13 Act may be used to propose, plan for, or execute a new
14 or additional Base Realignment and Closure (BRAC)
15 round.

16 SEC. 8124. Of the amounts appropriated in this Act
17 for “Operation and Maintenance, Navy”, \$274,524,000,
18 to remain available until expended, may be used for any
19 purposes related to the National Defense Reserve Fleet
20 established under section 11 of the Merchant Ship Sales
21 Act of 1946 (50 U.S.C. 4405): *Provided*, That such
22 amounts are available for reimbursements to the Ready
23 Reserve Force, Maritime Administration account of the
24 United States Department of Transportation for pro-

1 grams, projects, activities, and expenses related to the Na-
2 tional Defense Reserve Fleet.

3 (INCLUDING TRANSFER OF FUNDS)

4 SEC. 8125. Of the amounts appropriated in this Act,
5 the Secretary of Defense may use up to \$20,000,000
6 under the heading “Operation and Maintenance, Defense-
7 Wide”, and up to \$75,000,000 under the heading “Re-

1 SEC. 8127. None of the funds made available by this
2 Act may be used to carry out the closure or realignment
3 of the United States Naval Station, Guantanamo Bay,
4 Cuba.

5 (INCLUDING TRANSFER OF FUNDS)

6 SEC. 8128. Additional readiness funds made available
7 in title II of this Act for “Operation and Maintenance,
8 Army”, “Operation and Maintenance, Navy”, “Operation
9 and Maintenance, Marine Corps”, and “Operation and
10 Maintenance, Air Force” may be transferred to and
11 merged with any appropriation of the Department of De-
12 fense for activities related to the Zika virus in order to
13 provide health support for the full range of military oper-
14 ations and sustain the health of the members of the Armed
15 Forces, civilian employees of the Department of Defense,
16 and their families, to include: research and development,
17 disease surveillance, vaccine development, rapid detection,
18 vector controls and surveillance, training, and outbreak re-
19 sponse: *Provided*, That the authority provided in this sec-

SEC. 8131. None of the funds made available by this Act may be used to provide arms, training, or other assistance to the Azov Battalion.

10 utor to finance the sustainment of the activities and
11 maintenance of any equipment or facilities to be pro-
12 vided through the proposed project.

13 SEC. 9006. Funds available to the Department of De-
14 fense for operation and maintenance may be used, not-
15 withstanding any other provision of law, to provide sup-
16 plies, services, transportation, including airlift and sealift,
17 and other logistical support to allied forces participating
18 in a combined operation with the armed forces of the
19 United States and coalition forces supporting military and
20 stability operations in Afghanistan and to counter the Is-
21 lamic State of Iraq and the Levant: *Provided*, That the
22 Secretary of Defense shall provide quarterly reports to the
23 congressional defense committees regarding support pro-
24 vided under this section.

1 SEC. 9007. None of the funds appropriated or other-
2 wise made available by this or any other Act shall be obli-
3 gated or expended by the United States Government for
4 a purpose as follows:

5 (1) To establish any military installation or
6 base for the purpose of providing for the permanent
7 stationing of United States Armed Forces in Iraq.

8 (2) To exercise United States control over any
9 oil resource of Iraq.

10 (3) To establish any military installation or
11 base for the purpose of providing for the permanent
12 stationing of United States Armed Forces in Af-
13 ghanistan.

14 SEC. 9008. None of the funds made available in this
15 Act may be used in contravention of the following laws
16 enacted or regulations promulgated to implement the
17 United Nations Convention Against Torture and Other
18 Cruel, Inhuman or Degrading Treatment or Punishment
19 (done at New York on December 10, 1984):

20 (1) Section 2340A of title 18, United States
21 Code.

22 (2) Section 2242 of the Foreign Affairs Reform
23 and Restructuring Act of 1998 (division G of Public
24 Law 105–277; 112 Stat. 2681–822; 8 U.S.C. 1231
25 note) and regulations prescribed thereto, including

1 regulations under part 208 of title 8, Code of Fed-
2 eral Regulations, and part 95 of title 22, Code of
3 Federal Regulations.

4 (3) Sections 1002 and 1003 of the Department
5 of Defense, Emergency Supplemental Appropriations
6 to Address Hurricanes in the Gulf of Mexico, and
7 Pandemic Influenza Act, 2006 (Public Law 109–
8 148).

9 SEC. 9009. None of the funds provided for the “Af-
10 ghanistan Security Forces Fund” (ASFF) may be obli-
11 gated prior to the approval of a financial and activity plan
12 by the Afghanistan Resources Oversight Council (AROC)
13 of the Department of Defense: *Provided*, That the AROC
14 must approve the requirement and acquisition plan for any
15 service requirements in excess of \$50,000,000 annually
16 and any non-standard equipment requirements in excess
17 of \$100,000,000 using ASFF: *Provided further*, That the
18 Department of Defense must certify to the congressional
19 defense committees that the AROC has convened and ap-
20 proved a process for ensuring compliance with the require-
21 ments in the preceding proviso and accompanying report
22 language for the ASFF.

23 SEC. 9010. Funds made available in this title to the
24 Department of Defense for operation and maintenance
25 may be used to purchase items having an investment unit

1 cost of not more than \$250,000: *Provided*, That, upon de-
2 termination by the Secretary of Defense that such action
3 is necessary to meet the operational requirements of a
4 Commander of a Combatant Command engaged in contin-
5 uency operations overseas, such funds may be used to pur-
6 chase items having an investment item unit cost of not
7 more than \$500,000.

8 SEC. 9011. From funds made available to the De-
9 partment of Defense in this title under the heading “Oper-
10 ation and Maintenance, Air Force”, up to \$60,000,000
11 may be used by the Secretary of Defense, notwithstanding
12 any other provision of law, to support United States Gov-
13 ernment transition activities in Iraq by funding the oper-
14 ations and activities of the Office of Security Cooperation
15 in Iraq and security assistance teams, including life sup-
16 port, transportation and personal security, and facilities
17 renovation and construction, and site closeout activities
18 prior to returning sites to the Government of Iraq: *Pro-*
19 *vided*, That to the extent authorized under the National
20 Defense Authorization Act for Fiscal Year 2017, the oper-
21 ations and activities that may be carried out by the Office
22 of Security Cooperation in Iraq may, with the concurrence
23 of the Secretary of State, include non-operational training
24 activities in support of Iraqi Minister of Defense and
25 Counter Terrorism Service personnel in an institutional

1 environment to address capability gaps, integrate proc-
2 esses relating to intelligence, air sovereignty, combined
3 arms, logistics and maintenance, and to manage and inte-
4 grate defense-related institutions: *Provided further*, That
5 not later than 30 days following the enactment of this Act,
6 the Secretary of Defense and the Secretary of State shall
7 submit to the congressional defense committees a plan for
8 transitioning any such training activities that they deter-
9 mine are needed after the end of fiscal year 2017, to exist-
10 ing or new contracts for the sale of defense articles or
11 defense services consistent with the provisions of the Arms
12 Export Control Act (22 U.S.C. 2751 et seq.): *Provided*
13 *further*, That, not less than 15 days before making funds
14 available pursuant to the authority provided in this sec-
15 tion, the Secretary of Defense shall submit to the congres-
16 sional defense committees a written notice containing a
17 detailed justification and timeline for the operations and
18 activities of the Office of Security Cooperation in Iraq at
19 each site where such operations and activities will be con-
20 ducted during fiscal year 2017: *Provided further*, That
21 amounts made available by this section are designated by
22 the Congress for Overseas Contingency Operations/Global
23 War on Terrorism pursuant to section 251(b)(2)(A)(ii) of
24 the Balanced Budget and Emergency Deficit Control Act
25 of 1985.

1 SEC. 9012. Up to \$500,000,000 of funds appro-
2 priated by this Act for the Defense Security Cooperation
3 Agency in “Operation and Maintenance, Defense-Wide”
4 may be used to provide assistance to the Government of
5 Jordan to support the armed forces of Jordan and to en-
6 hance security along its borders.

7 SEC. 9013. None of the funds made available by this
8 Act under the heading “Counter-ISIL Train and Equip
9 Fund” may be used to procure or transfer man-portable
10 air defense systems.

11 SEC. 9014. For the “Ukraine Security Assistance Ini-
12 tiative”, \$150,000,000 is hereby appropriated, to remain
13 available until September 30, 2017: *Provided*, That such
14 funds shall be available to the Secretary of Defense, in
15 coordination with the Secretary of State, to provide assist-
16 ance, including training; equipment; lethal weapons of a
17 defensive nature; logistics support, supplies and services;
18 sustainment; and intelligence support to the military and
19 national security forces of Ukraine, and for replacement
20 of any weapons or defensive articles provided to the Gov-
21 ernment of Ukraine from the inventory of the United
22 States: *Provided further*, That the Secretary of Defense
23 shall, not less than 15 days prior to obligating funds pro-
24 vided under this heading, notify the congressional defense
25 committees in writing of the details of any such obligation:

1 *Provided further*, That the United States may accept
2 equipment procured using funds provided under this head-
3 ing in this or prior Acts that was transferred to the secu-
4 rity forces of Ukraine and returned by such forces to the
5 United States: *Provided further*, That equipment procured
6 using funds provided under this heading in this or prior
7 Acts, and not yet transferred to the military or National
8 Security Forces of Ukraine or returned by such forces to
9 the United States, may be treated as stocks of the Depart-
10 ment of Defense upon written notification to the congres-
11 sional defense committees: *Provided further*, That amounts
12 made available by this section are designated by the Con-
13 gress for Overseas Contingency Operations/Global War on
14 Terrorism pursuant to section 251(b)(2)(A)(ii) of the Bal-
15 anced Budget and Emergency Deficit Control Act of 1985.

16 SEC. 9015. Funds appropriated in this title shall be
17 available for replacement of funds for items provided to
18 the Government of Ukraine from the inventory of the
19 United States to the extent specifically provided for in sec-
20 tion 9014 of this Act.

21 SEC. 9016. None of the funds made available by this
22 Act under section 9014 for “Assistance and Sustainment
23 to the Military and National Security Forces of Ukraine”
24 may be used to procure or transfer man-portable air de-
25 fense systems.

1 SEC. 9017. (a) None of the funds appropriated or
2 otherwise made available by this Act under the heading
3 “Operation and Maintenance, Defense-Wide” for pay-
4 ments under section 1233 of Public Law 110–181 for re-
5 imbursement to the Government of Pakistan may be made
6 available unless the Secretary of Defense, in coordination
7 with the Secretary of State, certifies to the congressional
8 defense committees that the Government of Pakistan is—

9 (1) cooperating with the United States in
10 counterterrorism efforts against the Haqqani Net-
11 work, the Quetta Shura Taliban, Lashkar e-Tayyiba,
12 Jaish-e-Mohammed, Al Qaeda, and other domestic
13 and foreign terrorist organizations, including taking
14 steps to end support for such groups and prevent
15 them from basing and operating in Pakistan and
16 carrying out cross border attacks into neighboring
17 countries;

18 (2) not supporting terrorist activities against
19 United States or coalition forces in Afghanistan, and
20 Pakistan’s military and intelligence agencies are not
21 intervening extra-judicially into political and judicial
22 processes in Pakistan;

23 (3) dismantling improvised explosive device
24 (IED) networks and interdicting precursor chemicals
25 used in the manufacture of IEDs;

1 (4) preventing the proliferation of nuclear-re-
2 lated material and expertise;

3 (5) implementing policies to protect judicial
4 independence and due process of law;

5 (6) issuing visas in a timely manner for United
6 States visitors engaged in counterterrorism efforts
7 and assistance programs in Pakistan; and

8 (7) providing humanitarian organizations access
9 to detainees, internally displaced persons, and other
10 Pakistani civilians affected by the conflict.

11 (b) The Secretary of Defense, in coordination with
12 the Secretary of State, may waive the restriction in sub-
13 section (a) on a case-by-case basis by certifying in writing
14 to the congressional defense committees that it is in the
15 national security interest to do so: *Provided*, That if the
16 Secretary of Defense, in coordination with the Secretary
17 of State, exercises such waiver authority, the Secretaries
18 shall report to the congressional defense committees on
19 both the justification for the waiver and on the require-
20 ments of this section that the Government of Pakistan was
21 not able to meet: *Provided further*, That such report may
22 be submitted in classified form if necessary.

23 (INCLUDING TRANSFER OF FUNDS)

24 SEC. 9018. In addition to amounts otherwise made
25 available in this Act, \$500,000,000 is hereby appropriated

1 to the Department of Defense and made available for
2 transfer only to the operation and maintenance, military
3 personnel, and procurement accounts, to improve the intel-
4 ligence, surveillance, and reconnaissance capabilities of the
5 Department of Defense: *Provided*, That the transfer au-
6 thority provided in this section is in addition to any other
7 transfer authority provided elsewhere in this Act: *Provided*
8 *further*, That not later than 30 days prior to exercising
9 the transfer authority provided in this section, the Sec-
10 retary of Defense shall submit a report to the congres-
11 sional defense committees on the proposed uses of these
12 funds: *Provided further*, That the funds provided in this
13 section may not be transferred to any program, project,
14 or activity specifically limited or denied by this Act: *Pro-*
15 *vided further*, That amounts made available by this section
16 are designated by the Congress for Overseas Contingency
17 Operations/Global War on Terrorism pursuant to section
18 251(b)(2)(A)(ii) of the Balanced Budget and Emergency
19 Deficit Control Act of 1985: *Provided further*, That the
20 authority to provide funding under this section shall termi-
21 nate on September 30, 2017.

22 SEC. 9019. None of the funds made available by this
23 Act may be used with respect to Syria in contravention
24 of the War Powers Resolution (50 U.S.C. 1541 et seq.),
25 including for the introduction of United States armed or

SEC. 9020. None of the funds in this Act may be made available for the transfer of additional C-130 cargo aircraft to the Afghanistan National Security Forces or the Afghanistan Air Force until the Department of Defense provides a report to the congressional defense committees of the Afghanistan Air Force's medium airlift requirements. The report should identify Afghanistan's ability to utilize and maintain existing medium lift aircraft in the inventory and the best alternative platform, if necessary, to provide additional support to the Afghanistan Air Force's current medium airlift capacity.
