3 Whereas, this legislation restores funding to Maine's Tobacco Prevention and Control 4 Program, which recently had its funding reduced; and 5 Whereas, Maine has the highest adult smoking rate in the Northeast and, like the rest of the nation, is experiencing a youth tobacco use epidemic; and 6 Whereas, smoking is the leading preventable risk factor for many of the leading causes of death of Maine people, including cancer, heart disease, lung disease and stroke, 8 and increases an individual's risk for severe illness from COVID-19; and 9 10 Whereas, tobacco use costs Maine \$811 million in health care bills each year, including approximately \$262 million in state Medicaid costs; each Maine household pays 11 an additional \$1,066 in state and federal taxes from smoking-caused government 12 13 expenditures; and smoking costs Maine \$647 million in productivity losses; and 14 Whereas, adequate funding for comprehensive tobacco prevention and control programs leads to greater reductions in smoking, and the longer states adequately invest in 15 such programs, the greater the impact; and 16 17 Whereas, the reduction in funding has resulted in declines in funding for surveillance 18 and evaluation, counter-marketing campaigns, eliminating tobacco-related health disparities and tobacco treatment; and 19 20 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as 21 immediately necessary for the preservation of the public peace, health and safety; now, 22 23 therefore, 24 Be it enacted by the People of the State of Maine as follows: Sec. 1. Appropriations and allocations. The following appropriations and 25 26 allocations are made. 27 HEALTH AND HUMAN SERVICES, DEPARTMENT OF 28 Maine Center for Disease Control and Prevention 0143 29 Initiative: Provides ongoing allocations to the Tobacco Prevention and Control Program to 30 restore the level of funding provided for the program in fiscal year 2020-21. 31 **FUND FOR A HEALTHY MAINE** 2021-22 2022-23 32 All Other \$5,000,000 \$5,000,000 33 34 \$5,000,000 FUND FOR A HEALTHY MAINE TOTAL \$5,000,000 35 **Emergency clause.** In view of the emergency cited in the preamble, this legislation 36 takes effect when approved. **SUMMARY** 37 38 This bill provides ongoing allocations to the Tobacco Prevention and Control Program 39 to restore the level of funding provided for the program in fiscal year 2020-21.

Emergency preamble. Whereas, acts and resolves of the Legislature do not

become effective until 90 days after adjournment unless enacted as emergencies; and
