1 AN ACT concerning

2 Estates and Trusts - Maryland Revised Uniform Anatomical Gift Act - Revisions

- FOR the purpose of altering the purposes for which certain anatomical gifts may be used; repealing provisions of law that require certain persons to search certain individuals for a document of gift or any other information identifying the individual as a donor, that specify certain procedures to be taken if a document is located, and that concern certain administrative sanctions; requiring a certain procurement organization to make a certain search of certain registries under certain circumstances; and

- 25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 26 That the Laws of Maryland read as follows:

- 3 (a) An anatomical gift may be made to the following persons named in a document 4 of gift:
- 5 (1) A hospital, an accredited medical school, a dental school, a college or 6 university, an organ procurement organization, the State Anatomy Board, or a 7 nontransplant tissue bank for research, training, or education;
- 8 (2) Subject to subsection (b) of this section, if the individual is the recipient 9 of the part, an individual designated by the person making the anatomical gift; or
- 10 (3) An eye bank or a transplant tissue bank.
- 11 (e) If an anatomical gift of one or more specific parts is made in a document of gift 12 that does not name a person described in subsection (a) of this section and does not identify 13 the purpose of the gift, the gift passes in accordance with subsection (g) of this section [and 14 may be used only for transplantation or therapy].
- 15 (f) If a document of gift specifies only a general intent to make an anatomical gift 16 by words such as "donor", "organ donor", or "body donor", or by a symbol or statement of 17 similar import, the gift passes in accordance with subsection (g) of this section and may be 18 used [only] for transplantation, RESEARCH, EDUCATION, or therapy.
- 19 (g) For purposes of subsections (b), (e), and (f) of this section, the following 20 provisions apply:
- 21 (1) If the part is an eye, the gift passes to the appropriate eye bank;
- 22 (2) If the part is tissue, the gift passes to the appropriate tissue bank; and
- 23 (3) If the part is an organ, the gift passes to the appropriate organ 24 procurement organization as custodian of the organ.

- 26 (a) The following persons shall make a reasonable search of an individual who 27 the person reasonably believes is dead or whose death is imminent for a document of gift 28 or any other information identifying the individual as a donor or as an individual who made 29 a refusal:
- 30 (1) A law enforcement officer, firefighter, paramedic, or any other 31 emergency rescuer finding the individual; and

- 1 (2) If no other source of the information is immediately available, a 2 hospital, as soon as practical after the individual's arrival at the hospital.
 - (b) If a document of gift or a refusal to make an anatomical gift is located by the search required under subsection (a)(1) of this section and the individual or deceased individual to whom it relates is taken to a hospital, the person responsible for conducting the search shall send the document of gift or refusal to the hospital.
- 7 (c) A person is not subject to criminal or civil liability for failing to discharge the 8 duties imposed by this section but may be subject to administrative sanctions.]

- 10 (a) Whenever a hospital refers an individual who is dead or whose death is 11 imminent to a procurement organization to ascertain whether the individual has made an 12 anatomical gift, the organization shall make a reasonable search of any NATIONAL AND 13 LOCAL donor registry that [the hospital knows] exists for the geographical area in which 14 the individual resides.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 16 October 1, 2021.
