## A BILL

To prohibit any person from soliciting or knowingly acquiring, receiving, or accepting a donation of human fetal tissue for any purpose other than disposal of the tissue if the donation affects interstate commerce and the tissue will be or is obtained pursuant to an induced abortion, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “End Trafficking of  
5 the Terminated Unborn Act of 2017”.

1 **SEC. 2. REMOVAL OF AUTHORITY FOR FUNDING RESEARCH**  
2 **ON FETAL TISSUE OBTAINED PURSUANT TO**  
3 **AN INDUCED ABORTION.**

4 Section 498A of the Public Health Service Act (42  
5 U.S.C. 289g–1) is amended—

6 (1) by amending paragraph (2) of subsection  
7 (a) to read as follows:

8 “(2) SOURCE OF TISSUE.—Human fetal tissue  
9 may be used in research carried out under para-  
10 graph (1) only if the tissue is obtained pursuant to  
11 a spontaneous abortion or a stillbirth.”;

12 (2) in subsection (b)(2), by striking subpara-  
13 graph (A) and redesignating subparagraphs (B) and  
14 (C) as subparagraphs (A) and (B), respectively;

15 (3) in subsection (c)(1)(B), by striking “or in-  
16 duced”; and

17 (4) in subsection (g), by striking “or induced”.

18 **SEC. 3. PROHIBITION AGAINST SOLICITATION OR ACCEPT-**  
19 **ANCE OF A DONATION OF FETAL TISSUE PUR-**  
20 **SUANT TO AN INDUCED ABORTION.**

21 Subsection (b) of section 498B of the Public Health  
22 Service Act (42 U.S.C. 289g–2) is amended to read as  
23 follows:

24 “(b) PROHIBITION AGAINST SOLICITATION OR AC-  
25 CEPTANCE OF A DONATION OF FETAL TISSUE PURSUANT  
26 TO AN ABORTION.—It shall be unlawful for any person

1 to solicit or knowingly acquire, receive, or accept a dona-  
2 tion of human fetal tissue for any purpose other than dis-  
3 posal of the tissue if the donation affects interstate com-  
4 merce and the tissue will be or is obtained pursuant to  
5 an induced abortion.”.
