

In the House of Representatives, U. S.,

December 12, 2022.

Resolved, That the bill from the Senate (S. 1466) entitled “An Act to authorize the Director of the United States Geological Survey to establish a regional program to assess, monitor, and benefit the hydrology of saline lakes in the Great Basin and the migratory birds and other wildlife dependent on those habitats, and for other purposes.”, do pass with the following

AMENDMENT:

Strike out all after the enacting clause and insert:

1 ***SECTION 1. SHORT TITLE.***

2 *This Act may be cited as the “Saline Lake Ecosystems*
3 *in the Great Basin States Program Act of 2022”.*

4 ***SEC. 2. SALINE LAKE ECOSYSTEMS IN THE GREAT BASIN***
5 ***STATES ASSESSMENT AND MONITORING PRO-***
6 ***GRAM.***

7 *(a) DEFINITIONS.—In this section:*

8 *(1) PROGRAM.—The term “Program” means the*
9 *Saline Lake Ecosystems in the Great Basin States*
10 *Assessment and Monitoring Program established*
11 *under subsection (b).*

1 (2) *SECRETARY.*—*The term “Secretary” means*
 2 *the Secretary of the Interior, acting through the Di-*
 3 *rector of the United States Geological Survey.*

4 (b) *ESTABLISHMENT.*—*The Secretary shall establish a*
 5 *Saline Lake Ecosystems in the Great Basin States Assess-*
 6 *ment and Monitoring Program to assess and monitor the*
 7 *hydrology of saline lake ecosystems in the Great Basin and*
 8 *the migratory birds and other wildlife that depend on those*
 9 *ecosystems to inform and support coordinated management*
 10 *and conservation actions to benefit those ecosystems, migra-*
 11 *tory birds, and other wildlife.*

12 (c) *WORK AND IMPLEMENTATION PLAN.*—

13 (1) *IN GENERAL.*—*Under the Program, the Sec-*
 14 *retary, in coordination with the Director of the*
 15 *United States Fish and Wildlife Service and the enti-*
 16 *ties described in paragraph (2), shall establish a*
 17 *multiyear work and implementation plan to assess,*
 18 *monitor, and conserve saline lake ecosystems in the*
 19 *Great Basin and the migratory birds and other wild-*
 20 *life that depend on those ecosystems.*

21 (2) *COORDINATING ENTITIES.*—*The entities re-*
 22 *ferred to in paragraph (1) include—*

23 (A) *Federal, State, Tribal, and local agen-*
 24 *cies;*

25 (B) *institutions of higher education;*

1 (C) nonprofit organizations; and

2 (D) other local stakeholders.

3 (3) *INCLUSIONS.*—*The work and implementation*
 4 *plan established under paragraph (1) shall include—*

5 (A) *a synthesis of available information, lit-*
 6 *erature, and data, and an assessment of sci-*
 7 *entific and informational needs, relating to—*

8 (i) *water quantity, water quality,*
 9 *water use, and water demand;*

10 (ii) *migratory bird and other wildlife*
 11 *populations, habitats, and ecology;*

12 (iii) *annual lifecycle needs of migra-*
 13 *tory birds; and*

14 (iv) *environmental changes and other*
 15 *stressors, including climatic stressors;*

16 (B) *a description of how the plan should be*
 17 *implemented to address the scientific and infor-*
 18 *mational needs described in subparagraph (A),*
 19 *including proposed activities, such as moni-*
 20 *toring, data infrastructure needs, and develop-*
 21 *ment of tools necessary to implement the Pro-*
 22 *gram;*

23 (C) *recommendations and a cost assessment*
 24 *for the implementation of the plan; and*

1 (D) such other matters as the Secretary de-
 2 termines to be appropriate.

3 (4) *REPORT.*—Not later than 1 year after the
 4 date of enactment of this Act, the Secretary shall sub-
 5 mit to Congress a report describing the work and im-
 6 plementation plan established under paragraph (1).

7 (d) *IMPLEMENTATION.*—The Secretary shall imple-
 8 ment the Program based on the information, findings, and
 9 recommendations contained in the work and implementa-
 10 tion plan established under subsection (c).

11 (e) *COOPERATIVE AGREEMENTS AND GRANTS.*—The
 12 Secretary may enter into cooperative funding agreements
 13 with, or provide grants to, entities described in subsection
 14 (c)(2) for the purposes of—

15 (1) participating in developing, or providing in-
 16 formation to inform the development of, the work and
 17 implementation plan under subsection (c);

18 (2) carrying out assessments and monitoring of
 19 water quality, quantity, use, and demand under the
 20 Program; and

21 (3) carrying out ecological, biological, and avian
 22 assessments and monitoring under the Program.

23 (f) *EFFECT.*—The work and implementation plan es-
 24 tablished under subsection (c)(1) shall not affect—

1 (1) *any interstate water compacts in existence on*
2 *the date of enactment of this Act, including full devel-*
3 *opment of any apportionment made in accordance*
4 *with those compacts;*

5 (2) *valid and existing water rights in any State*
6 *located wholly or partially within the Great Basin;*

7 (3) *water rights held by the United States in the*
8 *Great Basin; and*

9 (4) *the management and operation of Bear Lake*
10 *or Stewart Dam, including the storage, management,*
11 *and release of water.*

12 (g) *AUTHORIZATION OF APPROPRIATIONS.—There is*
13 *authorized to be appropriated to carry out the Program*
14 *\$5,000,000 for each of fiscal years 2022 through 2027.*
