To award grants for up to 100% of eligible costs of projects 14 relating to planning, design, construction, and upgrade of a publicly owned wastewater 15 facility for flows up to the design capacity of the wastewater facility, as approved by the 16 Department, to achieve enhanced nutrient removal in accordance with paragraph (3) of this 17 subsection; and
- 2. To SUBJECT TO PARAGRAPH (12) OF THIS

  SUBSECTION, TO award grants for up to 50% of eligible costs of projects relating to
  planning, design, construction, and upgrade of a privately owned wastewater facility for
