# **A BILL**

To amend the Wild and Scenic Rivers Act to designate segments of the Little Manatee River as a component of the Wild and Scenic Rivers System, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Little Manatee Wild*  
 5       *and Scenic River Act”.*

6       **SEC. 2. DESIGNATION FOR STUDY OF WILD AND SCENIC**  
 7               **RIVER SEGMENTS, LITTLE MANATEE RIVER,**  
 8               **FLORIDA.**

9       *Section 5(a) of the Wild and Scenic Rivers Act (16*  
 10       *U.S.C. 1276(a)) is amended by adding at the end the fol-*  
 11       *lowing:*

12               “(\_\_\_\_) *LITTLE MANATEE RIVER, FLORIDA.—*  
 13       *The approximately 50-mile segment beginning at the*  
 14       *source in southeastern Hillsborough County, Florida,*  
 15       *downstream to the point at which the river enters*  
 16       *Tampa Bay, including appropriate tributaries, but*  
 17       *shall not include—*

18               “(A) *those portions lying within Manatee*  
 19       *County, Florida, and being more particularly*  
 20       *described as Parcel ID 247800059, Parcel ID*  
 21       *248200008 and Parcel ID 248100000; and*

22               “(B) *South Fork.*”.

1 **SEC. 3. STUDY AND REPORT.**

2        *Section 5(b) of the Wild and Scenic Rivers Act (16*  
3 *U.S.C. 1276(b)) is amended by adding at the end the fol-*  
4 *lowing:*

5                “(\_\_\_\_) *LITTLE MANATEE RIVER, FLORIDA.—Not*  
6 *later than 3 years after the date on which funds are*  
7 *made available to carry out this paragraph, the Sec-*  
8 *retary of the Interior shall—*

9                “(A) *complete the study of the Little Man-*  
10 *atee River, Florida named in subsection (a)(\_\_);*  
11 *and*

12                “(B) *submit to the Committee on Natural*  
13 *Resources of the House of Representatives and*  
14 *the Committee on Energy and Natural Resources*  
15 *of the Senate a report that describes the results*  
16 *of the study.”.*

17 **SEC. 4. EFFECT ON MANAGEMENT.**

18        *This Act and the amendments made by this Act shall*  
19 *not interfere with the current management of the area of*  
20 *the Little Manatee River described in section 5(a)(\_\_) of*  
21 *the Wild and Scenic Rivers Act, nor shall the fact that such*  
22 *area is listed for study under the Wild and Scenic Rivers*  
23 *Act (16 U.S.C. 1271 et seq.) be used as justification for more*  
24 *restrictive management until Congress acts on the study*  
25 *recommendations.*
