CHAPTER
AN ACT concerning
Catastrophic Event Account - Transfer of Funds - State Disaster Recovery Fund
FOR the purpose of authorizing the transfer of funds from the Catastrophic Event Account to the State Disaster Recovery Fund under certain circumstances; altering the number of days the Legislative Policy Committee has to review and make comments before the Governor may transfer certain funds from the Account through budget amendment; and generally relating to the transfer of funds from the Catastrophic Event Account.
BY repealing and reenacting, without amendments, Article – Public Safety Section 14–110.5(a) Annotated Code of Maryland (2022 Replacement Volume and 2024 Supplement)

- 1 [(v)] **(VI)** any other money from any other source accepted for the 2 benefit of the Fund. 3 **Article - State Finance and Procurement** 4 7 - 324. 5 (a) **(1)** In this section[,] THE FOLLOWING WORDS HAVE THE MEANINGS 6 INDICATED. 7 **(2)** "Account" means the Catastrophic Event Account. 8 "FUND" MEANS THE STATE DISASTER RECOVERY FUND **(3)** 9 ESTABLISHED UNDER § 14–110.5 OF THE PUBLIC SAFETY ARTICLE. 10 (b) Subject to the provisions of this section, the Account is established to enable 11 the State or a local government to respond without undue delay to a natural disaster or 12 other catastrophic situation, or federal employee financial hardship from a full or partial federal government shutdown due to a lapse in federal appropriations that cannot be taken 13 14 care of within the resources of existing appropriations. 15 (c) The Governor may provide an appropriation in the budget bill to the Account. 16 Subject to paragraph (2) of this subsection, after a [15-day] 5-DAY 17 10-DAY review and comment period by the Legislative Policy Committee, the Governor may transfer funds by budget amendment from the Account to: 18 19 the expenditure accounts of the appropriate unit of State **(I)** 20 government or unit of local government; OR SUBJECT TO SUBSECTION (E)(2)(II) OF THIS SECTION, THE 21(II) STATE DISASTER RECOVERY FUND. 2223 If the federal government is in a full or partial shutdown due to a lapse 24 in appropriations, after a 2-day review and comment period by the Legislative Policy Committee, the Governor may transfer funds by budget amendment from the Account to 25 26 the Federal Government Shutdown Employee Assistance Loan Fund established under § 27 7–327 of this subtitle. 28 Funds appropriated to the Catastrophic Event Account: (e) 29 may not be used to offset operating deficiencies in regular programs of (1) 30 State government; but
- 31 (2) (I) may be expended to assist a unit of State government or unit of 32 local government in funding costs in connection with a natural disaster, a catastrophic

3 4	(II) MAY BE TRANSFERRED TO THE STATE DISASTER RECOVERY FUND IF:
5 6	1. THE BALANCE OF THE FUND HAS BEEN DEPLETED DUE TO USE OR TRANSFER; OR
7 8 9	2. THE ESTIMATED COSTS FOR PROVIDING ADEQUATE DISASTER RELIEF FOR A NATURAL DISASTER OR CATASTROPHIC SITUATION ARE IN EXCESS OF THE FUND'S BALANCE.
10 11	(f) (1) The Account is a continuing, nonlapsing fund which is not subject to § 7–302 of this subtitle.
12 13	(2) The Treasurer shall separately hold, and the Comptroller shall account for, the Account.
14 15	(3) The Account shall be invested and reinvested in the same manner as other State funds.
16	(4) Any investment earnings shall be subject to § 7–311(d) of this subtitle.
17 18	(g) Money appropriated to the Account does not revert to the Revenue Stabilization Account.
19 20	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2025.
