RESOLUTION

Providing the Sergeant-at-Arms with the authority to fine Members, Delegates, or the Resident Commissioner for failure to complete security screening for entrance to the House Chamber, and for other purposes.

- 1 Resolved,
- 2 SECTION 1. IMPOSITION OF FINES FOR FAILURE TO COM-
- 3 PLETE SECURITY SCREENING FOR EN-
- 4 TRANCE TO HOUSE CHAMBER.
- 5 (a) Imposition by Sergeant-At-Arms.—(1) The
- 6 Sergeant-at-Arms is authorized and directed to impose a
- 7 fine against a Member, Delegate, or the Resident Commis-

- 1 sioner for failure to complete security screening for en-
- 2 trance to the House Chamber.
- 3 (2) A fine imposed pursuant to this resolution shall
- 4 be \$5,000 for a first offense and \$10,000 for any subse-
- 5 quent offense.
- 6 (3) The Sergeant-at-Arms shall promptly notify in
- 7 writing the Member, Delegate, or the Resident Commis-
- 8 sioner, the Speaker, the Committee on Ethics, and the
- 9 Chief Administrative Officer of any fine under this sub-
- 10 section. Such notification shall include findings detailing
- 11 the violation and shall also be made publicly available by
- 12 the chair of the Committee on Ethics.
- 13 (b) Appeal to Committee on Ethics.—(1) The
- 14 Member, Delegate, or Resident Commissioner may appeal
- 15 the fine imposed under subsection (a) in writing to the
- 16 Committee on Ethics not later than 30 calendar days or
- 17 five legislative days, whichever is later, after notification
- 18 pursuant to subsection (a)(3). Such appeal shall include
- 19 a response to the findings issued by the Sergeant-at-Arms
- 20 pursuant to such paragraph.
- 21 (2) Upon receipt of an appeal pursuant to paragraph
- 22 (1), the Committee on Ethics shall have a period of 30
- 23 calendar days or five legislative days, whichever is later,
- 24 to consider the appeal. The fine will be upheld unless the
- 25 appeal is agreed to by a majority of the Committee. Upon

- 1 a determination regarding the appeal or if no appeal has
- 2 been filed at the expiration of the period specified in para-
- 3 graph (1), the chair of the Committee on Ethics shall
- 4 promptly notify the Member, Delegate, or the Resident
- 5 Commissioner, the Speaker, the Sergeant-at-Arms, and
- 6 the Chief Administrative Officer, and shall make such no-
- 7 tification publicly available. The Speaker shall promptly
- 8 lay such notification before the House.
- 9 (3) If a Member, Delegate, or Resident Commissioner
- 10 files an appeal under paragraph (1) prior to the date on
- 11 which the Committee on Ethics has adopted written rules,
- 12 the period for the Committee's consideration of the appeal
- 13 under paragraph (2) shall begin on the date on which the
- 14 chair of the Committee notifies the Member, Delegate, or
- 15 Resident Commissioner that the Committee has adopted
- 16 such rules.
- 17 (c) DEDUCTING FINE FROM PAY.—(1) If a Member,
- 18 Delegate, or Resident Commissioner against whom a fine
- 19 is imposed by the Sergeant-at-Arms under subsection (a)
- 20 has not paid the fine prior to the expiration of the 90-
- 21 calendar day period which begins on the date described
- 22 in paragraph (2), the Chief Administrative Officer shall
- 23 deduct the amount of the fine from the net salary other-
- 24 wise due the Member, Delegate, or Resident Commis-
- 25 sioner, in accordance with timetables and procedures es-

- 1 tablished by the Committee on House Administration for
- 2 purposes of carrying out this subsection.
- 3 (2) The date described in this paragraph is, with re-
- 4 spect to a fine imposed on a Member, Delegate, or Resi-
- 5 dent Commissioner—
- 6 (A) the date of the determination of the Com-
- 7 mittee on Ethics under subsection (b)(2); or
- 8 (B) if the Member, Delegate, or Resident Com-
- 9 missioner does not file an appeal with the Com-
- mittee on Ethics prior to the expiration of the period
- specified in subsection (b)(1), the first day after the
- 12 expiration of such period.
- 13 (d) Prohibiting Use of Campaign or Official
- 14 Funds To Pay Fines.—A Member, Delegate, or Resi-
- 15 dent Commissioner may not use campaign funds or official
- 16 funds, including amounts in the Members' Representa-
- 17 tional Allowance, to pay a fine imposed under this resolu-
- 18 tion.
- 19 (e) Policies and Procedures.—The Sergeant-at-
- 20 Arms, Committee on Ethics, Committee on House Admin-
- 21 istration, and Chief Administrative Officer are authorized
- 22 to establish policies and procedures for the implementation
- 23 of this resolution.
