Impeaching Donald John Trump, President of the United States, of high misdemeanors.

IN THE HOUSE OF REPRESENTATIVES

DECEMBER 6, 2017

Mr. AL Green of Texas submitted the following resolution; which was laid on the table

RESOLUTION

Impeaching Donald John Trump, President of the United States, of high misdemeanors.

- 1 Resolved, That Donald John Trump, President of the
- 2 United States is unfit to be President and is impeached
- 3 for high misdemeanors, and that the following articles of
- 4 impeachment be exhibited to the Senate:
- 5 Articles of Impeachment exhibited by the House of
- 6 Representatives of the United States, in the name of itself
- 7 and of the people of the United States, against Donald
- 8 John Trump, President of the United States, in mainte-
- 9 nance and support of its impeachment against him for
- 10 high misdemeanors committed as President constituting

- 1 harm to American society to the manifest injury of the
- 2 people of the United States:
- 3 ARTICLE I
- 4 In his capacity as President of the United States, un-
- 5 mindful of the high duties of his high office and the dig-
- 6 nity and proprieties thereof, and of the harmony and cour-
- 7 tesies necessary for stability within the society of the
- 8 United States, Donald John Trump has with his state-
- 9 ments done more than insult individuals and groups of
- 10 Americans, he has harmed the society of the United
- 11 States, brought shame and dishonor to the office of Presi-
- 12 dent of the United States, sowing discord among the peo-
- 13 ple of the United States by associating the majesty and
- 14 dignity of the presidency with causes rooted in white su-
- 15 premacy, bigotry, racism, anti-Semitism, white nation-
- 16 alism, or neo-Nazism on one or more of the following occa-
- 17 sions:
- On August 15, 2017, Donald John Trump made a
- 19 widely published statement characterizing a group of anti-
- 20 Semites, bigots, racists, white nationalists, and Ku Klux
- 21 Klansmen who rallied in Charlottesville, Virginia, as "very
- 22 fine people".
- On August 7, 2017, hate groups returned to Char-
- 24 lottesville, Virginia, at the statue of Robert E. Lee, the
- 25 Confederate general, chanting "You will not replace us!"
- 26 Since this event on October 7, the President has made

- 1 many widely published statements about many things in-
- 2 cluding, the National Football League, but has not made
- 3 one widely published statement condemning the hate
- 4 groups for returning to the place where an innocent person
- 5 lost her life at the hands of hate.
- 6 On November 29, 2017, Donald John Trump shared
- 7 3 videos posted by a leader of a British political party
- 8 considered by many to be an extremist group. The videos
- 9 purported to show various violent acts committed by Mus-
- 10 lims, and were entitled: "Muslim migrant beats up Dutch
- 11 boy on crutches!"; "Muslim Destroys a Statue of Virgin
- 12 Mary!"; and "Islamist mob pushes teenage boy off roof
- 13 and beats him to death!". The clearly inferable intent of
- 14 the post was to demonstrate the alleged propensity of
- 15 Muslim immigrants to engage in violent acts. Even if the
- 16 videos showed what they purport to show, in sharing these
- 17 videos with his 43,800,000 followers on Twitter, Donald
- 18 John Trump's dissemination of such material evinces an
- 19 invidious intent to create division within American society.
- In all of this, the aforementioned Donald John
- 21 Trump, by his statements, unmindful of the high duties
- 22 of his high office and the dignities and proprieties thereof,
- 23 and of the harmony, respect, and courtesies necessary for
- 24 stability within the society of the United States, has un-
- 25 dermined the integrity of his office, has sown discord

- 1 among the people of the United States, has brought disre-
- 2 pute, contempt, ridicule and disgrace on the Presidency,
- 3 has acted in a manner antithetical to the cause of a just
- 4 society, has betrayed his trust as President to the manifest
- 5 injury of the people of the United States, and committed
- 6 a high misdemeanor in office.
- 7 Therefore, Donald John Trump by causing such
- 8 harm to the society of the United States is unfit to be
- 9 President and warrants impeachment, trial, and removal
- 10 from office.
- 11 ARTICLE II
- 12 In his capacity as President of the United States, un-
- 13 mindful of the high duties of his high office, of the dignity
- 14 and proprieties thereof, and of the harmony, and respect
- 15 necessary for stability within the society of the United
- 16 States, Donald John Trump has with his statements done
- 17 more than simply insult individuals and groups of Ameri-
- 18 cans, he has harmed the American society by publicly cast-
- 19 ing contempt on individuals and groups, inciting hate and
- 20 hostility, sowing discord among the people of the United
- 21 States, on the basis of race, national origin, religion, gen-
- 22 der, and sexual orientation, on one or more of the fol-
- 23 lowing occasions:
- On January 27, 2017, Donald John Trump issued
- 25 Executive Order 13769 providing for a partial shutdown
- 26 of immigration from mainly Muslim countries, to fulfill a

- 1 campaign promise that read as follows: "DONALD J.
- 2 TRUMP STATEMENT ON PREVENTING MUSLIM
- 3 IMMIGRATION (New York, NY) December 7th, 2015—
- 4 Donald J. Trump is calling for a total and complete shut-
- 5 down of Muslims entering the United States until our
- 6 country's representatives can figure out what's going on",
- 7 thereby casting contempt upon Muslims, inciting hate and
- 8 hostility, and sowing discord among the people of the
- 9 United States on the basis of religion.
- On July 26, 2017, Donald John Trump made a pub-
- 11 lic statement substantially as follows: "After consultation
- 12 with my Generals and military experts, please be advised
- 13 that the United States Government will not accept or
- 14 allow Transgender individuals to serve in any capacity in
- 15 the U.S. Military. Our military must be focused on deci-
- 16 sive and overwhelming victory and cannot be burdened
- 17 with the tremendous medical costs and disruption that
- 18 transgender in the military would entail", and thereby
- 19 casting contempt on transgender individuals, inciting hate
- 20 and hostility, and sowing discord among the people of the
- 21 United States on the basis of gender.
- On September 23, 2017, Donald John Trump made
- 23 a public statement substantially as follows: "Wouldn't you
- 24 love to see one of these NFL owners, when somebody dis-
- 25 respects our flag, to say, 'Get that son of a b-i-t-c-h off

- 1 the field right now, out, he's fired? He's fired!" thereby
- 2 casting contempt on professional football players who en-
- 3 gaged in constitutionally protected protests pertaining to
- 4 allegations of police misconduct with regard to racial mi-
- 5 norities, as well as casting contempt on the professional
- 6 players' mothers by calling the mothers "b-i-t-c-h-e-s", ef-
- 7 fectively calling these mothers dogs, thereby inciting hate
- 8 and hostility, and sowing discord among the people of the
- 9 United States on the basis of race and gender.
- 10 On September 30, 2017, Donald John Trump made
- 11 a public statement substantially as follows: "They want
- 12 everything to be done for them when it should be a com-
- 13 munity effort", in the aftermath of Hurricane Maria
- 14 thereby casting contempt on Puerto Rican citizens of the
- 15 United States, inciting hate and hostility, and sowing dis-
- 16 cord among the people of the United States based on na-
- 17 tional origin and race.
- On October 3, 2017, Donald John Trump made a
- 19 public statement substantially as follows: "I hate to tell
- 20 you, Puerto Rico, but you've thrown our budget a little
- 21 out of whack because we spent a lot of money on Puerto
- 22 Rico, that's fine, we've saved a lot of lives", but Donald
- 23 John Trump did not make similar comments about Texas
- 24 or Florida in the aftermath of Hurricane Harvey or Hurri-
- 25 cane Irma, treating the Puerto Rican citizens of the

- 1 United States disparately, thereby casting contempt on
- 2 Puerto Ricans, inciting hate and hostility, and sowing dis-
- 3 cord among the people of the United States based on na-
- 4 tional origin and race.
- 5 On October 19, 2017, Donald John Trump made a
- 6 public statement substantially as follows: "The Fake News
- 7 is going crazy with wacky Congresswoman Wilson (D),
- 8 who was SECRETLY on a very personal call, and gave
- 9 a total lie on content!", thereby casting contempt on an
- 10 African-American Member of Congress, inciting hate and
- 11 hostility, and sowing discord among the people of the
- 12 United States based on gender and race.
- On October 21, 2017, Donald John Trump made a
- 14 public statement substantially as follows: "I hope the Fake
- 15 News Media keeps talking about Wacky Congresswoman
- 16 Wilson in that she, as a representative, is killing the Dem-
- 17 ocrat Party!" thereby casting contempt on an African-
- 18 American female Member of Congress, inciting hate and
- 19 hostility, and sowing discord among the people of the
- 20 United States based on gender and race.
- 21 On October 22, 2017, Donald John Trump made a
- 22 public statement substantially as follows: "Wacky Con-
- 23 gresswoman Wilson is the gift that keeps on giving for
- 24 the Republican Party, a disaster for Dems. You watch her
- 25 in action & vote R!" thereby casting contempt on an Afri-

- 1 can-American female Member of Congress inciting hate
- 2 and hostility, and sowing discord among the people of the
- 3 United States based on gender and race.
- 4 In all of this, the aforementioned Donald John
- 5 Trump has, by his statements, brought the high office of
- 6 President of the United States in contempt, ridicule, dis-
- 7 grace and disrepute, has sown discord among the people
- 8 of the United States, has demonstrated that he is unfit
- 9 to be President and has betrayed his trust as President
- 10 of the United States to the manifest injury of the people
- 11 of the United States, and has committed a high mis-
- 12 demeanor in office.
- 13 Therefore, Donald John Trump, by causing such
- 14 harm to the society of the United States, is unfit to be
- 15 President, warrants impeachment, trial, and removal from
- 16 office.
