13 Preamble

WHEREAS, Vernal pools are unique, small—scale ecosystems that contribute significantly to the biodiversity of Maryland by providing habitat for species that cannot reproduce in alternative habitats, including the wood frog, mole salamanders, and fairy shrimp; and

WHEREAS, Vernal pools provide a significant amount of ecosystem services as they occur frequently throughout Maryland and have the capacity to replenish groundwater and filter stormwater flows; and

WHEREAS, Vernal pools are threatened due to limited knowledge of their seasonal presence and the lack of regulatory protections; now, therefore,

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

27 (B) THE DEPARTMENT SHALL ADOPT REGULATIONS TO:

- 1 (1) ESTABLISH PROTECTIONS RELATED TO THE PRESERVATION OF VERNAL POOLS IN THE STATE; AND
- 3 (2) Establish protections for buffers around vernal pools $4\,$ in the State.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 6 October 1, 2025.
