A BILL

To establish a Supply Chain Czar, and for other purposes.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "COVID-19 Supply
- 5 Chain Relief Act".
- 6 SEC. 2. SUPPLY CHAIN CZAR.
- 7 (a) Establishment.—There is established in the
- 8 Executive Office of the President an Office of Supply
- 9 Chain Policy, which shall do the following:

8	(b) APPOINTMENT.—There shall be at the head of the
9	Office a Supply Chain Czar, appointed by the President,
10	who shall serve at the pleasure of the President.
