A BILL

To establish the Blackwell School National Historic Site in Marfa, Texas, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Blackwell School Na-
- 5 tional Historic Site Act".

1 SEC. 2. FINDINGS.

2	Congress finds that—
3	(1) the Blackwell School, located at 501 South
4	Abbott Street, in Marfa, Presidio County, Texas,
5	is—
6	(A) associated with the period of racial
7	segregation in Marfa public schools; and
8	(B) the only extant property directly asso-
9	ciated with Hispanic education in Marfa since
10	the other buildings were torn down after the
11	Blackwell School closed in 1965;
12	(2) the Blackwell School is a tangible reminder
13	of the period during which the doctrine of "separate
14	but equal" dominated education and social systems;
15	(3) despite being categorized as "white" by
16	Texas law, Mexican Americans were regularly ex-
17	cluded from commingling with Anglo individuals at
18	barbershops, restaurants, funeral homes, theaters,
19	churches, and schools;
20	(4) the spectrum of experiences of students and
21	teachers at the Blackwell School are an important
22	record of life in a segregated school in the context
23	of the history of Texas and the United States;
24	(5) Mexican and Mexican American culture and
25	history in Marfa is tied to the Blackwell School,
26	which for more than 50 years served as a leading

1	feature of the Hispanic community, illustrating the
2	challenge of maintaining cultural identity in a domi-
3	nant Anglo society;
4	(6) Hispanic influences continue to be seen in
5	social and religious organizations, business and gov-
6	ernment institutions, and shared experiences of lan-
	,
7	guage, food, and music in Marfa, Texas;
8	(7) the historic Blackwell School building is a
9	physical record of—
10	(A) the longevity and beauty of the distinc-
11	tive design and craftsmanship informed by tra-
12	ditional techniques and materials; and
13	(B) the transition from the purely
14	vernacular to the period of materials, design,
15	and workmanship made available after the ar-
16	rival of the railroad;
17	(8) the original historic school building and
18	grounds on which the Blackwell School building
19	stands provide an authentic setting to commemorate
20	and interpret the history of the Blackwell School;
21	(9) the Blackwell School is closely associated
22	with the broad patterns of local, State, and national
23	history in the area of school segregation; and
24	(10) Mexicans and other members of the Latin
25	American diaspora have placed a high value on edu-

1	cation as a means of economic, social, and political
2	advancement, but Hispanics and Latinos have not
3	always had equitable opportunities and access to
4	quality educational facilities in the United States.
5	SEC. 3. DEFINITIONS.
6	In this Act:
7	(1) Map.—The term "map" means the map
8	prepared under section 4(b)(1).
9	(2) National historic site.—The term "Na-
10	tional Historic Site" means the Blackwell School
11	National Historic Site established by section $4(a)(1)$.
12	(3) Secretary.—The term "Secretary" means
13	the Secretary of the Interior.

5	(2) Determination by Secretary.—The Na-
6	tional Historic Site shall not be established until the
7	date on which the Secretary determines that—
8	(A) a written agreement has been entered
9	into by the Secretary with the Marfa Unified
10	School District providing that the Blackwell
11	School shall be donated to the United States or
12	co-managed with the Secretary for inclusion in
13	a national historic site to be managed consist-
14	ently with the purposes of a national historic
15	site; and
16	(B) a sufficient quantity of land or an in-
17	terest in land within the boundaries of the Na-
18	tional Historic Site has been acquired to con-
19	stitute a manageable unit.
20	(b) Map.—
21	(1) In general.—As soon as practicable after
22	the date of enactment of this Act, the Secretary
23	shall prepare a map that depicts the boundaries of

the National Historic Site.

1	(2) Boundaries.—The boundaries of the Na-
2	tional Historic Site shall be the boundaries generally
3	depicted on the map.
4	(3) AVAILABILITY OF MAP.—The map shall be
5	on file and available for public inspection in the ap-
6	propriate offices of the National Park Service.
7	(c) Acquisition of Authority.—The Secretary
8	may only acquire any land or interest in land located with-
9	in the boundary of the National Historic Site by—
10	(1) donation;
11	(2) purchase with donated funds; or
12	(3) exchange.
13	(d) Administration.—
14	(1) In General.—The Secretary shall admin-
15	ister the National Historic Site in accordance with—
16	(A) this Act; and
17	(B) the laws generally applicable to units
18	of the National Park System.
19	(2) Management plan.—
20	(A) In general.—Not later than 3 years
21	after the date on which funds are first made
22	available to the Secretary to prepare a general
23	management plan for the National Historic
24	Site, the Secretary shall prepare a general man-
25	agement plan for the National Historic Site in

- 1 accordance with section 100502 of title 54, 2 United States Code.
- 3 (B) Submission.—On completion of the
 4 general management plan under subparagraph
 5 (A), the Secretary shall submit to the Com6 mittee on Energy and Natural Resources of the
 7 Senate and the Committee on Natural Re8 sources of the House of Representatives the
 9 general management plan prepared under that
 10 subparagraph.
- 11 (e) Cooperative Agreements.—The Secretary
 12 shall enter into cooperative agreements with the Blackwell
 13 School Alliance and other local, regional, State, academic,
 14 and nonprofit partners for interpretive and educational
 15 programming, technical assistance, and rehabilitation re16 lating to the National Historic Site.
- 17 (f) WRITTEN CONSENT OF OWNER.—No private 18 property or non-Federal public property shall be included 19 within the boundaries of the National Historic Site or 20 managed as part of the National Historic Site without the 21 written consent of the owner of the property.
