AN ACT

To reauthorize the Traumatic Brain Injury program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Traumatic Brain In-
5 jury Program Reauthorization Act of 2018”.

6 **SEC. 2. PREVENTION AND CONTROL OF INJURIES.**

7 Part J of title III of the Public Health Service Act
8 (42 U.S.C. 280b et seq.) is amended—

9 (1) in section 393C (42 U.S.C. 280b–1d) by
10 adding at the end the following:

11 “(c) NATIONAL CONCUSSION SURVEILLANCE SYS-
12 TEM.—The Secretary, acting through the Director of the

1 Centers for Disease Control and Prevention, may imple-
 2 ment a national concussion surveillance system to deter-
 3 mine the prevalence and incidence of concussion.”; and

4 (2) in section 394A (42 U.S.C. 280b–3)—

5 (A) in subsection (b)—

6 (i) by striking “393B and 393C” and
 7 inserting “393B, 393C(a), and 393C(b)”;
 8 and

9 (ii) by striking “\$6,564,000 for each
 10 of fiscal years 2015 through 2019” and in-
 11 serting “\$6,750,000 for each of fiscal
 12 years 2019 through 2023”; and

13 (B) by adding at the end the following:

14 “(c) NATIONAL CONCUSSION SURVEILLANCE SYS-
 15 TEM.—To carry out section 393C(c), there are authorized
 16 to be appropriated \$5,000,000 for each of fiscal years
 17 2019 through 2023.”.

18 **SEC. 3. STATE GRANTS FOR PROJECTS REGARDING TRAU-**
 19 **MATIC BRAIN INJURY.**

20 Section 1252 of the Public Health Service Act (42
 21 U.S.C. 300d–52) is amended—

22 (1) in subsection (a), by inserting “, acting
 23 through the Administrator for the Administration
 24 for Community Living,” after “The Secretary”;

25 (2) by striking subsection (e);

1 (3) by redesignating subsections (f) through (j)
2 as subsections (e) through (i), respectively; and

3 (4) in subsection (i), as so redesignated, by
4 striking “\$5,500,000 for each of the fiscal years
5 2015 through 2019” and inserting “\$7,321,000 for
6 each of fiscal years 2019 through 2023”.

7 **SEC. 4. STATE GRANTS FOR PROTECTION AND ADVOCACY**
8 **SERVICES.**

9 Section 1253 of the Public Health Service Act (42
10 U.S.C. 300d–53) is amended—

11 (1) in subsection (a), by inserting “, acting
12 through the Administrator for the Administration
13 for Community Living,” after “The Secretary”; and

14 (2) in subsection (l), by striking “\$3,100,000
15 for each of the fiscal years 2015 through 2019” and
16 inserting “\$4,000,000 for each of fiscal years 2019
17 through 2023”.
