### Restrictions on Use - Solar Collector Systems - Alteration

3 FOR the purpose of prohibiting a restriction on use regarding land use that increases the 4 cost of installing a solar collector system by at least a certain percentage over a 5 certain cost or that reduces the efficiency of the solar collector system by at least a 6 certain percentage under a certain level of energy generation; authorizing a 7 community association to prohibit the installation of a solar collector system in the 8 common area or common elements within the real estate development served by the community association; authorizing a community association to impose reasonable 9 restrictions on the installation of a solar collector system in the common area or 10 11 common elements; authorizing a community association to install a solar collector 12 system in the common area or common elements provided the installation is not 13 otherwise prohibited by applicable law; and generally relating to regulation of solar 14 collector systems.

- 1 hours of the day on specified dates when direct sunlight to a specified surface of a solar collector system may not be obstructed;
- 3 (ii) The restrictions placed on vegetation, structures, and other 4 objects that would impair the passage of sunlight through the solar easement; and
- 5 (iii) The terms under which the solar easement may be revised or 6 terminated.
- 7 (3) A written instrument creating a solar easement shall be recorded in the 8 land records of the county where the property is located.
- 9 (d) This section does not apply to a restriction on use on historic property that is 10 listed in, or determined by the Director of the Maryland Historical Trust to be eligible for 11 inclusion in, the Maryland Register of Historic Properties.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2024.
