16 17	(f) (1) Except as provided in paragraph (2) of this subsection, the Secretary may not issue tax credit certificates for credit amounts in the aggregate totaling more than:
18	(i) for fiscal year 2014, \$25,000,000;

20	(iii) for fiscal year 2016, \$7,500,000;
