A BILL

To require the Director of the Financial Crimes Enforcement Network to submit a report to Congress on the way in which data collected pursuant to title 31 is being used, and for other purposes.

1	Be it enacted by the Senate and House of Representa-			
2	$tives\ of\ the\ United\ States\ of\ America\ in\ Congress\ assembled,$			
3	SECTION 1. SHORT TITLE.			
4	This Act may be cited as the "Improving Strategies			
5	to Counter Weapons Proliferation Act".			
6	SEC. 2. FINANCIAL CRIMES ENFORCEMENT NETWORK RE-			
7	PORTING REQUIREMENT.			
8	Section 310 of title 31, United States Code, is			
9	amended by adding at the end the following:			
10	"(e) Reports Relating to Use of Collected			
11	Data.—			
12	"(1) IN GENERAL.—Not later than 1 year after			
13	the date of enactment of this subsection and every			
14	year thereafter, the Director shall submit to the			
15	Committee on Financial Services of the House of			
16	Representatives and the Committee on Banking,			
17	Housing, and Urban Affairs of the Senate a report			
18	on—			
19	"(A) intelligence products created by			
20	FinCEN on finance transactions for the pro-			
21	liferation of weapons from filings submitted			
22	pursuant to subchapter II of chapter 53;			
23	"(B) FinCEN's efforts to collaborate with			
24	law enforcement agencies, the intelligence com-			
25	munity, and foreign financial intelligence units			

1	to maximize the use of data that is collected					
2	pursuant to subchapter II of chapter 53; and					
3	"(C) advisory notices issued to financial in-					
4	stitutions (as defined under section 5312(a)) or					
5	financial activity related to the proliferation of					
6	weapons.					
7	"(2) Separate presentation of classified					
8	MATERIAL.—Any part of the report under paragraph					
9	(1) that involves information that is properly classi-					
10	fied under criteria established by the President shall					
11	be submitted to the Congress separately in a classi-					
12	fied annex.					
13	"(3) Sunset.—No report is required under this					
14	subsection after the end of the 5-year period begin-					
15	ning on the date of enactment of this subsection.".
