A BILL ENTITLED

1 AN ACT concerning

2 **Election Law – Campaign Contributions – Alterations and Prohibition on Sports**
3 **Wagering Licensees**

4 FOR the purpose of prohibiting certain sports wagering licensees and certain individuals
5 employed by a sports wagering licensee or video lottery operator from directly or
6 indirectly making contributions to campaign finance entities; and generally relating
7 to campaign contributions.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Election Law**

16 13–237.

17 (a) (1) In this section the following words have the meanings indicated.

18 (2) **“ONLINE SPORTS WAGERING” HAS THE MEANING STATED IN §**
19 **9–1E–01 OF THE STATE GOVERNMENT ARTICLE.**

20 [(2)] (3) **“Own”** has the meaning stated in § 9–1A–01 of the State
21 Government Article.

22 (4) **“SPORTS WAGERING LICENSEE” HAS THE MEANING STATED IN §**

2 [(3)] (5) "Video lottery facility" has the meaning stated in § 9-1A-01 of
3 the State Government Article.

4 [(4)] (6) "Video lottery operation license" has the meaning stated in §
5 9-1A-01 of the State Government Article.

6 **(7) "VIDEO LOTTERY OPERATOR" HAS THE MEANING STATED IN §**
7 **9-1A-01 OF THE STATE GOVERNMENT ARTICLE.**

8 (b) This section applies to the following persons:

9 (1) an applicant for a video lottery operation license **OR SPORTS**
10 **WAGERING LICENSE;**

11 (2) a holder of a video lottery operation license **OR SPORTS WAGERING**
12 **LICENSE; [or]**

13 (3) a person who owns an interest in the operation of **ONLINE SPORTS**
14 **WAGERING, a video lottery facility, OR A SPORTS WAGERING FACILITY** in [this] **THE**
15 **State; OR**

16 **(4) AN EXECUTIVE OFFICER EMPLOYED BY A VIDEO LOTTERY**
17 **OPERATOR OR SPORTS WAGERING LICENSEE IN THE STATE.**

18 (c) This section does not apply to gaming activity that an eligible organization is
19 authorized to conduct under the Criminal Law Article.

20 (d) A person subject to this section may not, directly or indirectly, make a
21 contribution to:

22 (1) the campaign finance entity of a candidate for any nonfederal public
23 office in the State; or

24 (2) any other campaign finance entity organized in support of a candidate
25 for any nonfederal public office in the State.

26 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
27 **October 1, 2022.**
