## A BILL

To amend the Civil Rights Act of 1964 to make using critical race theory or critical race pedagogy in any program or activity receiving Federal financial assistance a violation of such Act, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Defending Students'
- 5 Civil Rights Act of 2021".

1	SEC. 2. RULE OF CONSTRUCTION MAKING CRITICAL RACE
2	THEORY A VIOLATION OF THE CIVIL RIGHTS
3	ACT.
4	Title VI of the Civil Rights Act of 1964 (42 U.S.C.
5	2000d et seq.) is amended by adding at the end the fol-
6	lowing new section:
7	"Sec. 607. (a) It is a violation of section 601 to use
8	critical race theory or critical race pedagogy in any pro-
9	gram or activity receiving Federal financial assistance.
10	"(b) In this section:
11	"(1) The term 'critical race pedagogy' means—
12	"(A) separating students or teachers based
13	on race, color, or national origin; or
14	"(B) assigning characteristics or assump-
15	tions to individuals based on race, color, or na-
16	tional origin.
17	"(2) The term 'critical race theory' means a
18	curriculum that establishes that—
19	"(A) one race or sex is inherently superior
20	to another race or sex;
21	"(B) the United States is fundamentally
22	racist or sexist;
23	"(C) an individual, by virtue of their race
24	or sex, is inherently racist, sexist, or oppressive,
25	whether consciously or unconsciously

1	"(D) an individual should be discriminated
2	against or receive adverse treatment solely or
3	partly because of the race or sex of such indi-
4	vidual;
5	"(E) members of one race or sex cannot
6	and should not attempt to treat others without
7	respect to race or sex;
8	"(F) an individual's moral character is
9	necessarily determined by the race or sex of
10	such individual;
11	"(G) an individual, by virtue of their race
12	or sex, bears responsibility for actions com-
13	mitted in the past by other members of the
14	same race or sex;
15	"(H) any individual should feel discomfort,
16	guilt, anguish, or any other form of psycho-
17	logical distress on account of the race or sex of
18	such individual; and
19	"(I) meritocracy or traits such as hard
20	work ethic are racist or sexist, or were created
21	by a particular race to oppress another race or
22	individual.".
