Mr. Barr introduced the following bill; which was referred to the Committee on Foreign Affairs

# A BILL

To prohibit the solicitation of reimbursement of any travel expenses incurred by the Department of State on behalf of any United States citizen or lawful permanent resident evacuated from Ukraine and repatriated to the United States, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Russians Engaged in
- 5 Threating Ukraine Refuge Now Act" or the "RETURN
- 6 Act".

#### SEC. 2. PROHIBITION ON SOLICITATION OF REIMBURSE-

- 2 MENT.
- 3 (a) In General.—Notwithstanding subsection
- 4 (b)(2)(A)(ii) of section 4 of the State Department Basic
- 5 Authorities Act of 1956 (22 U.S.C. 2671), during the pe-
- 6 riod of evacuation related to a Russian invasion of
- 7 Ukraine and withdrawal of United States Department of
- 8 State personnel from Ukraine—
- 9 (1) the Secretary of State shall waive any re-
- payment of any travel expenses incurred by the De-
- partment of State on behalf of any United States
- citizen or lawful permanent resident evacuated from
- 13 Ukraine and repatriated to the United States;
- 14 (2) any promissory note or other obligation to
- 15 repay an emergency repatriation loan signed by a
- 16 United States citizen or a lawful permanent resident
- of the United States to reimburse the Department of
- 18 State for travel expenses described in paragraph (1)
- shall be null and void; and
- 20 (3) no Federal official or employee may solicit
- or accept any amount from any individual who is a
- citizen of the United States or a lawful permanent
- resident of the United States, whether in the form
- of a reimbursement or as any other condition of
- using transportation provided by the United States,
- to repatriate such individual to the United States.

- 1 (b) Prohibition of Denial of Travel.—No trav-
- 2 eler on any Department of State-sponsored air travel pur-
- 3 suant to subsection (a) shall be denied a flight if such
- 4 traveler is unable to abide by the requirements the Amend-
- 5 ed Order: Requirement for Proof of Negative COVID-19
- 6 Test Result or Recovery from COVID-19 for All Airline
- 7 Passengers Arriving into the United States, published on
- 8 December 2, 2021.
- 9 (c) TERMINATION.—This Act shall terminate on the
- 10 date that is six months after the date of the enactment
- 11 of this Act.
