1 13–612. 2 IN THIS SECTION, "PROPERTY MANAGER" MEANS AN ENTITY (A) 3 RESPONSIBLE FOR THE MANAGEMENT AND MAINTENANCE OF REAL PROPERTY, **INCLUDING:** 4 **(1)** 5 FINDING TENANTS; 6 **(2) COLLECTING RENT**; 7 **(3)** PAYING EXPENSES AND APPLICABLE TAXES; 8 **(4)** MAINTAINING UTILITIES AND SYSTEMS; AND 9 TAKING ANY NECESSARY ACTIONS TO MANAGE AND OPERATE **(5)** 10 REAL PROPERTY. 11 [(a)] **(B)** The Council may operate in the region. 12 [(b)] **(C)** The Council may: 13 adopt a seal; (1) 14 (2) sue; 15 (3)adopt bylaws and rules for the conduct of its business; 16 enter into contracts and agreements; (4) 17 borrow money and accept advances, loans, grants, contributions, and 18 any other form of assistance from the federal government, the State, or other public or 19 private source; 20 give any required security; (6) 21 include in any contract for financial assistance with the federal (7)22government any reasonable and appropriate condition imposed under federal law that is not inconsistent with the purposes of this subtitle; [and] 2324(8)execute any instrument and act as necessary, convenient, or desirable 25to carry out its powers and the purposes of this subtitle; AND

26 (9) ACT AS A PROPERTY MANAGER OF THE SOUTHERN MARYLAND REGIONAL AGRICULTURAL CENTER OWNED BY AND LOCATED WITHIN ST. MARY'S COUNTY.
