To amend the Small Business Act to extend the statute of limitation for fraud by borrowers under the Paycheck Protection Program, and for other purposes.

3	SECTION 1. SHORT TITLE.					
4	This Act may be cited as the "PPP and Bank Fraud					
5	Enforcement Harmonization Act of 2022".					
6	SEC. 2. FRAUD ENFORCEMENT HARMONIZATION.					
7	(a) Paycheck Protection Program.—Section					
8	7(a)(36) of the Small Business Act (15 U.S.C.					
9	636(a)(36)) is amended by adding at the end the following					
10	new subparagraph:					
11	"(W) Fraud enforcement harmoni-					
12	ZATION.—Notwithstanding any other provision					
13	of law, any criminal charge or civil enforcement					
14	action alleging that a borrower engaged in					
15	fraud with respect to a covered loan guaranteed					
16	under this paragraph shall be filed not later					
17	than 10 years after the offense was com-					
18	mitted.".					
19	(b) PAYCHECK PROTECTION PROGRAM SECOND					
20	Draw Loans.—Section 7(a)(37) of the Small Business					
21	Act (15 U.S.C. 636(a)(37)) is amended by adding at the					
22	end the following new subparagraph:					
23	"(P) Fraud enforcement harmoni-					
24	ZATION.—Notwithstanding any other provision					
25	of law, any criminal charge or civil enforcement					

1	action alleging that a borrower engaged in
2	fraud with respect to a covered loan guaranteed
3	under this paragraph shall be filed not later
4	than 10 years after the offense was com-
