AN ACT concerning
Baltimore County - Orphans' Court Judges and Surviving Spouses - Pensions
FOR the purpose of requiring Baltimore County to pay Orphans' Court judges and their surviving spouses a certain pension under certain circumstances; requiring the County Council of Baltimore County to establish, by law, certain requirements and procedures relating to the pension of a judge of the Orphans' Court; and generally relating to the pension of a judge of the Orphans' Court for Baltimore County.
