A BILL

To prohibit the Secretary of Homeland Security from procuring certain foreign-made batteries, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Decoupling from Foreign*
 5 *Adversarial Battery Dependence Act”.*

6 **SEC. 2. PROHIBITION ON AVAILABILITY OF FUNDS FOR**
 7 **PROCUREMENT OF CERTAIN BATTERIES.**

8 (a) *IN GENERAL.*—*Beginning on October 1, 2027,*
 9 *none of the funds authorized to be appropriated or otherwise*
 10 *made available for the Department of Homeland Security*
 11 *may be obligated to procure a battery produced by an entity*
 12 *specified in subsection (b).*

13 (b) *ENTITIES SPECIFIED.*—*The entities specified in*
 14 *this subsection are the following:*

15 (1) *Contemporary Amperex Technology Com-*
 16 *pany, Limited (also known as “CATL”).*

17 (2) *BYD Company, Limited.*

18 (3) *Envision Energy, Limited.*

19 (4) *EVE Energy Company, Limited.*

20 (5) *Gotion High tech Company, Limited.*

21 (6) *Hithium Energy Storage Technology com-*
 22 *pany, Limited.*

23 (7) *Any entity on any list required under clauses*
 24 *(i), (ii), (iv), or (v) of section 2(d)(2)(B) of Public*

1 *Law 117–78 (commonly referred to as the “Uyghur*
2 *Forced Labor Prevention Act”).*

3 *(8) Any entity identified by the Secretary of De-*
4 *fense as a Chinese military company pursuant to sec-*
5 *tion 1260H of the William M. (Mac) Thornberry Na-*
6 *tional Defense Authorization Act for Fiscal Year 2021*
7 *(10 U.S.C. 113 note).*

8 *(9) Any entity included in Supplement No. 4 to*
9 *part 744 of title 15, Code of Federal Regulations, or*
10 *any successor regulation.*

11 *(10) Any subsidiary or successor to an entity*
12 *specified in paragraphs (1) through (9).*

13 *(c) TREATMENT OF PRODUCTION.—For purposes of*
14 *this section, a battery shall be treated as produced by an*
15 *entity specified in subsection (b) if such entity—*

16 *(1) assembles or manufactures the final product*
17 *that uses such battery; or*

18 *(2) creates or otherwise provides a majority of*
19 *the components used in such battery.*

20 *(d) WAIVERS.—*

21 *(1) RELATING TO ASSESSMENT.—The Secretary*
22 *of Homeland Security may waive the limitation*
23 *under subsection (a) if the Secretary assesses in the*
24 *affirmative all of the following:*

1 (A) *The batteries to be procured do not pose*
2 *a national security, data, or infrastructure risk*
3 *to the United States.*

4 (B) *There is no available alternative to pro-*
5 *cure batteries that are—*

6 (i) *of similar or better cost and qual-*
7 *ity; and*

8 (ii) *produced by an entity not specified*
9 *in subsection (b).*

10 (2) *RELATING TO RESEARCH.—The Secretary of*
11 *Homeland Security may waive the limitation under*
12 *subsection (a) if the Secretary determines that the*
13 *batteries to be procured are for the sole purpose of re-*
14 *search, evaluation, training, testing, or analysis*

15 (3) *CONGRESSIONAL NOTIFICATION.—Not later*
16 *than 15 days after granting a waiver under this sub-*
17 *section, the Secretary of Homeland Security shall sub-*
18 *mit to the Committee on Homeland Security of the*
19 *House of Representatives and the Committee on*
20 *Homeland Security and Governmental Affairs of the*
21 *Senate a notification relating thereto.*

22 (e) *REPORT.—Not later than 180 days after the date*
23 *of the enactment of this Act, the Secretary of Homeland Se-*
24 *curity shall submit to the Committee on Homeland Security*
25 *of the House of Representatives and the Committee on*

1 *Homeland Security and Governmental Affairs of the Senate*
2 *a report on the anticipated impacts on mission and costs*
3 *on the Department of Homeland Security associated with*
4 *carrying out this section, including with respect to fol-*
5 *lowing components of the Department:*

6 (1) *U.S. Customs and Border Protection, includ-*
7 *ing the U.S. Border Patrol.*

8 (2) *U.S. Immigration and Customs Enforcement,*
9 *including Homeland Security Investigations.*

10 (3) *The United States Secret Service.*

11 (4) *The Transportation Security Administra-*
12 *tion.*

13 (5) *The United States Coast Guard.*

14 (6) *The Federal Protective Service.*

15 (7) *The Federal Emergency Management Agency.*

16 (8) *The Federal Law Enforcement Training Cen-*
17 *ters.*

18 (9) *The Cybersecurity and Infrastructure Secu-*
19 *rity Agency.*
