14	(2) Contrary provisions of any section of the Kentucky Revised Statutes
15	notwithstanding, the proposed ordinary amendments referenced in subsection (1)
16	of this section shall be null, void, and unenforceable as of the effective date of
17	this Act.
18	(3) Contrary provisions of any section of the Kentucky Revised Statutes
19	notwithstanding, the administrative body shall be prohibited from promulgating
20	administrative regulations that are identical to, or substantially the same as, the
21	proposed amendments referenced in subsection (1) of this section for a period
22	beginning on January 7, 2025, and concluding on June 1, 2026.
