A BILL

To amend title XI of the Social Security Act to clarify the mailing requirement relating to social security account statements.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Know Your Social Secu-*
 5 *rity Act of 2019”.*

6 **SEC. 2. CLARIFICATION OF REQUIREMENT TO MAIL SOCIAL**
 7 **SECURITY ACCOUNT STATEMENTS.**

8 *(a) IN GENERAL.—Section 1143 of the Social Security*
 9 *Act (42 U.S.C. 1320b-13) is amended—*

10 *(1) in subsection (a)(1), by adding at the end the*
 11 *following: “Such statement shall be provided by mail*
 12 *unless the requesting individual chooses electronic de-*
 13 *livery for that request.”; and*

14 *(2) in subsection (c)(2)—*

15 *(A) by striking “Beginning not later than”*
 16 *and inserting “(A) Beginning not later than”;*

17 *(B) by inserting “by mail” after “provide”;*
 18 *and*

19 *(C) by adding at the end the following:*

20 *“(B) In any case in which an eligible individual de-*
 21 *scribed in subparagraph (A) responds to an annual inquiry*
 22 *by the Commissioner relating to the mailing of the individ-*
 23 *ual’s statement by making an election that such statement*
 24 *for such year be provided in electronic form only, the re-*

1 *quirements of this paragraph shall be deemed to be satisfied*
2 *for such year with respect to the individual.”.*

3 *(b) EFFECTIVE DATE.—The amendments made by sub-*
4 *section (a) shall apply with respect to social security ac-*
5 *count statements required to be provided after the date of*
6 *the enactment of this Act.*
