A BILL

To amend title XVIII of the Social Security Act to provide for electronic prior authorization under Medicare part D for covered part D drugs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Standardizing Elec-*
 5 *tronic Prior Authorization for Safe Prescribing Act of*
 6 *2018”.*

7 **SEC. 2. ELECTRONIC PRIOR AUTHORIZATION FOR COVERED**

8 **PART D DRUGS.**

9 *(a) INCLUSION IN ELECTRONIC PRESCRIPTION PRO-*
 10 *GRAM.—Section 1860D–4(e)(2) of the Social Security Act*
 11 *(42 U.S.C. 1395w–104(e)(2)) is amended by adding at the*
 12 *end the following new subparagraph:*

13 *“(E) ELECTRONIC PRIOR AUTHORIZA-*
 14 *TION.—*

15 *“(i) IN GENERAL.—Not later than Jan-*
 16 *uary 1, 2021, the program shall provide for*
 17 *the secure electronic transmittal of—*

18 *“(I) a prior authorization request*
 19 *from the prescribing health care profes-*
 20 *sional for coverage of a covered part D*
 21 *drug for a part D eligible individual*
 22 *enrolled in a part D plan (as defined*
 23 *in section 1860D–23(a)(5)) to the PDP*
 24 *sponsor or Medicare Advantage organi-*
 25 *zation offering such plan; and*

1 “(II) a response, in accordance
2 with this subparagraph, from such
3 PDP sponsor or Medicare Advantage
4 organization, respectively, to such pro-
5 fessional.

6 “(ii) *ELECTRONIC TRANSMISSION.*—

7 “(I) *EXCLUSIONS.*—For purposes
8 of this subparagraph, a facsimile, pro-
9 prietary payer portal that meets such
10 standards as specified by the Secretary,
11 or electronic form shall not be treated
12 as an electronic transmission described
13 in clause (i).

14 “(II) *STANDARDS.*—In order to be
15 treated, for purposes of this subpara-
16 graph, as an electronic transmission
17 described in clause (i), such trans-
18 mission shall comply with technical
19 standards adopted by the Secretary in
20 consultation with the National Council
21 for Prescription Drug Programs, other
22 standard setting organizations deter-
23 mined appropriate by the Secretary,
24 and stakeholders including PDP spon-
25 sors, Medicare Advantage organiza-

1 *tions, health care professionals, and*
2 *health information technology software*
3 *vendors.”.*

4 *(b) SENSE OF CONGRESS REGARDING ELECTRONIC*
5 *PRIOR AUTHORIZATION.—It is the sense of the Congress*
6 *that—*

7 *(1) there should be increased use of electronic*
8 *prior authorizations for coverage of covered part D*
9 *drugs for part D eligible individuals enrolled in pre-*
10 *scription drug plans under part D of title XVIII of*
11 *the Social Security Act and MA–PD plans under*
12 *part C of such title to reduce access delays by resolv-*
13 *ing coverage issues before prescriptions for such drugs*
14 *are transmitted; and*

15 *(2) greater priority should be placed on increas-*
16 *ing the adoption of use of such electronic prior au-*
17 *thorizations among prescribers of such drugs, phar-*
18 *macies, PDP sponsors, and Medicare Advantage orga-*
19 *nizations.*
