

In the Senate of the United States,

December 22, 2018.

Resolved, That the bill from the House of Representatives (H.R. 4203) entitled “An Act to amend title 18, United States Code, with regard to stalking.”, do pass with the following

AMENDMENT:

Strike all after the enacting clause and insert the following:

1 ***SECTION 1. SHORT TITLE.***

2 *This Act may be cited as the “Combat Online Preda-*
3 *tors Act”.*

4 ***SEC. 2. ENHANCED PENALTY FOR STALKERS OF CHILDREN.***

5 *(a) IN GENERAL.—Chapter 110A of title 18, United*
6 *States Code, is amended by inserting after section 2261A*
7 *the following:*

8 ***“§ 2261B. Enhanced penalty for stalkers of children***

9 *“(a) IN GENERAL.—Except as provided in subsection*
10 *(b), if the victim of an offense under section 2261A is under*

1 *the age of 18 years, the maximum imprisonment for the*
 2 *offense is 5 years greater than the maximum term of im-*
 3 *prisonment otherwise provided for that offense in section*
 4 *2261.*

5 “(b) *LIMITATION.*—Subsection (a) shall not apply to
 6 *a person who violates section 2261A if—*

7 “(1) *the person is subject to a sentence under sec-*
 8 *tion 2261(b)(5); and*

9 “(2)(A) *the person is under the age of 18 at the*
 10 *time the offense occurred; or*

11 “(B) *the victim of the offense is not less than 15*
 12 *nor more than 17 years of age and not more than 3*
 13 *years younger than the person who committed the of-*
 14 *fense at the time the offense occurred.”.*

15 (b) *CLERICAL AMENDMENT.*—*The table of sections at*
 16 *the beginning of chapter 110A of title 18, United States*
 17 *Code, is amended by inserting after the item relating to*
 18 *section 2261A the following new item:*

“2261B. Enhanced penalty for stalkers of children.”.

19 (c) *CONFORMING AMENDMENT.*—*Section 2261A of title*
 20 *18, United States Code, is amended by striking “section*
 21 *2261(b) of this title” and inserting “section 2261(b) or sec-*
 22 *tion 2262B, as the case may be”.*

1 **SEC. 3. REPORT ON BEST PRACTICES REGARDING EN-**
2 **FORCEMENT OF ANTI-STALKING LAWS.**

3 *Not later than 1 year after the date of the enactment*
4 *of this Act, the Attorney General shall submit a report to*
5 *Congress, which shall—*

6 *(1) include an evaluation of Federal, tribal,*
7 *State, and local efforts to enforce laws relating to*
8 *stalking; and*

9 *(2) identify and describe those elements of such*
10 *efforts that constitute the best practices for the en-*
11 *forcement of such laws.*
