# **AN ACT**

Making continuing appropriations for fiscal year 2020, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

- 3 tions Act, 2020, and Health Extenders Act of 2019".

### 12 APPROPRIATIONS ACT, 2020

- The following sums are hereby appropriated, out of
- 14 any money in the Treasury not otherwise appropriated,
- 15 and out of applicable corporate or other revenues, receipts,
- 16 and funds, for the several departments, agencies, corpora-

- 1 tions, and other organizational units of Government for
- 2 fiscal year 2020, and for other purposes, namely:
- 3 Sec. 101. Such amounts as may be necessary, at a
- 4 rate for operations as provided in the applicable appro-
- 5 priations Acts for fiscal year 2019 and under the authority
- 6 and conditions provided in such Acts, for continuing
- 7 projects or activities (including the costs of direct loans
- 8 and loan guarantees) that are not otherwise specifically
- 9 provided for in this Act, that were conducted in fiscal year
- 10 2019, and for which appropriations, funds, or other au-
- 11 thority were made available in the following appropriations
- 12 Acts:
- 13 (1) The Agriculture, Rural Development, Food
- and Drug Administration, and Related Agencies Ap-
- propriations Act, 2019 (division B of Public Law
- 16 116-6), except that the language under the heading
- 17 "Rural Utilities Service—Rural Water and Waste
- 18 Disposal Program Account" in title III shall be ap-
- plied by inserting "the cost of direct loans," before
- 20 "loan guarantees" at the beginning of the second
- sentence in the matter preceding the first proviso.

- 8 SEC. 102. (a) No appropriation or funds made avail-9 able or authority granted pursuant to section 101 for the 10 Department of Defense shall be used for:
- 11 (1) the new production of items not funded for 12 production in fiscal year 2019 or prior years;
  - (2) the increase in production rates above those sustained with fiscal year 2019 funds; or
    - (3) the initiation, resumption, or continuation of any project, activity, operation, or organization (defined as any project, subproject, activity, budget activity, program element, and subprogram within a program element, and for any investment items defined as a P-1 line item in a budget activity within an appropriation account and an R-1 line item that includes a program element and subprogram element within an appropriation account) for which appropriations, funds, or other authority were not available during fiscal year 2019.

- 1 (b) No appropriation or funds made available or au-
- 2 thority granted pursuant to section 101 for the Depart-
- 3 ment of Defense shall be used to initiate multi-year pro-
- 4 curements utilizing advance procurement funding for eco-
- 5 nomic order quantity procurement unless specifically ap-
- 6 propriated later.
- 7 Sec. 103. Appropriations made by section 101 shall
- 8 be available to the extent and in the manner that would
- 9 be provided by the pertinent appropriations Act.
- 10 Sec. 104. Except as otherwise provided in section
- 11 102, no appropriation or funds made available or author-
- 12 ity granted pursuant to section 101 shall be used to ini-
- 13 tiate or resume any project or activity for which appro-
- 14 priations, funds, or other authority were not available dur-
- 15 ing fiscal year 2019.
- 16 Sec. 105. Appropriations made and authority grant-
- 17 ed pursuant to this Act shall cover all obligations or ex-
- 18 penditures incurred for any project or activity during the
- 19 period for which funds or authority for such project or
- 20 activity are available under this Act.
- 21 Sec. 106. Unless otherwise provided for in this Act
- 22 or in the applicable appropriations Act for fiscal year
- 23 2020, appropriations and funds made available and au-
- 24 thority granted pursuant to this Act shall be available
- 25 until whichever of the following first occurs:

- 1 (1) The enactment into law of an appropriation 2 for any project or activity provided for in this Act.
- 3 (2) The enactment into law of the applicable 4 appropriations Act for fiscal year 2020 without any
- 5 provision for such project or activity.
- 6 (3) November 21, 2019.
- 7 Sec. 107. Expenditures made pursuant to this Act
- 8 shall be charged to the applicable appropriation, fund, or
- 9 authorization whenever a bill in which such applicable ap-
- 10 propriation, fund, or authorization is contained is enacted
- 11 into law.
- 12 Sec. 108. Appropriations made and funds made
- 13 available by or authority granted pursuant to this Act may
- 14 be used without regard to the time limitations for submis-
- 15 sion and approval of apportionments set forth in section
- 16 1513 of title 31, United States Code, but nothing in this
- 17 Act may be construed to waive any other provision of law
- 18 governing the apportionment of funds.
- 19 Sec. 109. Notwithstanding any other provision of
- 20 this Act, except section 106, for those programs that
- 21 would otherwise have high initial rates of operation or
- 22 complete distribution of appropriations at the beginning
- 23 of fiscal year 2020 because of distributions of funding to
- 24 States, foreign countries, grantees, or others, such high
- 25 initial rates of operation or complete distribution shall not

- 1 be made, and no grants shall be awarded for such pro-
- 2 grams funded by this Act that would imping on final
- 3 funding prerogatives.
- 4 Sec. 110. This Act shall be implemented so that only
- 5 the most limited funding action of that permitted in the
- 6 Act shall be taken in order to provide for continuation of
- 7 projects and activities.
- 8 Sec. 111. (a) For entitlements and other mandatory
- 9 payments whose budget authority was provided in appro-
- 10 priations Acts for fiscal year 2019, and for activities under
- 11 the Food and Nutrition Act of 2008, activities shall be
- 12 continued at the rate to maintain program levels under
- 13 current law, under the authority and conditions provided
- 14 in the applicable appropriations Act for fiscal year 2019,
- 15 to be continued through the date specified in section

- 12 U.S.C. 2680), section 313 of the Foreign Relations Au-
- 13 thorization Act, Fiscal Years 1994 and 1995 (22 U.S.C.
- 14 6212), and section 504(a)(1) of the National Security Act
- 15 of 1947 (50 U.S.C. 3094(a)(1)).
- 16 Sec. 114. (a) Each amount incorporated by reference
- 17 in this Act that was previously designated by the Congress
- 18 for Overseas Contingency Operations/Global War on Ter-
- 19 rorism or as an emergency requirement pursuant to sec-
- 20 tion 251(b)(2)(A) of the Balanced Budget and Emergency
- 21 Deficit Control Act of 1985 or as being for disaster relief
- 22 pursuant to section 251(b)(2)(D) of such Act is des-
- 23 ignated by the Congress for Overseas Contingency Oper-
- 24 ations/Global War on Terrorism or as an emergency re-

- 10 Sec. 115. (a) Rescissions or cancellations of discre-
- 11 tionary budget authority that continue pursuant to section
- 12 101 in Treasury Appropriations Fund Symbols (TAFS)—
- 13 (1) to which other appropriations are not pro-
- vided by this Act, but for which there is a current
- applicable TAFS that does receive an appropriation
- in this Act; or
