A BILL

To enact a comprehensive legislative response to the threats posed by the Chinese Communist Party to the United States of America and to freedom, democracy, and human rights around the world.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “China Task Force Act”
3 or the “CTF Act”.

4 **SEC. 2. FINDINGS.**

5 Congress finds the following:

6 (1) The Chinese Communist Party (CCP) is
7 completely committed to a hostile communist ide-
8 ology in which individuals exist to serve the state,
9 enjoying rights and freedoms only at the state’s dis-
10 cretion.

11 (2) The CCP applies this ideology onto the Peo-
12 ple’s Republic of China (PRC) through a system of
13 government called “socialism with Chinese charac-
14 teristics”, the main tenet of which is the absolute to-
15 talitarianism of the CCP. CCP General Secretary Xi
16 Jinping recently described this political system by
17 writing “the Party, the government, the military, the
18 people, and academia—east, west, south, north, and
19 center—the Party leads everything”.

20 (3) The CCP’s adherence to communist ide-
21 ology and its application of this ideology through to-
22 talitarianism drives its persistently malign conduct
23 as the CCP seeks to eliminate perceived threats to
24 the security of its regime.

25 (4) The CCP has legally defined the national
26 security of the PRC as the “absence of international

1 or domestic threats to the state's power'', enshrining
2 in law its belief that the CCP will not be secure until
3 all threats foreign and domestic are eliminated, a
4 concept which requires external aggression.

5 (5) The CCP considers constitutional democ-
6 racy, internationally recognized human rights, free
7 markets, independent journalism, and internal dis-
8 sent to be security threats.

9 (6) It is a bedrock American principle that the
10 United States Government is not built to grant
11 rights, but to protect rights inalienable to every
12 human being, and furthermore that the infringement
13 of such rights anywhere is unjust.

14 (7) Driven by its hostile communist ideology
15 and enabled by decades of foreign policy from the
16 United States and likeminded democracies which
17 disregarded this ideology, the CCP has risen to be-
18 come the United States prevailing economic and na-
19 tional security threat of this generation.

20 (8) The CCP's malign conduct, its threat to
21 American interests and values, and its fundamental
22 illegitimacy as a means of governing one-fifth of
23 mankind all ultimately derive from the CCP's hostile
24 communist ideology. As in the United States prior
25 great power competition with a communist super-

1 power, the United States goal should be the end of
2 the CCP's monopoly on power, rather than indefinite
3 coexistence with a fundamentally hostile communist
4 state.

5 (9) The theory that unprincipled economic en-
6 tanglement with the PRC's CCP-controlled economy
7 would induce economic and political liberalization
8 while contributing to United States interests has
9 been proven false. Decisive action is required to stop
10 the CCP from further exploiting the United States
11 economy, defend United States national security in-
12 terests, impose costs on the CCP's malign actions,
13 and uphold American values.
