Mr. Marshall (for himself, Mrs. Hyde-Smith, Ms. Lummis, and Mr. Wicker) introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

To prohibit the flying, draping, or other display of any flag other than the flag of the United States at covered public buildings, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "One Flag for All Act".
- 5 SEC. 2. PROHIBITION ON FLAGS OTHER THAN THE FLAG OF
- 6 THE UNITED STATES.
- 7 (a) Definitions.—In this section:
- 8 (1) Covered public building.—

| 15 | (2) FLAG OF THE UNITED STATES.—The term |

| 18 | Code. |
| 19 | (3) MILITARY INSTALLATION.—The term "mili- |
| 20 | tary installation" has the meaning given the term in |
| 21 | section 2801(c) of title 10, United States Code. |
| 22 | (b) Prohibitions.—Notwithstanding any other pro- |
| 23 | vision of law, and except as provided in subsection (c), |
| 24 | no flag that is not the flag of the United States may be |
| 25 | flown, draped, or otherwise displayed— |

| 22 | (5) any flag that represents a unit or branch of |

| (6) any flag of historical significance to the |

| United States, including the Betsy Ross flag, the |
| Gadsden flag, and the Bennington flag; |
| (7) any flag that represents public safety; |
| (8) any flag commemorating a special national |
| observance, including any 9/11 memorial, Remem- |
| brance Day, Veterans Day, or Memorial Day flag; |
| (9) in the case of a religious liturgy or cere- |
| mony at a military installation or facility, any flag |
| that represents a religious organization or church |
| that is described in section 501(c)(3) of the Internal |
| Revenue Code of 1986 and exempt from taxation |
| under section 501(a) of that Code; |
| (10) in the case of a Federal agency, any flag |
| that represents the Federal agency; |
| (11) any flag that represents an Indian Tribe |
| (as defined in section 4 of the Indian Self-Deter- |
| mination and Education Assistance Act (25 U.S.C. |
| 5304)); or |
| (12) any flag that represents the State, terri- |
| tory, county, city, or local jurisdiction in which the |
| |

covered public building is located.
