# **Interstate Occupational Therapy Licensure Compact**

FOR the purpose of entering into the Interstate Occupational Therapy Licensure Compact; stating the purpose of the Compact; requiring a state to meet certain requirements to participate in the Compact; establishing certain duties of member states; authorizing a certain state to charge a certain fee for granting a certain compact privilege; requiring certain occupational therapists or occupational therapy assistants to meet certain eligibility requirements to receive certain licensure and exercise a certain privilege; establishing certain authorizations and requirements regarding the practice of occupational therapists and occupational therapy assistants under a compact privilege; requiring a licensee who is active duty military or the spouse of an individual who is active duty military to designate certain locations as the home state under certain circumstances; establishing certain authority of home states and remote states with regard to certain adverse actions;

- 26 THE INTERSTATE OCCUPATIONAL THERAPY LICENSURE COMPACT IS
- 27 ENACTED INTO LAW AND ENTERED INTO WITH ALL OTHER STATES LEGALLY JOINING
- 28 IN IT IN THE FORM SUBSTANTIALLY AS IT APPEARS IN THIS SECTION AS FOLLOWS:
- 29 **SECTION 1. PURPOSE.**
- THE PURPOSE OF THIS COMPACT IS TO FACILITATE INTERSTATE PRACTICE
  OF OCCUPATIONAL THERAPY WITH THE GOAL OF IMPROVING PUBLIC ACCESS TO
  OCCUPATIONAL THERAPY SERVICES. THE PRACTICE OF OCCUPATIONAL THERAPY
  OCCURS IN THE STATE WHERE THE PATIENT/CLIENT IS LOCATED AT THE TIME OF
- 33 OCCURS IN THE STATE WHERE THE PATIENT/CLIENT IS LOCATED AT THE TIME OF
- 34 THE PATIENT/CLIENT ENCOUNTER. THE COMPACT PRESERVES THE REGULATORY
- 35 AUTHORITY OF STATES TO PROTECT PUBLIC HEALTH AND SAFETY THROUGH THE
- 36 CURRENT SYSTEM OF STATE LICENSURE. THE COMPACT IS DESIGNED TO ACHIEVE
- 37 THE FOLLOWING OBJECTIVES:

- 1 (1) INCREASE PUBLIC ACCESS TO OCCUPATIONAL THERAPY
- 2 SERVICES BY PROVIDING FOR THE MUTUAL RECOGNITION OF OTHER MEMBER
- 3 STATE LICENSES;
- 4 (2) ENHANCE THE STATES' ABILITY TO PROTECT THE PUBLIC'S 5 HEALTH AND SAFETY:
- 6 (3) ENCOURAGE THE COOPERATION OF MEMBER STATES IN 7 REGULATING MULTI-STATE OCCUPATIONAL THERAPY PRACTICE;
- 8 (4) SUPPORT SPOUSES OF RELOCATING MILITARY MEMBERS;
- 9 (5) ENHANCE THE EXCHANGE OF LICENSURE, INVESTIGATIVE, AND 10 DISCIPLINARY INFORMATION BETWEEN MEMBER STATES;
- 11 (6) ALLOW A REMOTE STATE TO HOLD A PROVIDER OF SERVICES
- 12 WITH A COMPACT PRIVILEGE IN THAT STATE ACCOUNTABLE TO THAT STATE'S
- 13 PRACTICE STANDARDS; AND
- 14 (7) FACILITATE THE USE OF TELEHEALTH TECHNOLOGY IN ORDER TO
- 15 INCREASE ACCESS TO OCCUPATIONAL THERAPY SERVICES.
- 16 SECTION 2. DEFINITIONS.
- AS USED IN THE COMPACT, AND EXCEPT AS OTHERWISE PROVIDED, THE
- 18 FOLLOWING DEFINITIONS SHALL APPLY:
- 19 (1) "ACTIVE DUTY MILITARY" MEANS FULL-TIME DUTY STATUS IN
- 20 THE ACTIVE UNIFORMED SERVICE OF THE UNITED STATES, INCLUDING MEMBERS
- 21 OF THE NATIONAL GUARD AND RESERVE ON ACTIVE DUTY ORDERS PURSUANT TO
- 22 10 U.S.C. CHAPTER 1209 AND SECTION 1211.
- 23 (2) "ADVERSE ACTION" MEANS ANY ADMINISTRATIVE, CIVIL,
- 24 EQUITABLE, OR CRIMINAL ACTION PERMITTED BY A STATE'S LAWS THAT IS IMPOSED
- 25 BY A LICENSING BOARD OR OTHER AUTHORITY AGAINST AN OCCUPATIONAL
- 26 THERAPIST OR OCCUPATIONAL THERAPY ASSISTANT, INCLUDING ACTIONS AGAINST
- 27 AN INDIVIDUAL'S LICENSE OR COMPACT PRIVILEGE SUCH AS CENSURE,
- 28 REVOCATION, SUSPENSION, PROBATION, MONITORING OF THE LICENSEE, OR
- 29 RESTRICTION ON THE LICENSEE'S PRACTICE.
- 30 (3) "ALTERNATIVE PROGRAM" MEANS A NON-DISCIPLINARY
- 31 MONITORING PROCESS APPROVED BY AN OCCUPATIONAL THERAPY LICENSING
- 32 BOARD.

- 1 (4) "COMPACT PRIVILEGE" MEANS THE AUTHORIZATION, THAT IS
- 2 EQUIVALENT TO A LICENSE, GRANTED BY A REMOTE STATE TO ALLOW A LICENSEE
- 3 FROM ANOTHER MEMBER STATE TO PRACTICE AS AN OCCUPATIONAL THERAPIST OR
- 4 PRACTICE AS AN OCCUPATIONAL THERAPY ASSISTANT IN THE REMOTE STATE
- 5 UNDER ITS LAWS AND RULES. THE PRACTICE OF OCCUPATIONAL THERAPY OCCURS
- 6 IN THE MEMBER STATE WHERE THE PATIENT/CLIENT IS LOCATED AT THE TIME OF
- 7 THE PATIENT/CLIENT ENCOUNTER.
- 8 (5) "CONTINUING COMPETENCE/EDUCATION" MEANS A
- 9 REQUIREMENT, AS A CONDITION OF LICENSE RENEWAL, TO PROVIDE EVIDENCE OF
- 10 PARTICIPATION IN, AND/OR COMPLETION OF, EDUCATIONAL AND PROFESSIONAL
- 11 ACTIVITIES RELEVANT TO PRACTICE OR AREA OF WORK.
- 12 (6) "CURRENT SIGNIFICANT INVESTIGATIVE INFORMATION" MEANS
- 13 INVESTIGATIVE INFORMATION THAT A LICENSING BOARD, AFTER AN INQUIRY OR
- 14 INVESTIGATION THAT INCLUDES NOTIFICATION AND AN OPPORTUNITY FOR THE
- 15 OCCUPATIONAL THERAPIST OR OCCUPATIONAL THERAPY ASSISTANT TO RESPOND,
- 16 IF REQUIRED BY STATE LAW, HAS REASON TO BELIEVE IS NOT GROUNDLESS AND, IF
- 17 PROVED TRUE, WOULD INDICATE MORE THAN A MINOR INFRACTION.
- 18 (7) "DATA SYSTEM" MEANS A REPOSITORY OF INFORMATION ABOUT
- 19 LICENSEES ESTABLISHED IN ACCORDANCE WITH SECTION 9 THAT INCLUDES, BUT IS
- 20 NOT LIMITED TO, LICENSE STATUS, INVESTIGATIVE INFORMATION, COMPACT
- 21 PRIVILEGES, AND ADVERSE ACTIONS.
- 22 (8) "ENCUMBERED LICENSE" MEANS A LICENSE WITH RESPECT TO
- 23 WHICH AN ADVERSE ACTION RESTRICTS THE PRACTICE OF OCCUPATIONAL
- 24 THERAPY BY THE LICENSEE OR SAID ADVERSE ACTION HAS BEEN REPORTED TO THE
- 25 NATIONAL PRACTITIONERS DATA BANK.
- 26 (9) "EXECUTIVE COMMITTEE" MEANS A GROUP OF DIRECTORS
- 27 ELECTED OR APPOINTED TO ACT ON BEHALF OF, AND WITHIN THE POWERS
- 28 GRANTED TO THEM BY, THE COMMISSION.
- 29 (10) "HOME STATE" MEANS THE MEMBER STATE THAT IS THE
- 30 LICENSEE'S PRIMARY STATE OF RESIDENCE.
- 31 (11) "IMPAIRED PRACTITIONER" MEANS AN INDIVIDUAL WHOSE
- 32 PROFESSIONAL PRACTICE IS ADVERSELY AFFECTED BY SUBSTANCE ABUSE,
- 33 ADDICTION, OR OTHER HEALTH-RELATED CONDITIONS.
- 34 (12) "INVESTIGATIVE INFORMATION" MEANS INFORMATION,
- 35 RECORDS, AND/OR DOCUMENTS RECEIVED OR GENERATED BY AN OCCUPATIONAL
- 36 THERAPY LICENSING BOARD PURSUANT TO AN INVESTIGATION.

- 1 (13) "JURISPRUDENCE REQUIREMENT" MEANS THE ASSESSMENT OF
- 2 AN INDIVIDUAL'S KNOWLEDGE OF THE LAWS AND RULES GOVERNING THE PRACTICE
- 3 OF OCCUPATIONAL THERAPY IN A STATE.
- 4 (14) "LICENSEE" MEANS AN INDIVIDUAL WHO CURRENTLY HOLDS AN
- 5 AUTHORIZATION FROM A STATE TO PRACTICE AS AN OCCUPATIONAL THERAPIST OR
- 6 AS AN OCCUPATIONAL THERAPY ASSISTANT.
- 7 (15) "MEMBER STATE" MEANS A STATE THAT HAS ENACTED THE
- 8 COMPACT.
- 9 (16) "OCCUPATIONAL THERAPIST" MEANS AN INDIVIDUAL WHO IS
- 10 LICENSED BY A STATE TO PRACTICE OCCUPATIONAL THERAPY.
- 11 (17) "OCCUPATIONAL THERAPY," "OCCUPATIONAL THERAPY
- 12 PRACTICE," AND THE "PRACTICE OF OCCUPATIONAL THERAPY" MEAN THE CARE
- 13 AND SERVICES PROVIDED BY AN OCCUPATIONAL THERAPIST OR AN OCCUPATIONAL
- 14 THERAPY ASSISTANT AS SET FORTH IN THE MEMBER STATE'S STATUTES AND
- 15 REGULATIONS.
- 16 (18) "Occupational therapy assistant" means an individual
- 17 WHO IS LICENSED BY A STATE TO ASSIST IN THE PRACTICE OF OCCUPATIONAL

- 19 (19) "OCCUPATIONAL THERAPY COMPACT COMMISSION" OR
- 20 "COMMISSION" MEANS THE NATIONAL ADMINISTRATIVE BODY WHOSE MEMBERSHIP
- 21 CONSISTS OF ALL STATES THAT HAVE ENACTED THE COMPACT.
- 22 (20) "OCCUPATIONAL THERAPY LICENSING BOARD" OR "LICENSING
- 23 BOARD" MEANS THE AGENCY OF A STATE THAT IS AUTHORIZED TO LICENSE AND

21	SECTION 3. STATE PARTICIPATION IN THE COMPACT.
22	(A) TO PARTICIPATE IN THE COMPACT, A MEMBER STATE MUST:
23 $24$	(1) LICENSE OCCUPATIONAL THERAPISTS AND OCCUPATIONAL THERAPY ASSISTANTS;

- 14 (A) TO EXERCISE THE COMPACT PRIVILEGE UNDER THE TERMS AND 15 PROVISIONS OF THE COMPACT, A LICENSEE MUST:
- 16 (1) HOLD A LICENSE IN THE HOME STATE;
- 17 (2) HAVE A VALID UNITED STATES SOCIAL SECURITY NUMBER OR
- 18 NATIONAL PRACTITIONER IDENTIFICATION NUMBER;
- 19 (3) HAVE NO ENCUMBRANCE ON ANY STATE LICENSE;
- 20 (4) BE ELIGIBLE FOR A COMPACT PRIVILEGE IN ANY MEMBER STATE
- 21 IN ACCORDANCE WITH SUBSECTIONS (E) THROUGH (J) (D), (F), (G), AND (H) OF THIS

- 23 (5) HAVE PAID ALL FINES AND COMPLETED ALL REQUIREMENTS

- 25 PRIVILEGE, AND TWO YEARS HAVE ELAPSED FROM THE DATE OF SUCH COMPLETION;

- 28 (7) PAY ANY APPLICABLE FEES, INCLUDING ANY STATE FEE, FOR THE
- 29 COMPACT PRIVILEGE;

- 1 (8) COMPLETE A CRIMINAL BACKGROUND CHECK IN ACCORDANCE 2 WITH SUBSECTION (B) OF SECTION 3 AND PAY ANY FEE ASSOCIATED WITH THE 3 COMPLETION OF THE CRIMINAL BACKGROUND CHECK;
- 4 (9) MEET ANY JURISPRUDENCE REQUIREMENTS ESTABLISHED BY 5 THE REMOTE STATE(S) IN WHICH THE LICENSEE IS SEEKING A COMPACT PRIVILEGE; 6 AND
- 7 (10) REPORT TO THE COMMISSION ADVERSE ACTION TAKEN BY ANY 8 NON-MEMBER STATE WITHIN 30 DAYS FROM THE DATE THE ADVERSE ACTION IS 9 TAKEN.
- 10 **(B)** THE COMPACT PRIVILEGE IS VALID UNTIL THE EXPIRATION DATE OF 11 THE HOME STATE LICENSE. THE LICENSEE MUST COMPLY WITH THE 12 REQUIREMENTS OF SUBSECTION (A) OF THIS SECTION TO MAINTAIN THE COMPACT 13 PRIVILEGE IN THE REMOTE STATE.
- 14 (C) A LICENSEE PROVIDING OCCUPATIONAL THERAPY IN A REMOTE STATE
  15 UNDER THE COMPACT PRIVILEGE SHALL FUNCTION WITHIN THE LAWS AND
  16 REGULATIONS OF THE REMOTE STATE.
- 17 **(D)** OCCUPATIONAL THERAPY ASSISTANTS PRACTICING IN A REMOTE STATE 18 SHALL BE SUPERVISED BY AN OCCUPATIONAL THERAPIST LICENSED OR HOLDING A 19 COMPACT PRIVILEGE IN THAT REMOTE STATE.
- 20 A LICENSEE PROVIDING OCCUPATIONAL THERAPY IN A REMOTE STATE IS SUBJECT TO THAT STATE'S REGULATORY AUTHORITY. - 15 (3) THE FORMER HOME STATE SHALL CONVERT THE FORMER HOME
- 16 STATE LICENSE INTO A COMPACT PRIVILEGE ONCE THE NEW HOME STATE HAS
- 17 ACTIVATED THE NEW HOME STATE LICENSE IN ACCORDANCE WITH APPLICABLE

- 15 SECTION 11. OVERSIGHT, DISPUTE RESOLUTION, AND 16 ENFORCEMENT.
- (A) (1) THE EXECUTIVE, LEGISLATIVE, AND JUDICIAL BRANCHES OF STATE GOVERNMENT IN EACH MEMBER STATE SHALL ENFORCE THE COMPACT AND TAKE ALL ACTIONS NECESSARY AND APPROPRIATE TO EFFECTUATE THE COMPACT'S PURPOSES AND INTENT. THE PROVISIONS OF THE COMPACT AND THE RULES PROMULGATED HEREUNDER SHALL HAVE STANDING AS STATUTORY LAW.

- 16 (A) THE COMPACT SHALL COME INTO EFFECT ON THE DATE ON WHICH THE

- 3 OR OTHER COOPERATIVE ARRANGEMENT BETWEEN A MEMBER STATE AND A
- 4 NON-MEMBER STATE THAT DOES NOT CONFLICT WITH THE PROVISIONS OF THE
- 5 COMPACT.
- 6 (E) THE COMPACT MAY BE AMENDED BY THE MEMBER STATES. NO
- 7 AMENDMENT TO THE COMPACT SHALL BECOME EFFECTIVE AND BINDING UPON ANY
- 8 MEMBER STATE UNTIL IT IS ENACTED INTO THE LAWS OF ALL MEMBER STATES.

### 9 SECTION 13. CONSTRUCTION AND SEVERABILITY.

- THE COMPACT SHALL BE LIBERALLY CONSTRUED SO AS TO EFFECTUATE THE
- 11 PURPOSES THEREOF. THE PROVISIONS OF THE COMPACT SHALL BE SEVERABLE
- 12 AND IF ANY PHRASE, CLAUSE, SENTENCE OR PROVISION OF THIS COMPACT IS

- 18 THEREBY. IF THE COMPACT IS CONTRARY TO THE CONSTITUTION OF ANY MEMBER
- 19 STATE, THE COMPACT SHALL REMAIN IN FULL FORCE AND EFFECT AS TO THE
- 20 REMAINING MEMBER STATES AND IN FULL FORCE AND EFFECT AS TO THE MEMBER
- 21 STATE AFFECTED AS TO ALL SEVERABLE MATTERS.

#### 22 SECTION 14. BINDING EFFECT OF COMPACT AND OTHER LAWS.

- 27 OF A MEMBER STATE THAT IS NOT INCONSISTENT WITH THE COMPACT.
- 28 (C) ANY LAWS IN A MEMBER STATE IN CONFLICT WITH THE COMPACT ARE
- 29 SUPERSEDED TO THE EXTENT OF THE CONFLICT.
- 30 (D) ANY LAWFUL ACTIONS OF THE COMMISSION, INCLUDING ALL RULES
- 31 AND BYLAWS PROMULGATED BY THE COMMISSION, ARE BINDING UPON THE
- 32 MEMBER STATES.
- 33 (E) ALL AGREEMENTS BETWEEN THE COMMISSION AND THE MEMBER
- 34 STATES ARE BINDING IN ACCORDANCE WITH THEIR TERMS.

1 2 3 4	(F) IN THE EVENT ANY PROVISION OF THE COMPACT EXCEEDS THE CONSTITUTIONAL LIMITS IMPOSED ON THE LEGISLATURE OF ANY MEMBER STATE, THE PROVISION SHALL BE INEFFECTIVE TO THE EXTENT OF THE CONFLICT WITH THE CONSTITUTIONAL PROVISION IN QUESTION IN THAT MEMBER STATE.
