A BILL

To amend the Homeland Security Act of 2002 to ensure that the needs of children are considered in homeland security planning, and for other purposes.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Homeland Security for
5	Children Act".
6	SEC. 2. RESPONSIBILITIES OF THE UNDER SECRETARY FOR
7	STRATEGY, POLICY, AND PLANS.
8	Paragraph (6) of section 709(c) of the Homeland Secu-
9	rity Act of 2002 (6 U.S.C. 349(c)) is amended by inserting
10	", including feedback from organizations representing the
11	needs of children," after "stakeholder feedback".
12	SEC. 3. TECHNICAL EXPERT AUTHORIZED.
13	Paragraph (2) of section 503(b) of the Homeland Secu-
14	rity Act of 2002 (6 U.S.C. 313(b)) is amended—
15	(1) in subparagraph (G), by striking "and" at
16	$the\ end;$
17	(2) in subparagraph (H), by striking the period
18	at the end and inserting "; and"; and
19	(3) by adding at the end the following new sub-
20	paragraph:
21	"(I) identify and integrate the needs of chil-
22	dren into activities to prepare for, protect
23	against, respond to, recover from, and mitigate
24	against the risk of natural disasters, acts of ter-
25	rorism, and other manmade disasters, including

catastrophic incidents, including by appointing
a technical expert, who may consult with relevant outside organizations and experts, as necessary, to coordinate such integration, as necessary.".

6 SEC. 4. REPORT.

- 7 Not later than one year after the date of the enactment 8 of this Act and annually thereafter for five years, the Under Secretary for Strategy, Policy, and Plans of the Department of Homeland Security shall submit to the Committee 10 on Homeland Security of the House of Representatives and 12 the Committee on Homeland Security and Governmental Affairs of the Senate a report describing the efforts the Department has undertaken to review and incorporate feedback from organizations representing the needs of children into Department policy in accordance with paragraph (6) 16 of section 709(c) of the Homeland Security Act of 2002 (as added by section 2 of this Act), including information on 18 19 the following:
- 20 (1) The designation of any individual respon-21 sible for carrying out such paragraph (6).
- 22 (2) Any review, formal or informal, of Depart-23 ment policies, programs, or activities to assess the 24 suitability of such policies, programs, or activities for 25 children and where feedback from organizations rep-

- resenting the needs of children should be reviewed and 1 2 incorporated.
 - (3) Any review, change, modification, or promulgation of Department policies, programs, or activities to ensure that such policies, programs, or activities are appropriate for children.
- (4) Coordination with organizations or experts outside the Department pursuant to such paragraph 8 (6) conducted to inform any such review, change, 10 modification, or promulgation of such policies, programs, or activities.
