- 1 FOR AN ACT ENTITLED, An Act to establish the Government Accountability Task Force to
- 2 study government, campaign finance, lobbyist restrictions, and ethics and to declare an
- 3 emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 5 Section 1. That the code be amended by adding a NEW SECTION to read:
- There is hereby established the Government Accountability Task Force to examine the
- 7 issues of government accountability, campaign finance, lobbyist restrictions, and ethics; to
- 8 review current statutory protections and recent legislative changes; and to propose potential
- 9 legislation to the Ninety-third Legislature. The task force shall consist of the following
- 10 members:
- 11 (1) The president pro tempore of the Senate shall appoint two members of the Senate;
- 12 (2) The speaker of the House of Representatives shall appoint two members of the House
- of Representatives;

- 1 (3) The minority leader of the Senate shall appoint two members of the Senate;
- 2 (4) The minority leader of the House of Representatives shall appoint two members of
- 3 the House of Representatives;
- 4 (5) The auditor general shall appoint one member;
- 5 (6) The Governor shall appoint one member;
- 6 (7) The secretary of state shall appoint one member who has significant experience
- 7 related to working with campaign finance; and
- 8 (8) The attorney general shall appoint two members.
- Each member shall be a registered voter of the state as of November 8, 2016, and shall
- 10 currently reside in the state.
- 11 Section 2. That the code be amended by adding a NEW SECTION to read:
- The initial appointments shall be made no later than May 1, 2017. Each appointee shall
- serve until December 31, 2017. If there is a vacancy on the task force, the vacancy shall be filled
- in the same manner as the original appointment.
- 15 Section 3. That the code be amended by adding a NEW SECTION to read:
- The task force shall be under the supervision of the Executive Board of the Legislative
- 17 Research Council and staffed and funded as an interim legislative committee. The Executive
- 18 Board shall designate the chair and vice chair of the task force.
- 19 Section 4. Expenses incurred by the task force authorize pursuant to this Act shall be paid
- 20 from the legislative priority pilot program contingency fund.
- Section 5. This Act is repealed on December 31, 2017.
- Section 6. Whereas, this Act is necessary for the support of the state government and its
- 23 existing public institutions, an emergency is hereby declared to exist, and this Act shall be in
- 24 full force and effect from and after its passage and approval.
