A BILL

To prohibit the use of Federal funds for certain purposes
within the District of Columbia.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. PROHIBITIONS ON FEDERAL FUNDS FOR CER-**
2 **TAIN PURPOSES WITHIN THE DISTRICT OF**
3 **COLUMBIA.**

4 (a) NATIONAL GUARD.—No Federal funds may be
5 used after the day that is 15 days after the date of the
6 enactment of this Act to support the mission of the Na-
7 tional Guard in the District of Columbia in response to
8 the attacks on the United States Capitol Buildings and
9 Grounds (as defined and described in sections 5101 and
10 5102 of title 40, United States Code) on January 6, 2021.

11 (b) FENCING.—No Federal funds may be used to in-
12 stall permanent fencing around—

13 (1) the perimeter of any of the Capitol Build-
14 ings described in section 5101 of title 40, United
15 States Code; or

16 (2) the perimeter of the United States Capitol
17 Grounds, or any portion thereof, described in section
18 5102 of such title.
