A BILL

To conduct a global aviation security review, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Global Aviation System*
5 *Security Reform Act of 2017”.*

6 **SEC. 2. DEFINITIONS.**

7 *In this Act:*

8 (1) *ADMINISTRATION.*—*The term “Administra-*
9 *tion” means the Transportation Security Administra-*
10 *tion.*

11 (2) *ADMINISTRATOR.*—*The term “Adminis-*
12 *trator” means the Administrator of the Transpor-*
13 *tation Security Administration.*

14 (3) *APPROPRIATE CONGRESSIONAL COMMIT-*
15 *TEES.*—*The term “appropriate congressional commit-*
16 *tees” means the Committee on Homeland Security of*
17 *the House of Representatives and the Committee on*
18 *Commerce, Science, and Transportation and the Com-*
19 *mittee on Homeland Security and Governmental Af-*
20 *fairs of the Senate.*

21 **SEC. 3. GLOBAL AVIATION SECURITY REVIEW.**

22 (a) *IN GENERAL.*—*Not later than 180 days after the*
23 *date of the enactment of this Act, the Administrator shall*
24 *conduct a global aviation security review to address im-*
25 *proving aviation security standards, including standards*

1 *intended to mitigate cybersecurity threats, across the global*
2 *aviation system.*

3 (b) *COMPOSITION.—The global aviation security re-*
4 *view established under subsection (a) shall include input*
5 *from the following entities:*

6 (1) *The Office of Global Strategies of the Admin-*
7 *istration.*

8 (2) *The Office of Intelligence and Analysis of the*
9 *Administration.*

10 (3) *The Office of Security Policy and Industry*
11 *Engagement of the Administration.*

12 (c) *COORDINATION.—The Administrator shall coordi-*
13 *nate with the following entities on the global aviation secu-*
14 *rity review:*

15 (1) *U.S. Customs and Border Protection.*

16 (2) *The Office of International Engagement of*
17 *the Department of Homeland Security.*

18 (3) *The Department of State.*

19 (4) *Any other relevant office or agency of the*
20 *Federal government, as determined by the Adminis-*
21 *trator.*

22 (d) *BEST PRACTICES.—The global aviation security*
23 *review shall establish best practices regarding the following:*

1 (1) *Collaborating with foreign partners to im-*
2 *prove global aviation security capabilities and stand-*
3 *ards.*

4 (2) *Identifying foreign partners that have not*
5 *successfully implemented security protocols from the*
6 *International Civil Aviation Organization or the De-*
7 *partment of Homeland Security and have not taken*
8 *steps to implement such security protocols.*

9 (3) *Improving the development, outreach, and*
10 *implementation process for security directives or*
11 *emergency amendments, as the case may be, issued to*
12 *domestic and foreign air carriers.*

13 (4) *Assessing the cybersecurity and cyber espio-*
14 *nage risk of security screening equipment.*

15 **SEC. 4. REPORT TO CONGRESS.**

16 (a) *PROGRESS REPORT.*—*Not later than 90 days after*
17 *the date of the enactment of this Act, the Administrator*
18 *shall report to the appropriate congressional committees on*
19 *the organization, development, and progress of the global*
20 *aviation security review required under section 3.*

21 (b) *FINAL REPORT.*—*Not later than 240 days after the*
22 *date of the enactment of this Act, the Administrator shall*
23 *submit to the appropriate congressional committees a report*
24 *on best practices identified by the global aviation security*

- 1 *review required under section 3 and the actions the Admin-*
- 2 *istrator has taken to implement such best practices.*
