# A BILL

To direct the Secretary of Veterans Affairs to carry out a pilot program to improve the ability of Members of Congress to assist constituents with respect to benefits for veterans.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Phoenix VA Congres-
- 5 sional Oversight Act".

#### 1 SEC. 2. PILOT PROGRAM TO IMPROVE CONSTITUENT SERV-

- 2 ICES.
- 3 (a) PILOT PROGRAM.—The Secretary of Veterans Af-
- 4 fairs shall carry out a pilot program to improve the ability
- 5 of Members of Congress to assist constituents pursuant
- 6 to subsections (b) and (c).
- 7 (b) Congressional Relations Team.—In carrying
- 8 out the pilot program under subsection (a), the Secretary
- 9 shall establish a dedicated congressional relations team at
- 10 the location specified in subsection (d). Such team shall
- 11 consist of employees of the Department of Veterans Af-
- 12 fairs whose only duties relate to assisting Members and
- 13 committees of Congress with respect to casework issues
- 14 at each health care system of the Department in such loca-
- 15 tion.
- 16 (c) Use of Space.—Upon request of any Member
- 17 of Congress from the State of the location specified in sub-
- 18 section (d), the Secretary shall authorize the Member to
- 19 use a facility of the Department at such location for the
- 20 purposes of meeting with constituents of the Member.
- 21 (d) LOCATION.—The Secretary shall carry out the
- 22 pilot program in Arizona, including at the Phoenix health
- 23 care system of the Department.
- (e) Report.—Not later than two years after the date
- 25 of the enactment of this Act, the Secretary shall submit
- 26 to the Committees on Veterans' Affairs of the House of

- 1 Representatives and the Senate a report on the pilot pro-
- 2 gram under subsection (a), including whether the Sec-

3 retary recommends expanding such pilot program.
