A BILL

To require the Director of National Intelligence to declassify information relating to the origin of COVID-19, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "COVID-19 Origin Act
- 5 of 2021".

1 SEC. 2. FINDINGS.

| 4 | sheet on January 15, 2021, about the Wuhan Insti- |
| 5 | tute of Virology (WIV) which stated the following: |
| 6 | (A) "The U.S. government has reason to |

| 8 | became sick in autumn 2019, before the first |
| 9 | identified case of the outbreak, with symptoms |
| 10 | consistent with both COVID-19 and common |
| 11 | seasonal illnesses.". |
| 12 | (B) "WIV researchers conducted experi- |
| 13 | ments involving RaTG13, the bat coronavirus |
| 14 | identified by the WIV in January 2020 as its |
| 15 | closest sample to SARS-CoV-2.". |
| 16 | (C) "Despite the WIV presenting itself as |
| 17 | a civilian institution, the United States has de- |
| 18 | termined that the WIV has collaborated on pub- |
| 19 | lications and secret projects with China's mili- |
| 20 | tary.". |
| 21 | (2) Former Director of the Centers for Disease |
| 22 | Control and Prevention, Robert Redfield, stated in |
| 23 | March 2021 that, "the most likely etiology of this |
| 24 | pathogen in Wuhan was from a laboratory" and |

noted that, "[i]t is not unusual for respiratory

| 7 | tory and said this hypothesis "requires further inves- |
| 8 | tigation, potentially with additional missions involve |
| 9 | ing specialist experts.". |
| 10 | SEC. 3. SENSE OF CONGRESS. |
| 11 | It is the sense of Congress that— |
| 12 | (1) identifying the origin of Coronavirus Dis- |
| 13 | ease 2019 (COVID-19) is critical for preventing a |
| 14 | similar pandemic from occurring in the future; |
| 15 | (2) there is reason to believe the COVID-19 |
| 16 | pandemic may have originated at the Wuhan Insti- |
| 17 | tute of Virology; and |
| 18 | (3) the Director of National Intelligence should |
| 19 | declassify and make available to the public as much |
| 20 | information as possible about the origin of COVID- |
| 21 | 19 so the United States and like-minded countries |
| 22 | can— |
| 23 | (A) identify the origin of COVID-19 as ex- |
| 24 | peditiously as possible, and |

| 4 | SEC. 4. DECLASSIFICATION OF INFORMATION RELATED TO |
| 5 | THE ORIGIN OF COVID-19. |
| 6 | Not later than 90 days after the date of the enact- |
| 7 | ment of this Act, the Director of National Intelligence |
| 8 | shall— |
| 9 | (1) declassify any and all information relating |
| 10 | to potential links between the Wuhan Institute of Vi- |
| 11 | rology and the origin of the Coronavirus Disease |
| 12 | 2019 (COVID-19), including— |
| 13 | (A) activities performed by the Wuhan In- |
| 14 | stitute of Virology with or on behalf of the Peo- |
| 15 | ple's Liberation Army; |
| 16 | (B) coronavirus research or other related |
| 17 | activities performed at the Wuhan Institute of |
| 18 | Virology prior to the outbreak of COVID-19; |
| 19 | and |
| 20 | (C) researchers at the Wuhan Institute of |
| 21 | Virology who fell ill in autumn 2019, including |
| 22 | for any such researcher— |
| 23 | (i) the researcher's name; |
| 24 | (ii) the researcher's symptoms; |

| 1 | (iii) the date of the onset of the re- |

| 3 | (iv) the researcher's role at the |
| 4 | Wuhan Institute of Virology; |
| 5 | (v) whether the researcher was in- |
| 6 | volved with or exposed to coronavirus re- |
| 7 | search at the Wuhan Institute of Virology; |
| 8 | (vi) whether the researcher visited a |
| 9 | hospital while they were ill; and |
| 10 | (vii) a description of any other actions |
| 11 | taken by the researcher that may suggest |
| 12 | they were experiencing a serious illness at |
| 13 | the time; and |
| 14 | (2) submit to Congress an unclassified report |
| 15 | that contains— |
| 16 | (A) all of the information described under |
| 17 | paragraph (1); and |
| 18 | (B) only such redactions as the Director |
| 19 | determines necessary to protect sources and |
| 20 | methods without altering or obscuring in any |
| 21 | way the information described under paragraph |
| 22 | (1). |
