A BILL ENTITLED

1 AN ACT concerning

2 **Public Safety – Missing Persons With Cognitive Impairment – Purple Alert**
3 **Program**

4 FOR the purpose of establishing a Purple Alert Program to disseminate information to
5 assist in locating a certain missing person with certain cognitive impairments; and
6 generally relating to the establishment of a Purple Alert Program.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Public Safety**

15 **3–608.**

16 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
17 **INDICATED.**

18 **(2) “CAREGIVER” MEANS A PARENT, SPOUSE, GUARDIAN, LEGAL**
19 **CUSTODIAN, OR PERSON RESPONSIBLE FOR THE SUPERVISION OF ANOTHER ADULT.**

20 **(3) “DEVELOPMENTAL DISABILITY” HAS THE MEANING STATED IN §**
21 **7–101(G) OF THE HEALTH – GENERAL ARTICLE.**

22 **(4) “INTELLECTUAL DISABILITY” HAS THE MEANING STATED IN §**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **7-101(N) OF THE HEALTH – GENERAL ARTICLE.**

2 **(5) “LAW ENFORCEMENT AGENCY” MEANS A STATE, COUNTY, OR**
3 **MUNICIPAL POLICE DEPARTMENT OR AGENCY OR A SHERIFF’S DEPARTMENT.**

4 **(6) “MISSING PERSON” MEANS AN INDIVIDUAL:**

5 **(I) WHOSE WHEREABOUTS ARE UNKNOWN;**

6 **(II) WHO SUFFERS A COGNITIVE IMPAIRMENT, INTELLECTUAL**
7 **OR DEVELOPMENTAL DISABILITY, OR BRAIN INJURY THAT IS NOT:**

8 **1. ALZHEIMER’S DISEASE;**

9 **2. DEMENTIA; OR**

10 **3. A PHYSICAL, MENTAL, OR EMOTIONAL DISABILITY**
11 **RELATED TO SUBSTANCE ABUSE;**

12 **(III) WHOSE DISAPPEARANCE POSES A CREDIBLE THREAT TO**
13 **THE HEALTH AND SAFETY OF THE INDIVIDUAL DUE TO AGE, HEALTH, MENTAL OR**
14 **PHYSICAL DISABILITY, ENVIRONMENT, OR WEATHER CONDITIONS, AS DETERMINED**
15 **BY A LAW ENFORCEMENT AGENCY; AND**

16 **(IV) WHO DOES NOT MEET THE CRITERIA FOR ACTIVATION OF A**
17 **SILVER ALERT UNDER § 3-604 OF THIS SUBTITLE.**

18 **(B) (1) THE DEPARTMENT OF STATE POLICE SHALL ESTABLISH A**
19 **PURPLE ALERT PROGRAM TO PROVIDE A SYSTEM FOR RAPID DISSEMINATION OF**
20 **INFORMATION TO ASSIST IN LOCATING A MISSING PERSON.**

21 **(2) THE DEPARTMENT OF STATE POLICE SHALL:**

22 **(I) ADOPT GUIDELINES AND DEVELOP PROCEDURES FOR**
23 **ISSUING A PURPLE ALERT FOR A MISSING PERSON;**

24 **(II) PROVIDE TRAINING TO LOCAL LAW ENFORCEMENT**
25 **AGENCIES ON THE GUIDELINES AND PROCEDURES TO BE USED TO HANDLE A**
26 **REPORT OF A MISSING PERSON;**

27 **(III) PROVIDE ASSISTANCE TO A LOCAL LAW ENFORCEMENT**
28 **AGENCY, AS NECESSARY, TO ASSIST IN THE SAFE RECOVERY OF A MISSING PERSON;**

1 **(IV) RECRUIT PUBLIC AND COMMERCIAL TELEVISION AND**
2 **RADIO BROADCASTERS, LOCAL VOLUNTEER GROUPS, AND OTHER MEMBERS OF THE**
3 **PUBLIC TO ASSIST IN DEVELOPING AND IMPLEMENTING A PURPLE ALERT;**

4 **(V) CONSULT WITH THE STATE HIGHWAY ADMINISTRATION TO**
5 **ESTABLISH A PLAN FOR PROVIDING INFORMATION RELEVANT TO A PURPLE ALERT**
6 **TO THE PUBLIC THROUGH THE DYNAMIC MESSAGE SIGN SYSTEM LOCATED ACROSS**
7 **THE STATE; AND**

8 **(VI) CONSULT WITH THE STATE DEPARTMENT OF EDUCATION**
9 **TO DEVELOP A PROGRAM THAT:**

10 **1. ALLOWS HIGH SCHOOL STUDENTS TO ASSIST IN THE**
11 **SEARCH FOR A MISSING PERSON UNDER THIS SECTION;**

12 **2. COMPLIES WITH COMAR 13A.03.02.06; AND**

13 **3. IS CONSISTENT WITH THE STUDENT**
14 **SERVICE-LEARNING GUIDELINES DEVELOPED BY THE STATE DEPARTMENT OF**
15 **EDUCATION.**

16 **(C) A CAREGIVER OR PERSON FILING A REPORT REGARDING A MISSING**
17 **PERSON IMMEDIATELY SHALL NOTIFY THE LOCAL LAW ENFORCEMENT AGENCY**
18 **WITH WHICH THE REPORT WAS FILED AND THE DEPARTMENT OF STATE POLICE IF:**

19 **(1) THE MISSING PERSON WHO WAS THE SUBJECT OF THE REPORT IS**
20 **LOCATED; AND**

21 **(2) IT IS UNLIKELY THAT THE LOCAL LAW ENFORCEMENT AGENCY OR**
22 **THE DEPARTMENT OF STATE POLICE HAS KNOWLEDGE THAT THE MISSING PERSON**
23 **HAS BEEN LOCATED.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
25 October 1, 2024.
