Mr. Huffman introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

- To take certain Federal lands located in Siskiyou County, California, and Humboldt County, California, into trust for the benefit of the Karuk Tribe, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Katimiîn and
 - 5 Ameekyáaraam Sacred Lands Act".
 - 6 SEC. 2. LAND HELD IN TRUST FOR THE KARUK TRIBE.
 - 7 (a) In General.—In recognition of the historical use
 - 8 and ongoing relationship between the Karuk Tribe and the

- 1 Katimiîn and Ameekyáaraam tracts of land in the ances-
- 2 tral territory of the Karuk Tribe, administrative jurisdic-
- 3 tion of these tracts of land are hereby transferred from
- 4 the Secretary of Agriculture to the Secretary of the Inte-
- 5 rior and held in trust for the benefit of the Karuk Tribe,
- 6 subject to valid existing rights.
- 7 (b) Land Description.—The land taken into trust
- 8 pursuant to subsection (a) is the approximately 1,031
- 9 acres of Federal land located in Siskiyou County, Cali-
- 10 fornia, and Humboldt County, California, and generally
- 11 depicted as "Proposed Area" on the map titled "Katimiin
- 12 AreaBoundary Proposal" and dated 08–09–2021, includ-
- 13 ing improvements and appurtenances thereto.
- 14 (c) Survey.—Not later than 180 days after the date
- 15 of the enactment of this Act, the Secretary of the Interior
- 16 shall complete a survey of the land taken into trust under
- 17 subsection (a).
- 18 (d) Use of Land.—
- 19 (1) IN GENERAL.—Land taken into trust under
- subsection (a) shall be used only for traditional and
- 21 customary uses for the benefit of the Karuk Tribe.
- 22 (2) Gaming.—Class II and class III gaming
- under the Indian Gaming Regulatory Act (25 U.S.C.
- 24 2701 et seq.) shall not be allowed on the land taken
- into trust under subsection (a).

- 1 (e) WILD AND SCENIC RIVERS MANAGEMENT.—The
- 2 fact that the land described in subsection (b) is held in
- 3 trust for the benefit of the Karuk Tribe shall not affect
- 4 the status or administration of any component of the na-
- 5 tional wild and scenic rivers system, including components
- 6 located on such land.
