# A BILL

To amend the Endangered Species Act of 1973 to prohibit import and export of any species listed or proposed to be listed under such Act as a threatened species or endangered species, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Conserving Ecosystems
- 5 by Ceasing the Importation of Large Animal Trophies Act"
- 6 or the "CECIL Act".

# 7 SEC. 2. AMENDMENT TO PROHIBITED ACTS.

- 8 Section 9(a) of the Endangered Species Act of 1973
- 9 (16 U.S.C. 1538(a)) is amended by adding at the end the
- 10 following:
- 11 "(3) Except as provided in section 10 of this Act, it
- 12 is unlawful for any person to import into or export from
- 13 the United States any sport-hunted trophy of a species list-
- 14 ed or proposed to be listed under section 4(c) as a threatened
- 15 species or endangered species.".

#### 16 SEC. 3. IMPORTS OF SPORT-HUNTED TROPHIES.

- 17 Section 10(a) of the Endangered Species Act of 1973
- 18 (16 U.S.C. 1539(a)) is amended by adding at the end the
- 19 following:
- 20 "(3) Before issuing any permit under this Act author-
- 21 izing import of any sport-hunted trophy of a species that
- 22 is listed or proposed to be listed as an endangered or threat-
- 23 ened species, the Secretary must make a finding after public
- 24 notice and comment pursuant to section 553 of title 5,
- 25 United States Code, of whether the country where the ani-

1	mal was killed adequately provides for the conservation and
2	monitoring for that species, including that—
3	"(A) a management plan for that species based
4	on the best available science that—
5	"(i) addresses existing threats to the species;
6	"(ii) provides a significant conservation
7	benefit to the species;
8	"(iii) formally coordinates with adjacent
9	countries to protect transboundary populations;
10	and
11	"(iv) ensures that any take is sustainable
12	and does not contribute to the species' decline in
13	either the short-term or long-term according to
14	current population estimates derived through the
15	use of the best available science;
16	"(B) such management plan is being actively
17	implemented;
18	"(C) the country where the animal was killed
19	demonstrates transparency, accountability, and
20	verifiability in governance to ensure that any benefits
21	of trophy hunting, including revenue from such tak-
22	ing, materially, directly and substantially benefits the
23	conservation of that species;
24	"(D) hunting of the species in such country en-
25	hances the propagation or survival of the species; and

1	"(E) the local community in which the trophy
2	hunting occurs directly and substantially benefits
3	from the hunting of the species.
4	"(4) Notwithstanding subsections (b) and (c)(2) of sec-
5	tion 9, no permit may be issued by the Secretary for the
6	import of a sport-hunted trophy of an elephant or lion
7	taken in Tanzania, Zimbabwe, or Zambia.".
8	SEC. 4. PERMIT FEES FOR SPORT-HUNTED TROPHY IM-
9	PORTS.
10	Section 10(a)(2) of the Endangered Species Act of 1973
11	(16 U.S.C. 1539(a)(2)) is amended by redesignating sub-
12	paragraph (C) as subparagraph (D), and by inserting after
13	subparagraph (B) the following:
14	"(C) No permit may be issued by the Secretary under
15	this Act for import of a sport-hunted trophy unless the ap-
16	plicant pays to the Secretary all administrative costs in-
17	curred by the United States that are associated with proc-
18	essing the permit application.".
19	SEC. 5. TRANSPARENCY OF SPORTS-HUNTED TROPHY IM-

- 21 Section 10(c) of the Endangered Species Act of 1973
- (16 U.S.C. 1539(c)) is amended by inserting "The Secretary 22
- shall publish notice in the Federal Register of each applica-
- 24 tion for an exemption or permit which is made under this
- 25 Act for a sport-hunted trophy of a species that is listed or

1	proposed to be listed as an endangered species or threatened
2	species." after "section."
3	SEC. 6. TERMINATION OF INTERNATIONAL WILDLIFE CON-
4	SERVATION COUNCIL.
5	The International Wildlife Conservation Council of the
6	United States Fish and Wildlife Service is hereby abolished.
7	SEC. 7. GOVERNMENT ACCOUNTABILITY OFFICE STUDY.
8	(a) In General.—Not later than 6 months after the
9	date of the enactment of this Act, the Comptroller General
10	of the United States shall conduct and submit to the Con-
11	gress a report on the results of a study of the effectiveness
12	of trophy hunting in supporting international wildlife con-
13	servation efforts.
14	(b) Report.—The report shall—
15	(1) include a detailed analysis of how permit fees
16	and other payments from hunters to government enti-
17	ties and hunting guides in host countries are applied
18	to tangible actions supporting the conservation of the
19	target species and other wildlife in such countries;
20	(2) identify data gaps and recommend informa-
21	tion that hunters and host countries must submit to
22	verify the impacts of trophy hunting on wildlife con-
23	servation efforts; and

- 1 (3) recommend actions that the Department of
- 2 the Interior and the Congress should take to ensure
- 3 that trophy hunting contributes to conservation.

Amend the title so as to read: "A bill to amend the Endangered Species Act of 1973 to strengthen protections for endangered and threatened species, as well as species proposed to be listed, by requiring certification by the Fish and Wildlife Service that any international trophy hunting of those species enhances the conservation of the species before any import of the trophy would be permitted, and for other purposes.".
