2 **Maryland Zero Emission Electric Vehicle Infrastructure Council – Membership**
3 **and Reporting**

4 FOR the purpose of altering the composition of the Maryland Zero Emission Electric
5 Vehicle Infrastructure Council to include a representative of a light-duty plug-in
6 electric drive vehicle manufacturer, a heavy-duty plug-in electric drive vehicle
7 manufacturer, the automotive dismantling and recycling industry, and the Secretary
8 of General Services; altering reporting requirements for the Council; and generally
9 relating to the Maryland Zero Emission Electric Vehicle Infrastructure Council.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

(3) The Secretary of Transportation, or the Secretary’s designee;

(4) The Secretary of Planning, or the Secretary’s designee;

(5) The Secretary of the Environment, or the Secretary’s designee;

(6) The Secretary of Commerce, or the Secretary’s designee;
