1 AN ACT concerning

2 **Maryland Community Investment Corporation – Establishment**
3 **(Housing and Community Development Financing Act of 2024)**

4 FOR the purpose of establishing the Maryland Community Investment Corporation as an
5 independent unit to make investments in certain low-income communities;
6 authorizing the Board of Directors of the Corporation to establish a certain advisory
7 committee and requiring the Corporation to establish an investment committee;
8 requiring the Corporation to apply for an allocation of federal new markets tax
9 credits; establishing eligible uses of money of the Corporation; expanding the eligible
10 uses of the Strategic Demolition and Smart Growth Impact Fund to include grants
11 and loans for debt payments and for credit enhancement for certain projects; and
12 generally relating to community investment, the Maryland Community Investment
13 Corporation, and the Strategic Demolition and Smart Growth Impact Fund.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

8 **(A) THERE IS A MARYLAND COMMUNITY INVESTMENT CORPORATION.**

9 **(B) THE CORPORATION IS A BODY POLITIC AND CORPORATE AND IS AN**
10 **INSTRUMENTALITY OF THE STATE.**

11 **10-1104.**

12 **THE PURPOSES OF THE CORPORATION ARE TO:**

13 **(1) DO ALL THINGS NECESSARY TO QUALIFY AS A QUALIFIED**
14 **COMMUNITY DEVELOPMENT ENTITY;**

15 **(2) APPLY TO THE U.S. DEPARTMENT OF THE TREASURY TO BE**
16 **DESIGNATED AS A QUALIFIED COMMUNITY DEVELOPMENT ENTITY;**

24 **(6) COORDINATE WITH OTHER QUALIFIED COMMUNITY**
25 **DEVELOPMENT ENTITIES IN THE STATE TO HELP ENSURE THAT LOW-INCOME**
26 **COMMUNITIES ARE RECEIVING THE MAXIMUM BENEFIT OF QUALIFIED EQUITY**
27 **INVESTMENTS;**

(7) MAKE INVESTMENTS AND FINANCIAL ASSISTANCE AVAILABLE TO LOW-INCOME COMMUNITIES FROM THE CORPORATION'S MONEY OR FROM ANY OTHER SOURCE;

(8) BUILD A LONG-TERM FINANCIAL CAPACITY AND SUSTAINED INVESTMENT IN LOW-INCOME COMMUNITIES IN THE STATE;

(9) COORDINATE AND CREATE PATHWAYS TO FOLLOW-ON FINANCING IN THE STATE; AND

(10) FOSTER INCLUSIVE AND DIVERSE ENTREPRENEURSHIP AND INNOVATION THROUGHOUT THE STATE, WHICH MAY INCLUDE INITIATIVES TO RAISE AWARENESS OF PROGRAMS TO ASSIST LOW-INCOME COMMUNITIES.

(A) A BOARD OF DIRECTORS SHALL MANAGE THE CORPORATION AND ITS UNITS AND EXERCISE ITS CORPORATE POWERS.

(B) THE BOARD CONSISTS OF THE FOLLOWING MEMBERS:

(1) THE COMPTROLLER OR THE COMPTROLLER'S DESIGNEE;

(2) THE SECRETARY OR THE SECRETARY'S DESIGNEE;

(3) THE SECRETARY OF HOUSING AND COMMUNITY DEVELOPMENT OR THE SECRETARY'S DESIGNEE;

(4) THE SECRETARY OF PLANNING OR THE SECRETARY'S DESIGNEE;

(5) THE SECRETARY OF GENERAL SERVICES OR THE SECRETARY'S DESIGNEE; AND

(6) THE FOLLOWING MEMBERS APPOINTED BY THE GOVERNOR WITH THE ADVICE AND CONSENT OF THE SENATE:

(I) ONE REPRESENTATIVE OF NONPROFIT ENTITIES IN THE STATE; AND

(II) ONE REPRESENTATIVE OF LOW-INCOME COMMUNITIES.

(C) A MEMBER OF THE BOARD SHALL RESIDE IN THE STATE.

1 **(D) IN MAKING APPOINTMENTS TO THE BOARD, THE GOVERNOR SHALL**
2 **CONSIDER:**

3 **(1) DIVERSITY; AND**

4 **(2) ALL GEOGRAPHIC REGIONS OF THE STATE.**

5 **(E) A MEMBER OF THE BOARD:**

6 **(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE BOARD;**
7 **BUT**

8 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
9 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.**

10 **(F) (1) THE TERM OF AN APPOINTED MEMBER IS 4 YEARS.**

11 **(2) THE TERMS OF THE APPOINTED MEMBERS ARE STAGGERED AS**
12 **REQUIRED BY THE TERMS PROVIDED FOR MEMBERS ON OCTOBER 1, 2024.**

13 **(3) AT THE END OF A TERM, AN APPOINTED MEMBER CONTINUES TO**
14 **SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.**

15 **(4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES**
16 **ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND**
17 **QUALIFIES.**

18 **(G) (1) THIS SUBSECTION APPLIES TO A MEMBER WHO IS APPOINTED BY**
19 **THE GOVERNOR UNDER SUBSECTION (B)(6) OF THIS SECTION.**

20 **(2) THE GOVERNOR MAY REMOVE AN APPOINTED MEMBER FOR**
21 **INCOMPETENCE, MISCONDUCT, OR FAILURE TO PERFORM THE DUTIES OF THE**
22 **POSITION.**

24 **THE BOARD SHALL ELECT A CHAIR FROM AMONG ITS MEMBERS.**

25 **10-1107.**

26 **(A) FOUR MEMBERS OF THE BOARD ARE A QUORUM.**

(B) A MAJORITY VOTE OF THE MEMBERS PRESENT AT A MEETING HAVING A QUORUM IS NEEDED FOR THE CORPORATION TO ACT.

10-1108.

(A) THE BOARD SHALL APPOINT MEMBERS OF AN ADVISORY COMMITTEE.

(B) THE MEMBERSHIP OF THE ADVISORY COMMITTEE SHALL BE COMPOSED OF MEMBERS REQUIRED FOR THE CORPORATION TO QUALIFY AS A QUALIFIED COMMUNITY DEVELOPMENT ENTITY UNDER 26 U.S.C. § 45D(c)(1).

(C) THE BOARD SHALL ADOPT POLICIES ESTABLISHING THE RESPONSIBILITIES OF THE ADVISORY COMMITTEE.

(A) THE CORPORATION SHALL ESTABLISH AN INVESTMENT COMMITTEE.

(B) THE CORPORATION SHALL ADOPT REGULATIONS ESTABLISHING:

(1) THE RESPONSIBILITIES OF THE INVESTMENT COMMITTEE; AND

(2) THE PROCEDURES FOR THE APPOINTMENT OF INVESTMENT COMMITTEE MEMBERS.

(A) THE CORPORATION SHALL EMPLOY A CHIEF EXECUTIVE OFFICER.

(B) THE CHIEF EXECUTIVE OFFICER SHALL HAVE EXPERIENCE WITH AND POSSESS QUALIFICATIONS RELEVANT TO THE ACTIVITIES AND PURPOSES OF THE CORPORATION.

(B) (1) THE ATTORNEY GENERAL SHALL ASSIGN TO THE CORPORATION ASSISTANT ATTORNEYS GENERAL.

1 **(2) THE ATTORNEY GENERAL SHALL DESIGNATE ONE ASSISTANT**
2 **ATTORNEY GENERAL AS GENERAL COUNSEL TO THE CORPORATION.**

3 **(3) (I) THE GENERAL COUNSEL TO THE CORPORATION SHALL:**

4 **1. ADVISE THE CHIEF EXECUTIVE OFFICER, THE**
5 **BOARD, AND ANY OTHER OFFICIAL OF THE CORPORATION AS REQUESTED BY THE**
6 **CORPORATION;**

7 **2. SUPERVISE THE OTHER ASSISTANT ATTORNEYS**
8 **GENERAL ASSIGNED TO THE CORPORATION; AND**

9 **3. PERFORM FOR THE CORPORATION OTHER DUTIES**
10 **THE ATTORNEY GENERAL ASSIGNS.**

11 **(II) THE GENERAL COUNSEL MAY NOT PROVIDE ANY OTHER**
12 **ASSISTANCE NOT SPECIFIED IN SUBPARAGRAPH (I) OF THIS PARAGRAPH.**

13 **(C) WITH THE APPROVAL OF THE ATTORNEY GENERAL, THE CORPORATION**
14 **MAY RETAIN ANY ADDITIONAL NECESSARY ATTORNEYS.**

16 **(A) THE DEPARTMENT AND THE DEPARTMENT OF HOUSING AND**
17 **COMMUNITY DEVELOPMENT MAY PROVIDE STAFF TO THE CORPORATION AS**
18 **PROVIDED IN THE STATE BUDGET.**

19 **(B) THE CORPORATION MAY RETAIN ANY NECESSARY ACCOUNTANTS,**
20 **ENGINEERS, FINANCIAL ADVISORS, OR OTHER CONSULTANTS.**

22 **(A) EXCEPT AS PROVIDED IN SUBSECTIONS (B), (C), AND (E) OF THIS**
23 **SECTION, THE CORPORATION IS EXEMPT FROM TITLE 10 AND DIVISION II OF THE**
24 **STATE FINANCE AND PROCUREMENT ARTICLE.**

25 **(B) THE CORPORATION IS SUBJECT TO THE PUBLIC INFORMATION ACT.**

26 **(C) THE BOARD, THE OFFICERS AND EMPLOYEES OF THE CORPORATION,**
27 **MEMBERS OF THE INVESTMENT COMMITTEE, AND MEMBERS OF ANY ADVISORY**
28 **COMMITTEE APPOINTED ARE SUBJECT TO THE PUBLIC ETHICS LAW.**

(D) THE OFFICERS AND EMPLOYEES OF THE CORPORATION ARE NOT SUBJECT TO THE PROVISIONS OF DIVISION I OF THE STATE PERSONNEL AND PENSIONS ARTICLE THAT GOVERN THE STATE PERSONNEL MANAGEMENT SYSTEM.

(E) (1) THE CORPORATION, THE BOARD, AND EMPLOYEES OF THE CORPORATION ARE SUBJECT TO TITLE 12, SUBTITLE 4 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

(2) THE BOARD, THE OFFICERS AND EMPLOYEES OF THE CORPORATION, THE MEMBERS OF THE INVESTMENT COMMITTEE, AND THE MEMBERS OF ANY ADVISORY COMMITTEE APPOINTED SHALL DISCLOSE TO THE STATE ETHICS COMMISSION WHETHER THEY ARE EMPLOYED BY OR HAVE A FINANCIAL INTEREST IN AN ENTITY THAT CURRENTLY HAS OR WILL APPLY FOR FUNDS OR AN INVESTMENT IN A PROGRAM ADMINISTERED BY THE CORPORATION.

(F) FOR PURPOSES OF THE OPEN MEETINGS ACT, A PROJECT SITE VISIT OR EDUCATIONAL FIELD TOUR MAY NOT BE CONSIDERED A MEETING OF THE CORPORATION IF NO ORGANIZATIONAL BUSINESS IS CONDUCTED.

(A) THE CORPORATION SHALL ESTABLISH A SYSTEM OF FINANCIAL ACCOUNTING, CONTROLS, AUDITS, AND REPORTS.

(B) THE FISCAL YEAR OF THE CORPORATION BEGINS ON JULY 1 AND ENDS ON THE FOLLOWING JUNE 30.

(D) UNLESS AN AGREEMENT OR COVENANT BETWEEN THE CORPORATION AND THE HOLDERS OF ITS OBLIGATIONS LIMITS CLASSES OF INVESTMENTS, THE

**CORPORATION MAY INVEST ITS MONEY IN BONDS OR OTHER OBLIGATIONS OF, OR
GUARANTEED AS TO PRINCIPAL AND INTEREST BY, THE UNITED STATES, THE
STATE, OR A GOVERNMENTAL UNIT.**

**(E) ANY INCOME FROM THE INVESTMENT OF MONEY OF THE CORPORATION,
INCLUDING INVESTMENT PROCEEDS AND EARNINGS, SHALL BE CREDITED TO THE
CORPORATION.**

21 (c) The purpose of the Fund is to provide grants and loans to assist in
22 predevelopment activities, including interior and exterior demolition, land assembly,
23 architecture and engineering, [and] site development, **DEBT PAYMENTS, AND CREDIT**
24 **ENHANCEMENT** for revitalization projects in designated areas of the State.

25 (d) The Department shall administer the Fund.

26 (e) (1) The Fund is a special, nonlapsing fund that is not subject to § 7–302 of

(i) a Sustainable Community; or

(ii) a qualified opportunity zone designated under § 1400Z–1 of the Internal Revenue Code in Allegany County, Garrett County, Somerset County, or Wicomico County.

(2) (i) For fiscal years 2017 through 2019, to be eligible for a grant or loan from the Fund, a government agency or community development organization shall provide evidence of a matching fund that is equal to \$1 for every \$4 in State funding that the agency or organization is applying for from the Fund.

(ii) The matching fund required under subparagraph (i) of this paragraph may include:

1. money from the federal government, local government, or any other public or private source;

2. real property;

3. in-kind contributions; and

4. funds expended before the date the grant or loan is awarded.

(3) For fiscal year 2020 and each fiscal year thereafter, to be eligible for a grant or loan from the Fund, a government agency or community development organization is not required to provide evidence of a matching fund.

(4) The Department shall award grants and loans from the Fund on a competitive basis.

(h) (1) The State Treasurer shall invest the money of the Fund in the same

manner as other State money may be invested.

(2) Any interest earnings of the Fund shall be credited to the Fund.

(i) Expenditures from the Fund may be made only in accordance with the State budget.

(j) (1) For fiscal year 2018, the Governor shall include in the annual budget bill or capital budget bill an appropriation of \$25,625,000 from general funds or the proceeds from the sale of State general obligation bonds to the Fund, which shall be allocated as follows:

(i) \$22,125,000 for projects in Baltimore City; and

(ii) \$3,500,000 for projects throughout the State.

(2) For fiscal year 2019, the Governor shall include in the annual budget bill or capital budget bill an appropriation of \$28,500,000 from general funds or the proceeds from the sale of State general obligation bonds to the Fund, which shall be allocated as follows:

(i) \$25,000,000 for projects in Baltimore City; and

(ii) \$3,500,000 for projects throughout the State.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2024.
