BY repealing and reenacting, with amendments, Article – General Provisions Section 4–322 Annotated Code of Maryland (2019 Replacement Volume and 2023 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - General Provisions **4**4−322.
