Property Tax Credit - Public Safety Officers

3 FOR the purpose of authorizing the governing body of a county or municipal corporation to 4 grant, by law, a certain property tax credit against the county or municipal 5 corporation property tax imposed on a certain dwelling that is owned by a certain 6 public safety officer under certain circumstances; providing that the credit may not 7 exceed a certain amount per dwelling and the amount of property tax imposed on the dwelling; requiring the State Department of Assessments and Taxation to be 8 9 responsible for certain administrative duties relating to the credit; requiring a 10 county or municipal corporation to reimburse the Department for certain 11 administrative costs; authorizing the governing body of a county or municipal 12 corporation to provide, by law, for certain matters relating to the tax credit; defining certain terms; providing for the application of this Act; and generally relating to a 13 14 property tax credit for certain public safety officers.
