A BILL

To require all deportation officers of U.S. Immigrations and Customs Enforcement to wear body cameras when engaged in field operations and removal proceedings, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "ICE Body Camera Act
- 5 of 2017".

- 15 sure that all deportation officers of Enforcement and Re-

- 19 (b) Implementation.—To carry out subsection (a),
- 20 the Director of ICE shall, not later than 12 months after

- 21 SEC. 5. WITHHOLDING OF CERTAIN FUNDS.
- Any funds necessary to purchase, store, use, or main-23 tain body cameras described in this Act shall be derived

- 1 from funds made available to purchase new weapons for
- 2 ICE officials.
