CHAPTER _____

1 AN ACT concerning

2 **Food Service Facilities – Automated External Defibrillator Program**
3 **(The Joe Sheya Act)**

4 FOR the purpose of requiring the owner and operator of a certain food service facility to
5 develop and, beginning on a certain date, implement an automated external
6 defibrillator program that meets certain requirements; requiring the Department of
7 Health and Mental Hygiene and the Maryland Institute for Emergency Medical
8 Services Systems jointly to adopt certain regulations; and generally relating to an
9 automated external defibrillator program for food service facilities.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Health – General**

18 **21–330.3.**

(A) THIS SECTION DOES NOT APPLY TO A FOOD SERVICE FACILITY THAT HAS:

(1) AN ANNUAL GROSS INCOME OF \$400,000 OR LESS; OR

(2) A SEATING CAPACITY OF LESS THAN 50.

(B) THE OWNER AND OPERATOR OF A FOOD SERVICE FACILITY SHALL DEVELOP AND, BEGINNING OCTOBER 1, 2018, IMPLEMENT AN AUTOMATED EXTERNAL DEFIBRILLATOR PROGRAM THAT MEETS THE REQUIREMENTS OF § 13-517 OF THE EDUCATION ARTICLE.

(C) THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE AND THE MARYLAND INSTITUTE FOR EMERGENCY MEDICAL SERVICES SYSTEMS JOINTLY SHALL ADOPT REGULATIONS THAT:

(1) ESTABLISH GUIDELINES FOR PERIODIC INSPECTIONS AND ANNUAL MAINTENANCE OF THE AUTOMATED EXTERNAL DEFIBRILLATORS; AND

(2) ASSIST THE OWNER AND OPERATOR OF A FOOD SERVICE FACILITY IN CARRYING OUT THE PROVISIONS OF THIS SECTION.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2017.
